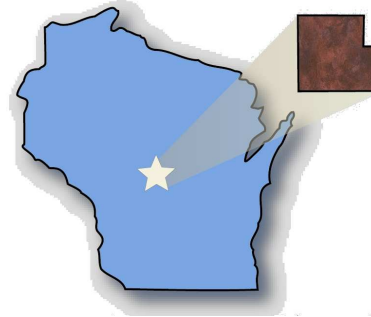
Adult Immunizations (ages 19+)

**Vaccines available at Wood County
Immunization Clinics ...**

Hib (Haemophilus influenza b)

Provides protection against Haemophilus influenza type b illness and meningitis.

DTaP (Diphtheria, Tetanus & Acellular Pertussis)

Provides protection against diphtheria, tetanus, and pertussis (whooping cough).

Td (Tetanus, Diphtheria)

Provides protection against diphtheria and tetanus.

Tdap (Tetanus, Diphtheria, and Pertussis)

Provides protection for adolescents and adults against tetanus, diphtheria and pertussis.

IPV (Inactivated Polio Vaccine)

Provides protection against polio.

MCV4 (Meningococcal Conjugate Vaccine)

Decreases risk for meningococcal disease.

MMR (Measles, Mumps, and Rubella)

Provides protection against measles, mumps and rubella (German measles).

Hep A (Hepatitis A)

Provides protection against Hepatitis A.

Hep B (Hepatitis B)

Provides protection against Hepatitis B.

Varicella (Chickenpox)

Provides protection against chicken pox.

PCV (Pneumococcal Conjugate Vaccine)

Reduces risk of meningitis, blood infections, and some types of ear infections.

HPV (Human Papillomavirus)

Protection against most cases of cervical cancer and genital warts for males and females.

Rotavirus

Oral vaccine to prevent rotavirus that causes severe diarrhea in babies. Given to infants 6-32 weeks of age.

**RECOMMENDED
IMMUNIZATION SCHEDULE**

Wood County Health Department follows the recommended schedule as suggested for disease control and to ensure maximum protection for your child.

2 months:	DTaP, Hib, IPV, Hep B, PCV, Rotavirus
4 months:	DTaP, Hib, IPV, Hep B (if the first dose was given at 2 months), PCV, Rotavirus
6 months:	DTaP, PCV (there must be a 6 month separation between the 3 rd and 4 th dose of DTaP), Rotavirus
6-18 months:	IPV, Hep B
12 months:	Hib, MMR, PCV, Varicella, Hep A
15-18 months:	DTaP, Hep A (must be 6 months between 1 st -2 nd dose of Hep A)
4-6 years:	DTaP, IPV, MMR, Varicella Hep B series (if not received previously)
11-12 years:	MCV4, Tdap, HPV

A Tdap booster and first dose of (MCV4) are recommended at age 11 with a Td booster every 10 years thereafter and a second dose of MCV4 at age 16.

An annual flu vaccine is recommended at 6 months of age and thereafter.

State law requires that all public and private school and daycare students present written evidence of immunizations against certain diseases within 30 days of admission. These requirements can be waived only if a properly signed health, religious, or personal conviction waiver is filed with the school/daycare.

SCHOOL IMMUNIZATION LAW

ENTRANCE TO GRADE K-12

- 4 – DTP, DTaP, DT, Td
- 1 – Tdap for grades 6-12
or (Td booster in past 5 years)
- 4 – IPV
- 2 – MMR
- 3 – Hepatitis B
- 1 – Varicella or history of Chickenpox disease;
(2 - for grades 5K, 1, 2, 3, 4, 6, 7, 8, 9,
10 & 12)*

If your child received the 3rd dose of DTP/DTaP/Td or IPV after the 4th birthday, further doses of these vaccines are recommended but not required.

ENTRANCE TO DAYCARE

- 5 months through 15 months
2 DTP/DTaP/DT; 2 IPV; 2 Hep B;
2 Hib; 2 PCV
- 16 months through 23 months
3 DTP/DTaP/DT; 2 IPV; 2 Hep B;
3 Hib; 1 MMR; 3 PCV
- 2 years through 4 years
4 DTP/DTaP/DT; 3 IPV; 3 Hep B;
3 Hib; 1 MMR, 1 Varicella; 3 PCV
