- 1. Goals: see attached memo entitled: "Rights and Authority of Supervisors."
- 2. The District IV Court of Appeals has granted the County's motion to dismiss an appeal of a paternity judgment. This is the matter which I have written to the committee about on multiple occasions as the appellant has used every means available to bypass and subvert the normal legal process in a paternity action in pursuit of his practice of impregnating women throughout the country as a sperm donor and trying to avoid any financial responsibility as a biological parent of the children. The essence of the appellate court decision is that the biological father did not have a valid reason to not timely file his brief and couldn't rely on his numerous motions seeking various types of relief as a basis therefor. I anticipate that there will be a request by the father to appeal the decision to the state supreme court but it is unlikely that court will take up the case, particularly in light of the way the appellant handled the case at the court of appeals level. Meanwhile, the state where the father lives has commenced child support enforcement proceedings and this decision will assist them in their efforts.
- 3. Public Comments at Committee Meetings. It was suggested to me that some instruction should be given to county board supervisors on how to handle public comments at committee meetings. In checking county board rule #12, I see that an explanation is contained therein. Specifically, "[c]ommittee members are not required to participate in discussion or answer questions from individuals during public comments.... However, committee members may answer, comment, or ask questions if they choose." I think that one of the concerns is that supervisors may feel compelled to respond to a question presented by a member of the public asking a question at a committee meeting when that is not the case. The questioner can either be referred on to appropriate staff or advised that an answer to their question will be obtained and provided to them. If there are specific concerns regarding how to handle situations that arise at a committee's public comment agenda item, please let me know.
- 4. Authority of county board vs. that of a committee. The question has been asked as to whether the county board can overrule a committee decision? Generally speaking the answer is yes, however there can be consequences in doing so. As has been explained in previous memos to the board, the committees primarily obtain their authority via action of the county board or by state statute. When the authority comes by means of delegation of the county board, the county board can rescind action taken by a committee. However, if for instance a committee authorized a department to execute a contract for the provision of a service and the county board determines to revoke the contract, then there will likely be damages that have to be paid if the contract has already been entered into. So, the county board overruling a committee on an action taken by the committee will have consequences specific to the action being addressed. I would encourage anyone considering having the county board overrule a decision by a committee, especially a committee decision that has been or may be acted upon prior to the county board meeting at which the committee minutes will be reviewed, to contact the corporation counsel at your earliest convenience to discuss the matter.

A corollary to the above discussion is that the minutes maintained by a committee typically do not need to be approved by the county board. Instead, the minutes of committees of the board are only received by the board and placed on file. The committees usually do not even approve their own minutes until their next meeting which happens after the county board has received those minutes. (If this didn't confuse you, I'll try harder next time.)

#### COMMENTS ON 2015 PERFORMANCE GOALS OF CORPORATION COUNSEL

What follows are my comments on the performance goals for 2015 that I set and the committee approved. If the committee has any specific questions on the goals or other aspects of the annual performance review, please let me know.

- 1. Legal Memos to the County Board. The proposal was to prepare a legal memo to the board every other month with the topics being pertinent to the work and responsibilities of the county board. These monthly memos included:
  - Withdrawal of a Resolution from the County Board Floor
  - The Uniform Commercial Code: in general and sales in particular
  - (UCC) The Battle of the Forms
  - Communicating with the Public
  - Immunity: Discretionary vs. Ministerial Acts
  - Workers' Compensation Overview
  - Authority of Indian Tribes
- 2. Expand Intranet Resources on Public Record Requests. In March I shared with county staff via department head training and inclusion on the intranet site a 50 plus page Public Records Compliance Outline based upon a publication from the AG's office and then followed that up with a several page flow chart and about 10 forms with instruction sheets to use in addressing open record requests. It is a rather comprehensive set of materials that will need updating as the law evolves through legislation and judicial decisions.

#### MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE

#### **OCTOBER 2015**

- The indirect cost calculation was completed and the costs have increased. This lowers the amount of levy the department will need for 2016 by about \$20,000. The amount of levy needed for 2016 will be \$49,669.
- The payment for the 3<sup>rd</sup> quarter will be arriving at the end of October.
- I completed the County FTE Survey and turned it into the state who will be submitting it to the Federal Office of Child Support Enforcement. This is done on an annual basis.
- I will be attending the WCSEA board meeting on October 20<sup>th</sup>.
- Five staff members will be attending the WCSEA Fall Conference on October 21<sup>st</sup> and 22<sup>nd</sup>.
- Supervisor Wagner and I will be attending CAP day at the capitol on November 4<sup>th</sup>. I plan to speak to legislators about SB 290 as it has implications for the Child Support Agency. I have attached a copy of the bill for your reference.
- Last month you agreed to co-sponsor a resolution with the Health and Human Services committee supporting AB 284 and SB 204 which would add penalty enhancers to persons involved in causing harm to social workers. Senator Tiffany has authored an amendment to SB 204 which would further extend the law to include child support employees.
- The final performance numbers for federal fiscal year 2015 are in. The agencies current support collection rate increased from 78.39% to 79.99%, an improvement of 1.6%. The court order and paternity establishment rates finished well above federal standards. The arrears collection rate jumped up 6.92% from 78.83% to 85.75%. We finished the year with the second highest arrears collection rate in the state!
- The current IV-D case count is 3,996.

## 2015 SENATE BILL 290

October 7, 2015 – Introduced by Senators KAPENGA, STROEBEL, WANGGAARD and NASS, cosponsored by Representatives KRUG, BRANDTJEN, CRAIG, GANNON, HORLACHER, KITCHENS, KLEEFISCH, KNODL, KREMER, T. LARSON, MURPHY, SANFELIPPO, THIESFELDT and TITTL. Referred to Committee on Public Benefit and Regulatory Reform.

AN ACT to create 49.84 (8) of the statutes; relating to: requiring verification

from court orders for eligibility for public assistance programs.

#### Analysis by the Legislative Reference Bureau

The Department of Health Services (DHS) and the Department of Children and Families (DCF) administer a number of programs that provide services, benefits, and other types of assistance to eligible persons, usually persons with low incomes, who need assistance to obtain such necessities as food, health care, or child care. These programs are known as public assistance programs. Some examples are Wisconsin Works, including Wisconsin Shares; the food stamp program; the Medical Assistance program; the program that provides eligible persons with assistance in establishing the paternity of a child, establishing or modifying child support obligations, enforcing child support or maintenance (alimony) obligations, and locating persons who owe child support or children taken by parents in violation of court orders; the programs that provide state supplemental payments to persons receiving federal supplemental security income; the program that pays funeral, burial, and cemetery expenses for persons whose estates are insufficient to pay those expenses; and the disease aids program that provides assistance in paying the costs of medical treatment for eligible persons with cystic fibrosis, hemophilia, or chronic renal disease. For some public assistance programs, a person is not eligible for assistance unless he or she has a specified relationship or arrangement with a child.

This bill provides that, if a person's eligibility for a public assistance program depends on his or her relationship or arrangement with a child and that relationship or arrangement is set out in a court order, DHS or DCF, whichever department

administers the program, must verify the information the person provides about his or her relationship or arrangement with a child by accessing the applicable court order. The bill specifies that, for purposes of the requirement, a person's relationship or arrangement with a child includes whether the person has legal custody of a child; whether a child resides with the person; whether the person is a child's parent or caretaker relative; whether the person exercises primary responsibility for a child's care and control; and any other relationship or arrangement that is relevant to eligibility for a public assistance program.

For further information see the state and local fiscal estimate, which will be printed as an appendix to this bill.

#### The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

**SECTION 1.** 49.84 (8) of the statutes is created to read:

Charge Payment Fund: Payments received on outstanding charges.

Escrow Payment Fund: Customer money being held for future activity.

County Transfer Fee Fund: County retains 20% of all Transfer Fees collected.

<u>County VitalChek Fee Fund:</u> County retains \$10.00 from every person requesting a vital record online via Vitalchek.

**Laredo Remote:** County collects a fee from customers using Laredo software outside of the courthouse.

**State DOA Fund:** Signing of state budget bill 10/26/2007 increased birth certificates by \$8, marriage and death certificates by \$13.00, and the expedite fee by \$10.00. All monies to be mailed to the Department of Administration. The increase was enacted to come into compliance with recent federal laws. The monies will be used to automate outdated paper registration, archiving and copy issuance systems at the State and local vital records offices.

**<u>Reports Fund:</u>** County collects a fee (.50/page) from customers requesting reports.

**<u>Register of Deeds Fund:</u>** County retains all remaining recording fees (\$15.00 from each document recorded. \$5.00 from each first copy of every birth record sold. \$7.00 from each first copy of every death and marriage record sold. \$3.00 for each extra copy of vital records sold.)

<u>County Land Record Fund:</u> Effective June 25, 2010 statutes provide that \$8.00 is retained for the provision of land information on the internet and for Land Records modernization.

State Transfer Fund: State collects 80% of all Transfer Fees collected.

State Birth Fund: State collects \$7.00 of every birth record sold.

State Land Record Fund: State collects \$7.00 from each document recorded.

RE:	Rights and Authority of Supervisors

Periodically I am contacted by a county board supervisor to answer questions about the authority of a supervisor as a committee member in relation to a committee chair and a department head. I have done several memorandums over the years pertaining to the authority of a committee, where it comes from, and how it can be passed on to others. Recently I have been asked questions about this topic and I answered them. Now I come across a memo from a while back that addresses the issue in an interesting context that I thought would be worthwhile to share with everyone. This is particularly an important read for committee chairs lest you assume you have more power than you do and are embarrassed when the point is made publically.

On December 6, 2000, you stopped by my office to discuss some problems you were experiencing as a member of the Planning & Zoning Committee. One of your concerns had to do with access, prior to a committee meeting, to documents to be discussed at a committee meeting. You requested that I put my comments in writing and to disseminate them to certain persons. This memorandum is a follow-up to that request.

In discussing your rights to access records, principally of the Planning & Zoning department, we reviewed briefly your rights and that of any other person under the public records law, Wisconsin Statute section 19.21, et seq. You stated a preference to avoid utilizing the public records law and the potential for litigation that its use implies.

I appreciate that.

You suggested that as the vice-chairperson of the committee you had a right and a responsibility to be prepared for each committee meeting and that this necessitated your viewing in advance of the meeting documents to be discussed at the meeting.

Apparently you have requested copies of such documents in the past from the department head and the department head has turned down your request at the direction of the committee chairperson. The committee chair has since allowed that if documents are to be sent to one committee member, they be sent to all committee members.

There are a number of problems with the initial picture you portray. First, as a supervisor and particularly as a committee member (but even as a member of the public) you have a right, a legal right, to receive upon request in advance of a committee meeting a copy of documents that will be disseminated, discussed, or referred to at the meeting. No one, not a department head, a committee chairperson, a county board chairperson or even a county executive, can deny or impede such a request. Fees for such copies can and typically are charged for the public but they should not be charged of a supervisor, unless so directed by the department head or the committee.

The second problem with this scenario is the authority that the committee chairperson was evidently attempting to exercise. A committee chairperson is responsible for running (maintaining order) at the committee meeting. In doing so, a good chairperson will maintain a higher level of communication with the department(s) he or she oversees and, therefore, will typically be more knowledgeable about the matters brought before the committee. Usually a committee chairperson sets the agenda, but a committee may delegate that authority otherwise.

The higher level of contact between a committee chairperson and a department head and staff does <u>not</u> in and of itself give the chairperson any specific control or authority greater than that of another committee member, another supervisor or even the general public! If a committee chairperson has any authority over department staff (other than setting the agenda), it is only by means of a motion contained in the minutes of the committee.

The county board conveys authority to a committee as a group, not as individuals. The committee conveys its authority by means of job descriptions and meetings, whereby motions are made, seconded and approved by a majority vote. A committee may authorize its chair to perform certain functions, such as an annual performance evaluation on a department head. This type of matter may tend to cause a department head to ingratiate him

or herself to the committee chair over other committee members and to committee members over other supervisors. However, when push comes to shove, a committee chair or other committee members has <u>no</u> independent control or authority over a department head or staff person unless that authority has been conveyed via motion contained in written committee minutes.

Please recognize that these comments are not intended to be critical of the department head or the committee chair. Department heads often give great deference to the wishes of an oversight committee chair and vice-versa. This would seem to be a natural development in such a relationship. However, when, as here, push comes to shove, the department head cannot simply abide by unauthorized directives of a committee chair.

As with any county board supervisor, I avail to you my services in making sure that you are able to perform your responsibilities as a supervisor in a legal manner. I cannot direct a supervisor or department head what to do or what not to do. I can only give them advice on what is and is not legal and why. I can, however, assist in advising you and others as to the "chain of command" and communicating with the entities that do not exercise control over a given issue.

INTENT & SYNOPSIS: To support the implementation of the Achieving a
Better Life Experience (ABLE) Act to reform the SSI asset limits in
Wisconsin.

WHEREAS, Supplemental Security Income (SSI) is a Federal and State income supplement program funded by general tax revenues (not Social Security taxes); and

WHEREAS, the SSI program is designed to help aged, blind, and disabled people, who have little or no income; and

WHEREAS, the SSI program provides cash to meet basic needs for food, clothing and shelter; and

WHEREAS, the SSI program eligibility requirements are as follows:

- Anyone who is 65 and over, blind or disabled.
- Has limited income, resources, and is a US citizen or national; and •

WHEREAS, the SSI program asset limits are as follows:

- Individual/Child is \$2,000/month.
- Couple is \$3,000/month; and

WHEREAS, the SSI asset limit was set in 1989 and has never been adjusted; and

WHEREAS, the asset level limits employment and savings options for recipients due to risk of losing Medicaid for health care coverage; and

WHEREAS, the SSI asset limits can prevent SSI recipients from saving for post-secondary education, home ownership, and retirement; and

WHEREAS, in December 2014 the Achieving a Better Life Experience (ABLE) Act was passed at the Federal level; and

WHEREAS, the ABLE Act allows individuals whose disability manifest before the age of 26 to be eligible to set up ABLE accounts that are tax-advantaged savings accounts where they can save \$14,000 per year and \$100,000 in total which will not affect eligibility for Medicaid, Wisconsin Long Term Programs and other public benefits; and

WHEREAS, each state is responsible for establishing and operating an ABLE program.

NOW, THEREFORE, THE WOOD COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES to support the implementation of the ABLE Act to reform the SSI asset limits in Wisconsin as soon as practicable.

FURTHER, BE IT RESOLVED THAT THE WOOD COUNTY BOARD OF SUPERVISORS directs the County Clerk to forward this resolution to the office of the governor, assembly members and senators representing Wood County, Disability Rights Wisconsin, all Wisconsin counties, and the Wisconsin Counties Association.
