- 1. Chairman Al Breu called the meeting to order at 8:00 A.M.
- 2. Public Comments: In attendance were individuals with questions and concerns regarding the firewood ordinance the committee approved at the January 7, 2016 meeting.

Discussion took place regarding several issues the individuals would like to see addressed. Greg Wipfli stated that people are wondering where the help is coming from to handle all the firewood that will be needed in order to keep up with the increased demand due to the new ordinance. A. Breu stated he and C. Schooley had discussed working with the county Forest Administrator, as there are always active timber sales where certain sections of county forest could be thinned out and the firewood brought into the county parks to sell. Currently, the Forest Administrator is working on setting up areas to be cut and thinned for the purpose of stockpiling for future firewood sales in the campgrounds. The goal would be to know where all wood is coming from that is processed into firewood for the campgrounds, and to stay as local as possible to the individual parks. The difference between a logger and a private citizen bringing the wood into the parks is we know exactly where the wood is coming from.

A constituent stated "We love our parks and we don't want to lose them, but why can't we bring our own wood in to the parks if we are residents of Wood County and revise the ordinance to indicate that?" It was also mentioned that people will be paying so much more money to buy firewood for camping.

Many campers burn wood all day and all weekend for warming, cooking and socializing. It's estimated to cost over \$100 for a family in addition to the cost of camping. Another constituent asked "What is wrong with the wood just a stone throw from the county park?

C. Schooley commented it is still not a guarantee that the wood is coming from that property and we would have no way of monitoring and enforcing where the wood is actually coming from or where it was cut from. The existing set up of the parks does not require individuals to "check in", and many times during early and late season, there may not be any staff in the campground at all with the campers self registering.

One constituent stated a lot of private campgrounds do not have these firewood restrictions, it is only campgrounds owned and operated by the Wood County Park and Forestry Department. A. Breu stated "We need to do the best job we can to control this Emerald Ash Borer. We won't catch everything, but we can only do the best we can and in the meantime we will educate all of our campers and visitors on why it is important we bring in clean wood."

W. Winch stated he would like to work on getting this ordinance revised so that firewood can be brought in from anywhere in Wood County. A. Breu said it has to go one way or the other and not pick and choose who can bring wood in and who can't. There needs to be a level playing field between everyone. C. Schooley explained that if Wood County wanted to ensure that only Wood County firewood was brought into the campground, there would be a pretty significant cost with building a "check in" entrance, along with staffing this location from May-November from 8am to 10pm daily. W. Winch asked the committee and constituents for suggestions:

- 1) Keep the parks going just as they are and continue to allow the Wood County residents to bring in their own firewood.
- 2) L. Pliml agrees with W. Winch. How do you ascertain the difference between tree species and what are hibernating in the trees? He also believes we should take this ordinance into further consideration for our camping residents.
- 3) Is this ordinance worth killing the County Parks System, a visitor asked.
- 4) Constituents are asking to place a large fine on bringing illegal wood in and remove the ordinance. It will only benefit those that are following the rules to keep the EAB out of our county park system.
- A. Breu states we should put it on the agenda for next month and fine tune it. Possibly make exceptions that we can try to enforce for the residents of Wood County using our campgrounds.

C. Schooley mentioned that he would not want to wait until the April HIRC and County Board meeting to make this decision, due to the campground opening of May 1st being just around the corner. If possible, the committee could meet prior to county board, with the full board voting that same day. It is agreed the HIRC will meet prior to the next County Board meeting on March 15, 2016 and then present the resolution or revised ordinance to the County Board that day. The visiting constituents appreciated us taking the time to listen to them and their concerns and taking all of their comments into consideration.

C. Schooley is asking what the committee would like him to do at this point. L. Pliml said to move the resolution forward to rescind the ordinance and then draft another resolution, ordinance or policy to put into place and then take this to the county board. It would still take board action to amend the current ordinance. C. Schooley asked if we should draft a new ordinance or simply make this a policy. A. Breu suggested simply excluding Wood County residents from the ordinance. It was mentioned this will no longer be enforceable, and thus must be an educational opportunity.

Wood County ATV Park in Port Edwards. A constituent stated he has been riding this park for many years and agrees the park is nice however, the trails are a mess. W. Winch said he learned that when it rains the ATV trails get very soupy and there is no bottom. C. Schooley stated the ATV area has a very high water table. There are a couple of holes that we have problems with. We let the club know and they go out there with the grader and level things out. Some people love it because that is the experience they are looking for.

The constituent also brought up the possibility of having campsites at the ATV area. Also, finding a way to get there using county land is not possible as the park goes nowhere. It would be really nice if we could connect with different town and/or county roads.

A constituent mentioned crossing the bridge in Nekoosa on the WI River. Highway Commissioner Passineau stated it is possible, but there is a Statute out there that you have to follow to a "T" in order to be able to cross that bridge. L. Pliml suggested pleasing both parties and split off part of the trail so its cleaner, but leave the mud holes. Also suggested it would behoove us to be able to connect to ATV trails connected to other counties. C. Schooley stated that the HIRC and P&F Department have always been open to expanding trails if the interested parties could get other routes or trails connected for longer sections. The challenge is going to be getting road routes on the town roads and County Highways to meet up with existing trails elsewhere.

3. Approve minutes of the February 4, 2016 Highway, Infrastructure, and Recreation Committee meeting(s).

M. Hokamp made a motion to approve the minutes of the February 4, 2016 Highway, Infrastructure, and Recreation Committee meeting minutes. D. Polach seconded the motion. Motion carried.

HIGHWAY:

Bids were opened yesterday. This is an annual occurrence. Information was handed out to each committee member regarding the bids that were placed. D. Polach made a motion to go with the bid most advantageous to Wood County.

M. Hokamp seconded the motion. Motion carried.

 - M. Hokamp made a motion to go with the bid most advantageous to Wood County. W. Winch seconded the motion. Motion carried.

8. Discuss PASER ratings.

Pavement ratings information was handed out to each committee member. The ratings show the conditions of all county roads in Wood County and helps us put together a maintenance program for them.

9. MOU with Land and Water Conservation for Forestry Shop use.

Memorandum of Understanding. How will the funding be handled to allow Land and Water to utilize this space? There is only one side of the connector door currently with a pad lock on. The other concern was there is no money/rent involved in this proposal. D. Polach states it should stay strictly for the Hwy. Dept. and allow Land and Water to utilize that space only when needed. D. Passineau said they will help them with their tree sales when needed and will not leave them hanging when the time comes. To be used for site-prep for Land and Water Conservation Dept. B. Winch asked why we are exchanging monies Wood County Dept. to Wood County Dept. However, it is noted this is normal practice within Wood County Government. It was noted that Land Conservation shall be a part of this discussion and should be placed on the agenda for the April meeting.

In addition, he mentioned that DOT had purchased a trailer about two months ago and is not big enough for them to haul their new Stop and Go lights. The Highway Department will be in discussion with the Wisconsin DOT regarding purchasing a new trailer at a reasonable price that will better suit their needs. D. Passineau stated this was a good buy and they would be able to put the old trailer to good use in hauling their crack filling routers.

1. Call meeting to order.

Meeting was called to order by A. Breu. T. Miner read a letter sent from a Biologist, Glenn Taylor from the Great Smoky Mountains National Park in Gatlinburg, TN who saw the issue in the Wisconsin Rapids Tribune regarding the Firewood Ban in Wood County. He is inquiring as they recently enacted a ban in 2015 on firewood that is not heat treated. He wanted to offer some background that would help with our decision in holding or rescinding the ordinance. If the ban is not upheld, Emerald Ash Borer (EAB) will spread to the limits of the suitable ash resource. A ban would limit the threat of invasive forest pests from becoming established. This individual was not writing to include the county's decision on maintaining or rescinding the firewood ban, but simply wanted to provide additional information that may help assist in their decision. A letter was also read by T. Miner from Steve Grant, WDNR Forester that supported the Firewood Ban Ordinance.

Public Comments. Jere Hamel also mailed each County Board Member a packet of information regarding the Emerald Ash Borer (EAB) and his reasons for supporting the firewood ban in Wood County. Mr. Hamel provided his opinion regarding the ban. We're disregarding the information has been provided to this committee and there is no denying how these pests and diseases spread.

Member A. Breu or B. Leichtnam expressed they are not in favor of rescinding the ordinance or lifting the ban. The decision has been made and we should stick by it. A. Breu stated, "We're not going to stop the EAB, but we would like to slow it down and educate as many people as we can. The ban is in place for a reason. We will vote to maintain our January ban on the county board floor."

T. Miner does not believe the agenda item should move forward to the County Board. "There are reasons we did it. We can't have a firewood marshall at the park to monitor this. No, it will not stop EAB, but it will educate our customers and should stop our pests from gaining ground." T. Miner asked C. Schooley how many letters or notifications have we sent out regarding this. What was the feedback? C. Schooley stated there were approximately 8,000 mass e-mail's sent out and we had approximately 900 bounce backs (changed e-mail, etc.). As for feedback, there were only about less than ten individuals with comments or complaints.

F. Schubert asked if the resolution to rescind this firewood ban ordinance succeeds, how do we move forward and what are the committee's thoughts? It was stated by several individuals, at some point, the EAB will move into Wood County, our Ash trees will be infested, they will start dying and then we would then have to ban firewood into campgrounds anyway.

There were comments made regarding the cost of a bundle of wood compared to outside The cost of a bundle of firewood from a local vendor is about 6-7 pieces of wood, about one cubic foot and is between \$5 and \$6. A rack of wood purchased from one of our three campgrounds is approximately three cubic feet and will cost \$5.

B. Winch stated he was the one that made the original motion to move the ordinance to County Board and then to have the ordinance rescinded. He also stated he has had many comments from constituents. One asked, "When we bring firewood into the campground and burn it, aren't pests burned along with it? Couldn't we just change the ordinance to indicate if you bring wood in, you must burn it or leave it at the campground? We have wood moving on the highway every day to paper and saw mills, it lies on the ground for a week before it's processed, why isn't that an issue?" Even saying the wood will be burned during those 5-7 days at the campground is when the problem arises of when that bug escapes and moves and begins destruction.

Mr. Hamel said EAB appears at certain times of the year, usually from April to October. At any such time, the bug could escape and move. During transportation such as to the paper mill or saw mill, those employees are under restrictions from Department of Agricultural, Trade and Consumer Protection (DATCAP) in which they sign an agreement they will not receive hardwood or ash products during a certain time period. They have one day to process this wood. If they don't, the fine is upwards of \$10K.

Other comments:

The bug is only in Ash, correct? It's only one bug in one type of tree, but overall, it's more than one bug and one species of tree. It's Asian Long Horn Beetle, the Gypsy Moth, Oak Wilt and more. Private campgrounds do not have restrictions of firewood brought in. F. Schubert stated he believes it's the responsibility of every landowner or business owner to do what is right. All you can do is take care of your own resources, do the best you can, hope the education will spread and they will follow suit. The cost for a rack of firewood remains at \$5.00.

Park and Forestry Director Report


By Chad Schooley, Park and Forestry Director April 7, 2016 HIRC meeting

- Continue the grant writing process for the White Sands Beach project.
- I will present a funding plan for the Powers Bluff development project at the committee meeting.
- Attended the Wisconsin Park and Recreation Association spring workshop, held in Oshkosh. Also attended the quarterly WPRA board meeting, held in West Bend.
- Performed the annual Emergency Action Plan (EAP) test for the Dexter and South Park Dam, on March 18th. Park staff, Emergency Management, and Dispatch are all involved in this test.
- Attended the "Discover Wisconsin" premier, which highlighted Marshfield and Wisconsin Rapids outdoor recreation opportunities. This episode aired on March 19th. If you have not seen it, you can access it on their website anytime.
- We contracted with Bohn Trucking to complete rip-rap work below the dam, which was a result of the DNR orders from the last inspection done in 2014. They also completed a small section of rip-rap on the lake side which the contractors couldn't complete this past winter because of steep, icy conditions of the bank.
- I met with the Powers Bluff Concessionaire for our end of season meeting. Things went well for both parties this year, besides the short season.
- I have decided to extend the mowing contracts, with the same vendors, for another 3 years. The service provided will be the same, with no increase of rates for the duration of the contracts.
- The Historical Marker has been approved for the Jack Lukes/State Waterski Show Tournament site at Red Sands Beach. I will be meeting with Maggie Muleski to identify the location and work out the installation details. A copy of the sign information is included in the packet, along with an example of a similar sign.

Since the tournament's inception, the Wisconsin State Water Ski Show Tournament has grown into the largest tournament of its kind in the world, while Lake Wazeecha has become known as one of the top venues in the country for show skiing. Thanks to Jack Lukes' commitment to the sport he loved, thousands of skiers, fans and spectators come to Red Sands Beach every summer to enjoy the competition and entertainment on the water.



Aggregate Specifications & Requirements

1. SCOPE OF WORK

The work shall consist of providing adequate machines and labor to pump water out of the quarry, drilling and blasting into the floor of the quarry, transporting the quarry rock to the crusher, crushing the rock to the specified gradation, stockpiling, and testing.

2. LOCATION

Pit Location
7258 CTH B, Pittsville, WI 54466
Town of Carry, Wood County
Located 0.75 miles north of Wood County Trunk Highway (CTH) CC on CTH B.

3. EQUIPMENT

It is the contractor's responsibility to provide all necessary equipment to pump water from the pit and maintain the water level for safe working conditions, and provide all necessary equipment to drill, blast, transport, crush and stockpile the products as specified below.

4. METHOD OF MEASUREMENT

The crushed aggregate base course will be measured in cubic yards (volume) in its final stockpile, computed by surveying the pile. The volume will be converted to tons using a field tested unit of weight in pounds/cu. ft. and compared to the actual belt scale.

The unit of weight (lb/cu.ft.) will be an agreed unit of weight between the Engineer and Contractor before work begins. There is a sample pile on site to use for comparison.

- (2) Conform to standard spec 301 and 305 of the Wisconsin DOT Standard Specifications for Highway and Structure Construction 2016 Edition as modified here in this special provision. Apply this special provision to all of the Base Aggregate Dense.
- (3) Provide and maintain a quality control program, defined as all activities related to and documentation of the following:
 - 1. Production and placement control and inspection.
 - 2. Material sampling and testing.
- (4) Chapter 8 of the Wisconsin DOT Construction and Materials Manual provides additional detailed guidance for QMP work and describes required sampling and testing procedures. The contractor may obtain the CMM from the department's website at:

B Materials

B.1 Quality Control Plan

- (1) Submit a comprehensive written quality control plan to the engineer at or at least 2 weeks prior to production beginning. Do not commence production before the engineer reviews and comments on the plan.
- (2) Do not change the quality control plan without the engineer's review. Update the plan with changes as they become effective. Provide a current copy of the plan to the engineer and post in each of the contractor's laboratories as changes are adopted. Ensure that the plan provides the following elements:
 - 1. An organizational chart with names, telephone numbers, current certifications and/or titles, and roles and responsibilities of QC personnel.
 - 2. The process used to disseminate QC information and corrective action efforts to the appropriate persons. Include a list of recipients, the communication means that will be used, and action time frames.
 - 3. Test results for all aggregates requiring QC testing.
 - 4. Descriptions of stockpiling and hauling methods.
 - 5. Locations of the QC laboratory, retained sample storage, and where control charts and other documentation is posted.

6. An outline for resolving a process control problem. Include responsible personnel, required documentation, and appropriate communication steps.

B.2 Personnel

(1) Have personnel certified under the department's highway technician certification program (HTCP) perform sampling, testing, and documentation as follows:

Plant personnel under the direct observation of an aggregate technician certified at level one or higher may operate equipment to obtain samples.

(2) A certified technician must coordinate and take responsibility for the work an ACT performs. Have a certified technician ensure that all sampling and testing is performed correctly, analyze test results, and post resulting data. No more than one ACT can work under a single certified technician.

B.3 Quality Control Documentation

B.3.1 General

(1) Submit base aggregate production documentation to the engineer within 10 business days after completing base production. Ensure that the submittal is complete, neatly organized, and includes applicable project records and control charts.

B.3.2 Records

(1) Document all production observations, inspection records, and control adjustments daily in a permanent field record. Also include all test results in the project records. Provide test results to the engineer within 6 hours after obtaining a sample. Post or distribute tabulated results using a method mutually agreeable to the engineer and contractor.

B.3.3 Control Charts

(1) Plot gradation and fracture on the appropriate control chart as soon as test results are available. Format control charts according to CMM 8.30. Include the project number on base production control charts. Maintain separate control charts for each base aggregate size, source or classification, and type.

- Provide control charts to the engineer within 6 hours after obtaining a sample. Post or distribute charts using a method mutually agreeable to the engineer and contractor. Update control charts daily to include the following:
 - 1. Contractor individual QC tests.
 - 2. Department QV tests.
 - 3. Department IA tests.
 - 4. Four-point running average of the QC tests.
- (3) Except as specified under B.7.2.1 for out-of-tolerance QV tests, include only QC tests in the running average. The contractor may plot process control or informational tests on control charts, but do not include these tests, conforming QV tests, or IA tests in the running average.

- (3) Split each contractor QC sample and identify it according to CMM 8.30. Retain the split in a dry, protected location. If requested for department comparison testing, deliver the split to the engineer within one business day.
- (4) The engineer may require additional sampling and testing to evaluate suspect material or the technician's sampling and testing procedures.
- (5) Test fracture for each gradation test until the fracture running average is above the lower warning limit. Subsequently, the contractor may reduce the frequency to one test per 5 gradation tests if the fracture running average remains above the warning limit.
- (6) Test the liquid limit and plasticity index for the first gradation test. Subsequently, test the liquid limit and plasticity index a minimum of once per 5 gradation tests.

Perform the work under this construction contract for Project 2016-72-08 CTH N, (P-71-929) Bridge over Yellow River (STH 80 – STH 186), Wood County, Wisconsin as the plans show and execute the work as specified in the State of Wisconsin, Department of Transportation (Department), Standard Specifications for Highway and Structure Construction, 2016 Edition, as published by the department, and these special provisions.

2) Scope of Work.

The work under this contract shall consist of bridge painting for Wood County Highway (County), and all incidental items necessary to complete the work as shown on the plans and included in the proposal and contract.

3) Prosecution and Progress.

Begin work within ten (10) calendar days after the engineer issues a written notice to do so. This contract requires the Contractor to complete the work by 5:00 PM, Friday June 17, 2016.

To revise the start date, submit a written request to the engineer within five (5) business days from receiving the Notice to Begin Work. The engineer will approve or deny the request based on the conditions cited in the request and its effect on the County's scheduled resources.

The County will purchase the Materials for the Coating System. The contractor must submit their source from the department's approved list for "Structure Repainting Recycling Abrasive Structure". See Materials 11. B

4) Certificate of Insurance

The prime Contractor and all sub-Contractors shall provide a Certificate of Insurance on forms acceptable to Wood County Highway Department. This shall be submitted to the County before a contract is signed.

5) Traffic

The County will provide traffic control for the project. The Contractor will be able to store equipment and materials within the work zone.

Temporary traffic signals will be used to control traffic through the work zone and limit the work zone to one lane. The County will supply and erect all advance traffic control signs, barricades and drums.

The County **IS NOT** going to erect concrete barriers for this project. If the contractor would like concrete barriers, then the contractor will furnish the concrete barriers at their expense.

6) Holiday Work Restrictions.

7) Utilities.

There are three utilities attached to the structure on the south side. Contractor is to work around the utilities, no conflicts are anticipated.

8) Containment and Collection of Waste Materials P-71-929, Item 517-4000.S.

A Description

This special provision describes providing a dust collector enclosure; furnishing and erecting enclosures as required to contain, collect and store waste material resulting from the preparation of steel surfaces for painting, and repainting, including collection of such waste material, and the labeling and storage of waste material in approved hazardous waste containers, all as hereinafter provided.

B Materials

County shall provide containers for containing the spent material.

C Construction

Erect an enclosure to completely enclose (surround) the blasting operations and power tool cleaning. The ground, slope paving, or roadway cannot be used as the bottom of the enclosure unless covered by approved containment materials. So that there are no visible emissions to the air or ground or water, design, erect, operate, maintain and disassemble the enclosures in such a manner to effectively contain and collect dust and waste materials resulting from surface

preparation and paint over spray. Suspend all enclosures over water from the structure or as approved by the engineer.

Construct the enclosure of flexible materials such as tarpaulins or of rigid materials such as plywood, or of a combination of flexible and rigid materials and meet SSPC Guide 6 requirements with Level 1 emissions. The tarpaulins shall be a non-permeable material, either as part of the tarp system or have a separate non-permeable lining. Maintain all materials free of tears, cuts or holes. The vertical sides of the enclosure shall extend from the bottom of the deck down to the level of the covered work platform or covered barge where used for structures over water, and shall be fastened securely to those levels to prevent the wind from lifting them. Bulkheads are required between beams to enclose the blasting area as approved by the engineer. Where bulkheads are required, construct them of plywood and properly seal them. To prevent spent materials and paint over spray from escaping the enclosed area, overlap and fasten together all seams. Place groundcovers under all equipment prior to operations or as approved by the engineer.

To allow proper cleaning, inspection of structures or equipment, and painting, provide safe adequate artificial lighting in areas where natural light is inadequate.

Contractor shall provide adequate ventilation, respirators, and any other devices needed to perform work inside the Containment enclosure. Contractor shall contain all dust and materials inside the Containment enclosure and remove it daily.

After all debris has been removed and all painting has been approved in the containment area is complete, remove containment in accordance with SSPC Guide 6.

As a safety factor for structures over water, provide for scum control. Provide a plan for corrective measures to mitigate scum forming and list the procedures, labor and equipment needed to assure compliance. Effectively contain the scum that forms on the water and does not sink in place from moving upstream or downstream by the use of floating boom devices.

If in the use of floating boom devices the scum tends to collect at the devices, contain, collect, store the scum, and do not allow it to travel upstream or downstream beyond the devices. Remove the scum at least once a day or more often if needed.

Collect and store at the bridge site for disposal all waste material or scum collected by this operation, or any that may have fallen onto the ground tarps. Collect and store all waste material and scum at the end of each workday or more often if needed. Storage shall be in provided hazardous waste containers. Label each container as it is filled, using the labels provided by the Hazardous Waste Disposal contractor. Secure all containers at the end of each workday. Keep the containers covered at all times except to add or remove waste material. Store the containers in an accessible and secured area, not located in a storm water runoff course, flood plain, or exposed to standing water.

Collect the spent debris by vacuuming, shoveling, sweeping, or by channeling it directly to disposal containers. The enclosure shall be thoroughly cleaned at the end of each work day.

D Measurement

The County will measure Containment and Collection of Waste Materials (Structure), completed in accordance to the contract and accepted, as a single complete unit of work for each structure designated in the contract.

9) Disposal of Waste Material

The County shall furnish and deliver appropriate hazardous waste containers to place disposal of waste material. The County will arrange for pick up and disposal of the waste generated from the CTH N structure.

During paint removal operations, continuously monitor and notify the engineer of the status of waste generation and quantity stored so that timely disposal can be arranged.

The County will provide a Special Waste Profile Sheet to be kept with the Contractor until the waste is removed and disposed of at <u>Advanced Disposal Cranberry Creek Landfill</u>, <u>LLC</u>.

10) Structure Repainting General.

A General

A.1 Inspection

On all structures in this contract, notify the engineer of any missing or broken bolts or nuts, any missing or broken rivets, or of any cracks or flaws in the steel members while cleaning or painting.

A.2 Date Painted

At the completion of all painting work, stencil in black paint or contrasting color paint the date of painting the bridge. The numbers shall be three inches (75 mm) in height and shall show the month and year in which the painting was completed: e.g., 11-95 (November 1995). On each bridge painted, stencil the date at two locations. On truss bridges, stencil the date on the cover plates of end posts near and above the top of the railings at the oncoming traffic end. On steel

girder bridges, stencil the date on the **inside** of the outside stringers at the abutments. The date on grade separation bridges shall be readable when going under the structure or at some equally visible surface near the ends of the bridge, as designated by the engineer.

C Construction

C.1 Repainting Methods

Do not perform blasting, cleaning and painting on days of high winds. Prevailing winds in excess of 15 mph (25 km/hr) shall be considered high winds.

Place the final field coat of paint on the exterior of the exterior beams as a continuous painting operation. Stop at splices, vertical stiffeners or other appropriate locations so that lap marks are not evident or noticeable.

Completely clean and remove spent abrasive and other waste materials resulting from the contractor's operation from bridge deck surfaces, gutter lines, drains, curbs, bridge seats, pier caps, slope paving, roadway below, and all structural members and assemblies.

C.2 Inspection

Furnish, erect and move scaffolding and other appropriate equipment to permit the engineer or inspector the opportunity to closely observe all affected surfaces. The scaffolding, with appropriate safety devices, shall meet the approval of the engineer.

11) Protection of Workers

For purposes of this contract, all spent materials from paint removal operations shall be handled and managed as "hazardous". In this regard, the contractor's attention is directed to standard spec 107.7 on Safety, Health and Sanitation, and as follows:

Provide and require all employees to wear all personal protective equipment required for the environment to which the workers are subjected, and provide medical monitoring as required for those employees in the work area. This shall include, but not limited to, air supplied respirators, eye protection, ear protection, fall protection, protective clothing and other such items. Provide for the decontamination of workers and authorized persons in the work area so that no lead contamination leaves the work area on the bodies or clothing of those persons.

12) Structure Repainting Recycled Abrasive P-71-929, Item 517-1800.S.

A Description

This special provision describes surface preparation and painting of the metal surfaces in accordance to the manufacturer's recommendations and as hereinafter provided.

A.1 Areas to be Cleaned and Painted

All structural metal surfaces of:

1. Structure P-71-929 1,380 SF.

Areas are approximate and given for informational purposes only.

B Materials

B.1 Coating System

Furnish a complete coating system from the department's approved list for "Structure Repainting Recycle Abrasive Structure". The color for the finish coating material shall match the color number below in accordance with Federal Standard Number 595B, as printed in 1989. Supply the engineer with the product data sheets for approval before any coating is applied. The product data sheets shall indicate the mixing and thinning directions, the recommended spray nozzles and pressures, and the minimum drying time between coats.

Finish Color: 26293 (GRAY).

The color of the primer must be such that a definite contrast between it and the color of the blasted steel is readily apparent. There shall be a color contrast between all subsequent coats for the paint system selected. Submit color samples of the primer and all coats to the engineer for approval prior to any application of paint.

C Construction

C.1 Surface Preparation

Prior to blast cleaning, solvent clean all surfaces to be coated in accordance to SSPC-SP1.

All metal surfaces must be blast cleaned in accordance with SSPC-SP10 and verified prior to painting.

Upon completion of surface preparation, test representative surfaces, which were previously rusted (i.e. pitted steel) for the presence of residual chloride. Perform Surface Contamination Tests (SCAT) in accordance with the manufacturer's recommendations. The tests must be witnessed by the Engineer. If chlorides are detected at levels greater than 7ug/cm², continue to clean the affected areas until results are below the specified limit. Submit anticipated testing frequencies and chloride remediation methods to the Engineer for review and approval.

Apply the prime coat the same day that the metal surfaces receive the No. 10 blast or re-blast before application. Cleaned surfaces shall be of the specified condition immediately prior to paint application. If rust bloom occurs prior to applying the primer, stop the painting operation in the area of the rust bloom and re-blast and clean the area to SSPC SP-10 prior to applying the primer.

The steel grit and any associated equipment brought to the site and used for blast cleaning shall be clean. Remove immediately dirty grit or equipment brought to the site at no expense to the county. Furnish an abrasive that has a gradation such that it will produce a uniform surface profile between 1 to 3 mils on the steel surface, as measured in accordance with ISO 8503-5.

The abrasive blasting and recovery system shall be a completely integrated self-contained system for abrasive blasting and recovery. It shall be an open blast and recovery system that will allow no emissions from the recovery operation. The recovery equipment shall be such that the amount of contaminants in the clean recycled steel grit shall be less than 1 percent by weight as per SSPC AB-2.

Remove by grinding all fins, tears, slivers, and burred or sharp edges that are present on any steel member, or that appear during the blasting operation, and re-blast the area to give a 1 to 3 mils surface profile.

Remove all spent material and paint residue from steel surfaces with a good commercial grade vacuum cleaner equipped with a brush-type cleaning tool, and test cleanliness in accordance with ASTM D4285. The airline used for surface preparation shall have an in-line water trap and the air shall be free of oil and water as it leaves the airline.

Take care to protect freshly coated surfaces from subsequent blast cleaning operations. Thoroughly wire brush damaged primed surfaces with a non-rusting tool, or if visible rust occurs, re-blast to a near white condition. Clean and re-prime the brushed or blast cleaned surfaces in accordance with this specification.

C.2 Coating Application

Apply paint in accordance to the manufacturer's recommendations in a neat workmanlike manner. Paint application shall normally be by airless spray or inaccessible areas by brush, roller or other methods approved by the engineer.

The engineer may allow the use of conventional spray equipment after satisfactory demonstration by the contractor of the proper application technique and handling of that equipment.

Mix the paint or coatings in accordance to the manufacturer's directions to a smooth lump-free consistency. Keep paint thoroughly mixed during the painting application.

After the inspector approves the entire cleaned surface to be coated, apply a prime coat uniformly to the entire surface. Either before or after applying the prime coat, brush or spray a stripe coat of primer on all plate edges, bolt heads, nuts, and washers. Apply succeeding coats as the product data sheet shows.

Remove all dry spray by vacuuming, wiping, or sanding if necessary.

If the application of the coating at the required thickness in one coat produces runs, bubbles, or sags; apply a "mist-coating" in multiple passes of the spray gun; separate the passes by several minutes. Where excessive coating thickness produces "mud-cracking", remove such coating back to soundly bonded coating and re-coat the area to the required thickness.

The resultant paint film shall be smooth and uniform, without skips or areas of excessive paint in accordance with SSPC PA1.

The coating is supplied for normal use without thinning. If in cool weather it is necessary to thin the coating for proper application, thin in accordance to the manufacturer's recommendations.

During surface preparation and coating application the ambient and steel temperature shall be between 39 degrees F and 100 degrees F. The steel temperature shall be at least 5 degrees F above the dew point temperature. (This requires the steel to be dry and free of any condensation or ice regardless of the actual temperature of the steel.) The relative humidity shall not exceed 85%. The manufacturer's ambient condition requirements must be followed if they are more stringent.

Paint thickness shall be within the requirements for a three coat paint system listed in the department's approved list for Structure Repainting Recycle Abrasive Structure and the paint system being used.

Time to recoat shall be according to the manufacturer's recommendations.

The dry film thickness will be determined by use of a magnetic film thickness gage. The gage shall be calibrated for dry film thickness measurement in accordance to SSPC-PA 2. Dry film thickness in each area measured will be based on an average of three gage readings, after calibration of the gage to account for surface profile of the bare steel as a result of surface preparation.

D Measurement

The department will measure Structure Repainting Recycled Abrasive (Structure) as a single complete lump sum unit of work, completed in accordance to the contract and accepted.

13) Portable Decontamination Facility, Item 517.6001.S.

A Description

This special provision describes furnishing and maintaining weekly, or more often if needed, a single unit portable decontamination facility as hereinafter provided.

B Materials

Supply and operate all equipment in accordance with OSHA.

The portable decontamination facility shall consist of a separate "Dirty Room" and "Clean Room". The facility shall be constructed so as to permit use by either sex. The facility shall have adequate ventilation.

The "Dirty Room" shall have appropriately marked containers for disposable garments, clothing that requires laundering, worker shoes, and any other related equipment. Each container shall be lined with poly bags for transporting clothing, or for disposal.
