MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE November 2015

- 1. Paternity Appeal. Last month I reported that the court of appeals granted the county's motion to dismiss based upon the appellant's failure to timely file a brief. That appellant has now petitioned the state supreme court to review the case. The appellant does not have a right of review in the Supreme Court as one does with the court of appeals and in most instances the Supreme Court will not grant review. I will keep the committee posted on the case in light of its very public nature.
- 2. Biron Business Park bill for financial consulting services incurred by the county. Nothing further has been heard from the Village of Biron nor has any additional documentation surfaced pertaining to the financial consultant fees. I will discuss orally with the committee my recommendation as to how to proceed.
- 3. UW Marshfield-Wood County STEM Project. I've spent a fair amount of time working with others on reviewing and suggesting revisions to the Construction Manager contract for the UW STEM project. Eventually I will be involved in reviewing the contract with the architect as well.
- 4. Human Services Department Space Needs Ad Hoc Committee. Here again, a lot of time is being allocated to the work of this committee and that is likely to continue for a while.
- 5. Groundwater Subcommittee. I have drafted a number of resolutions at the behest of one of the members of the subcommittee.
- 6. Child Abuse/Neglect Substantiation Appeal. As I have advised the committee in the past this particular appeal was, in my mind, inappropriate to take to hearing and I felt the Human Services administration should have consented to a deferred prosecution type of agreement. They didn't concur so I handled the appeal for the county. A hearing was held and the Administrative Law Judge has thirty days to render a decision and my guess is that the substantiation determination will be overturned due to there being a lack of a sufficient injury to constitute abuse. I have shared with the Human Services administration my perspective that they need to exercise discretion but they don't see it that way. If another such case comes up where it appears to me the county is acting inappropriately, I have advised I will likely take the case to the director. Meanwhile the administration will be discussing the facts at a training session they are going to as this is an evolving area.

Peter Kastenholz, Proposed Goals for 2016

- 1. Legal Memos to the County Board. I am proposing to continue the every other month memos for another year and to focus on legal information that would be useful for managers that they wouldn't likely be getting via conferences they attend or publications they read.
- 2. There have been so many projects that suddenly come up that demand my attention; I think it makes sense to set forth as a goal the proper handling of these unspecified projects that inevitably arise during the course of a year.

Escrow Payment Fund: Customer money being held for future activity.

County Transfer Fee Fund: County retains 20% of all Transfer Fees collected.

<u>County VitalChek Fee Fund:</u> County retains \$10.00 from every person requesting a vital record online via Vitalchek.

<u>Laredo Remote:</u> County collects a fee from customers using Laredo software outside of the courthouse.

State DOA Fund: Signing of state budget bill 10/26/2007 increased birth certificates by \$8, marriage and death certificates by \$13.00, and the expedite fee by \$10.00. All monies to be mailed to the Department of Administration. The increase was enacted to come into compliance with recent federal laws. The monies will be used to automate outdated paper registration, archiving and copy issuance systems at the State and local vital records offices.

Reports Fund: County collects a fee (.50/page) from customers requesting reports.

Register of Deeds Fund: County retains all remaining recording fees (\$15.00 from each document recorded. \$5.00 from each first copy of every birth record sold. \$7.00 from each first copy of every death and marriage record sold. \$3.00 for each extra copy of vital records sold.)

<u>County Land Record Fund:</u> Effective June 25, 2010 statutes provide that \$8.00 is retained for the provision of land information on the internet and for Land Records modernization.

State Transfer Fund: State collects 80% of all Transfer Fees collected.

State Birth Fund: State collects \$7.00 of every birth record sold.

State Land Record Fund: State collects \$7.00 from each document recorded.
