New Deputy Coroners: Both Amanda and Josh are taking calls on their own at this point. Any of the senior staff of the department are available to assist them when needed. With current staffing, we now have good coverage county wide, which hopefully, will reduce our response times to scene calls.

Covid: We handled 3 confirmed Covid related deaths in the month. We also had several other cases where families have requested we change death certificates, signed by physicians, to include Covid or "long term Covid." With these cases, we must request additional or initial medical records for review in determination of these cases.

Projects: The deputy coroners and I are currently working on a mission statement and policy/procedure manual for the office. It will take time, but my belief is we need to have one. With training of new employees, I found that south end runs things different from north end and sometimes even different between all of us.

I was tasked by Ms. Luchini from the health department to update the mass casualty incident (MCI) policy with respect to the coroner's office. While daunting, I have been given the materials necessary to accomplish this. When done, our office will develop a plan that meets the needs of the county but follows the Incident Command Structure (ICS.)

Notes: (The notes below reflect to the categories above in the y-t-d)

- 1. This is the total combined deaths in Wood County as recorded by this office, both hospitals, all nursing homes, and all hospice agencies in Wood County.
- 2. These are the total number of calls for service for the Wood County Coroner's office when paged through dispatch. These are: scene calls, requests for cremation permits, hospice calls, follow up calls regarding cases and any other inquiries paged to us via dispatch. While this number may seem high, it is quite low. This is due to the fact most funeral homes we work with now have our personal cell phone numbers and call us directly for cremation permits.
- 3. This is the total number of deaths due to natural causes that are signed by this office. These include scene deaths, both hospital deaths (Marshfield Medical and Aspirus Riverview) that occur in their respective Emergency Rooms, some hospital deaths where the decedent has been admitted less than 24 hours, any case where the State of WI has rejected the physician's cause of death and referred the case to our coroner's office and, lastly, any case where the signing physician is unable or unwilling to sign the cause and manner of death.
- 4. This, unfortunately, is our elderly population. Most of these falls result in injury to the victim of which they simply can't recover from. Typically, these are hip or femur fractures. These falls can also cause significant head injuries, or in a case from July, significant rib fractures. With the elderly, they are often frail or have other comorbidities and they simply can't overcome the traumatic injury sustained from a fall and resulting injury.

- 5. While the Covid virus still exists, the number of deaths related to it have significantly decreased. For July, Wood County had three deaths directly related to Covid infection. The issue we are currently experiencing is an individual may expire due to something while previously having had Covid. In these cases, we will review and determine if Covid is/was related to the death.
- 6. While typically motor vehicle accidents (autos), this also includes motorcycle accidents and in May, includes a pedestrian vs. motor vehicle.
- 7. Fortunately, we have not had any snowmobile or UTV/ATV related deaths to date. With the vast amount of snowmobile and ATV/UTV trails within the county, combined with the recent change of allowing UTV's on county roadways, I initially suspected this number would be greater than zero. While these accidents have occurred in the past, hopefully both operators of these vehicles and motor vehicle operators will keep safety in mind.
- 8. Suicide is such an individual choice with many variable options. For the year, Wood County has seen six suicides. Upon responding to a suicide, our office will request medical records and retain blood for toxicology purposes. While being suicides, we take this extra step in looking for the frame of mind of the decedent at the time of death.
- 9. While we have not any overt homicide cases to date, we should keep in mind the potential time involved between investigation (law enforcement, DA, and our office) and determination of a homicide case. We do have current cases that may end up being homicide cases.
- 10. Overdoses fall into two categories intentional and accidental, with respect to manner of death. Intentional would be considered a suicide. Accidental is a true "accident" as in the person took to many prescribed medications that took their life. More commonly, "accidental" involves the use of illicit drugs. With respect to the cases, out of the current 7 listed, only 1 is due to suicide. The remaining 6 are due to illicit street drugs, most commonly involving Fentanyl.

- 11. The "other" category is a "catch all" category for deaths that do not directly fall into other categories. To date, we have had two cases of hypothermia, one decedent expired from a house fire and in July, one individual expired from positional asphyxia.
- 12. This is the total number of death certificates signed by our office by month. These include, but are not limited to, scene death investigations, hospital ER deaths, deaths "kicked back" to our agency by the state, calls received by funeral homes and any death not signed by a physician.
- 13. This is the total amount of cremation permits signed by our office. Due several variables, cost being the major factor, most families are opting for cremation over traditional burial. A second driving force for cremation is simply a lack of preplanning on the part of individuals and families. Currently, our cremation to burial is 76% cremation.
- 14. Most of the autopsies are unfortunately drug overdose related. Out of the eight autopsies performed, only two have been out of medical necessity. The purpose of performing an autopsy on a suspected drug overdose to assist law enforcement and the DA's office in the potential future conviction of the drug supplier.

Gentlemen,

First and foremost, my intent as coroner has never been to cost the county more with respect to my budget. I understand that as past practice, every prior coroner stored supplies at their respective residence and basically ran this department from their home. The exception being, Coroner Hamm had a small amount of office space at the courthouse to conduct coroner duties from.

Currently, we have old files stored in banker boxes underneath the stairs at the courthouse. These files need to be properly stored in file drawers for ease of accessibility and better organization. While I say they are "old" they just predate when the coroner's office went to electronically written and stored format. My understanding is this has only been approximately five years ago. We still get questions with respect to these cases from law enforcement, insurance companies and families of the deceased.

The second issue, and probably more importantly, is the legality of storing some of these files at a residence after the individual is no longer coroner. Not to create any issues, but to simply point out my concern, is since Coroner Brehm stepped down in May 2021, I have had two text messages from him. One was to pick up case files, photographs, and legal coroner files he had found at his residence. The second was to pick up coroner supplies he had found. Since he was no longer affiliated with the coroner's office, I promptly retrieved these legal documents and supplies, taking them into my care.

It is easy to have the supplies located at my residence for dispersing when needed. However, these supplies must be moved around as coroners change. Further, all these supplies are property of Wood County and not the individual who is the current coroner.

I have spoken to Mr. Van Tassel with respect to this issue. He stated that in the proposed new jail, we would have a room that will contain a refrigerator for the storage of the deceased going to autopsy. He did not indicate that there would be office space allocated to the coroner.

I would like to investigate the possibility of having all the coroner files and supplies in one central location. Due to the nature of our business, we would need to have 24-hour access to the supplies.

With the budget process looming, I would like to have discussions and get your thoughts on this matter.

Gentlemen,

Currently, the deputy coroners are using their own personal computers to complete the written reports with respect to their cases. These reports, along with cremation permits, photographs and other sensitive data is currently stored on their laptops and computers. I am, as a department head, the only individual who has an actual Wood County assigned computer for coroner use.

A problem has arisen with respect to getting the information from the deputy coroners' computers to the Wood County assigned computer for storage purposes. The IT department has recently invoked a policy of not allowing storage drives plugged into their computers. I understand this policy. For the short term, I was given permission to use storage drives for the purpose of file transfers from the deputy coroner computers to the Wood County computer I have.

IT has come up with two options to rectify this situation.

Option 1: The coroner's office would purchase from IT six "protected" storage drives from IT. The cost would be \$1,119.95 (one time fee). Each deputy would receive a storage device and I would be responsible for traveling to their residence to pick up the storage device, download the needed files and then return the device to the deputy for further use. To minimalize the amount of information on their personal computers, I would be doing this on a bi-weekly basis. Once I have the information, they can delete any coroner related information from their personal computers. The only thing that would remain on their personal computers would be extended cases where

they would have to update the cause of death after autopsy or toxicology is known.

Option 2: The coroner's office would purchase from IT the following: 5 IPads, 5 cases, 5 screen protectors, 5 keyboards and 1 Office 365 account. The initial cost is \$2,611.20. This, however, does have an annual cost of \$700.00 for the Office 365. Files, photos and documents could be stored, shared and retrieved at any time by myself or the deputies. I would also from the Wood County computer access this and properly store these files on the main storage drive for Wood County.

I do believe that while more costly, option 2 is the best for several reasons: First, it eliminates the need for any sensitive information with respect to decedent's being on any personal computer. Second, it makes storing these files simpler and faster than the use of shifting around storage drives around the county.

I went to Babcock to follow up on a complaint of hoarding/animal neglect. I was at this house last week but did not make contact with the suspect. Last week I did get information from the subject's son in law who wishes to remain anonymous. He said his mother-in-law has 5-8 dogs. I got to the house at 12:30PM. The subject's car was in the driveway and the door was open, but she did not come to the door. I knocked several times but no answer. At that time, I heard no dogs inside. I made phone contact with her after I left and told her why I was coming. She admitted to having 3 dogs and 1 puppy but claims no more. She admitted dogs were not licensed because she lost her job. I will follow up next month on licensures. She told me she would not let me inside her house to further investigate this anonymous complaint. I confirmed with Remington Town Treasurer that no dogs at that property are licensed.

7/12/22

Follow up on a complaint of "a white horse that looks like it could be cared for a little better" outside of Marshfield on CTH V. When I arrived, I noticed a small barn off to my left. There was a small pony and a large white horse. The horse appeared skinny, as I could see it's ribs starting to show. I went to the door and knocked but no one answered. I left my card and a note on the door asking the owners to call me when they return home. This case is ongoing. Update 4:30PM 7/12 owner of horse called me and followed up on my visit. She stated that she has been trying to put weight on the horse for awhile but nothing seems to be working. She is open to calling a vet and open to suggestions on supplements to purchase. I reached out to Karen at Midwest Horse Rescue for suggestions and will call back with information this week. Update: Didn't hear back from Karen but gave some other advice to owner of horse that she is going to look into this weekend. I will call with Karen's advice as well. I have this as a September follow up.

Follow up on a complaint of dog abuse off Baker St in Rapids. On 7/11/22 I went to City Hall/Police Station to retrieve a file from Officer Guse. The complainant turned in video footage of her neighbor hitting his dog. It was hard to tell on the video because it was taken through a fence, but it was apparent that the man residing at this residence did hit the dog outside. Officer Guse could not make contact with the owners so I went there today 7/12/22. I did make contact with a man and a woman who owned the black and white dog (Milo). The woman's name was Sheyenne. The man would not talk to me or disclose his name. They said Milo is under 1 and a very energetic puppy. The dog appeared to be in good condition and was very friendly. I talked about why I was there and the man, who was a younger man with dyed, bright red hair, would not cooperate in talking with me. I advised them to look into training for the puppy if the energetic nature of the dog jumping and running around was the problem. I told

them I would help them look into trainers in the area and to call me if that was something they wanted to look into. They would not admit to hitting the dog or anything of that nature, and due to this being an anonymous complaint I did all I could at that time. Update 5PM neighbor that had seen the abuse called me again and stated he's hitting the dog again and throwing a small hard ball at him. I called Officer Guse and we are going to go over there Friday late morning to speak with this man again. This is an ongoing case. Update: I went back to the house with Officer Guse, no one was home so we left a door hanger. The tenant called me back and I informed him of the situation, he insisted he swats at the dog for digging holes but does not beat his dog. He did give me his name for the report on file and was cooperative with the conversation. Case is closed.

Dog bite reported in Biron at trailer park. I arrived at 1:45PM where I made contact with owner of the biting dog, Barb. No one has details regarding who owns the dog. Dog was at neighbors house next door, neighbor recently passed away. Ex wife said maybe it was someone related to previous owner but she doesn't know- all the info she gave me was it was a german shepard and they might not be from town. I do not have a dog to quarantine as I do not have any information about where this dog resides or belongs to at this time. Update: Late afternoon on 7/15 I was called by bite victim Ryan. I told him how the Rabies Control Law works and informed him I could not just go take this dog. He stated that he was going to the residence and would try to get more information for me. Matthew stated that him and Ryan were best friends but he was trespassing. Matthew says his dog did

not bite him and that Ryan and his wife are "picking on him and his dog and want him to lose his dog", he admits to having a german shepard but that the dog wasn't there that day and that it was a black lab. I called aspirus walk in and verified that ryan was seen the morning of 7/15, morning after the bite. Matthew will be called and told to quarantine his dog because I have "reason to believe" it was his dog. He is a 2 officer assist with record so I will be bringing an officer with me to deliver the rabies control report tomorrow. Still unknown as to whether or not dog is up to date on rabies. 12:00PM Matthew called me back and told me "good luck" with cooperating with quarantine order and he hung up on me. Before hanging up he stated that Ryan better not trespass on his property anymore. I advised him that anything beyond the rabies control law would have to be dealt with by an officer as I do not enforce those laws. Still no proof of rabies vaccination. Dog vs dog on the west side of Rapids. Contact was made with both parties. I saw the injury and stitches of the dog that was bit and received a copy of the vet bill. Working on a word document for this case, pictures included there. Owner of dog that attacked was talked to. He told me he is willing to cooperate with victim and pay vet expenses. Owner of dog that was attacked was contacted and given offender's number. They're keeping me updated as details progress and payments are arranged. UPDATE: Payment by offender given to victim for vet cost + damages on 6/28. I have a detailed report of this case in case it's needed.

I was contacted a few days ago by dispatch that there had been a complaint of a skinny horse off CTH HH. Police had been out and confirmed that horses are all properly fed and watered but said one horse looked skinny but couldn't quite tell from where he was standing so I followed up and went to farm. No one was home, but I drove around and observed a very well-groomed farm and pasture. From what I saw, I did not see any concerns with the animals on that farm. I left my card for owners to contact me and will follow up once more if I do not hear back from them.

Cat bite called in that happened a few days ago. Followed up with both parties. Dispatch did not have working number for offender (Brenda) so I drove to her house. She lives with victim's elderly father. Offender was sleeping as she works nights so I spoke with Tom, the father of victim Jackie. paperwork, and my card. I told her to call me with questions. As from what I know now, cat will have to quarantine for remainder of 10 days because no rabies paperwork present. 

HEMP-DERIVED CANNABINOIDS

The 2018 Farm Bill legalized industrial hemp with less than 0.3% tetrahydrocannabinol (THC). By defining THC as delta-9 THC, authors of this bill unintentionally created a market for legal hemp-derived synthetic cannabinoids that are psychoactive and intoxicating.



What is Delta-8 THC?

Delta-8 THC can be naturally occurring in the cannabis plant in small quantities and is estimated to be about 50-75% as psychoactive as delta-9 THC.

Manufacturers refine hemp to extract cannabinol (CBD) and produce synthetic delta-8 THC that is added to products that are generally marketed to youth.



TRAINING (MONTHLY) -

The Wood County K9s trained with the Nekoosa Police Department in July. Focus this month was on narcotic work and high risk stops. K9s worked on narcotic detection on vehicles, lockers, open area, and inside buildings. K9s also performed tracks while at Auburndale High School. K9s worked on obedience with a muzzle on and had positive physical contact in case of a medical emergency. Training venues included Auburndale High School and a property at 5609 Trestik Dr.

TRAINING (INDIVIDUAL) -

- Sergeant Arendt and K9 Timo trained 3.0 hours while on duty. During training, they focused on narcotic detection (vehicles, open area, and buildings) and obedience.
- Sergeant Christianson and K9 Ace completed four hours of on duty training. This consisted of working with special response team on building search for person. Also working with patrol members for building search for person. They also completed several narcotic detections.
- Deputy Beathard and K9 Rosco completed 2.5 hours of training while on duty. This consisted of training in obedience, narcotic detection, and tracking.

Security Services July 2022 Report

For the month of July 2022, the total number of prohibited items prevented from entering the Courthouse are:

Guns - 1 Knives - 115 O.C. - 9 Misc. Items - 3

The miscellaneous items that were located were a Taser, shotgun shells and a corkscrew. On July 21st, a woman came into the courthouse with a gun in her purse. She did have a valid CCW permit. She was educated on the law of CCW and the firearm was returned to her vehicle.

Security Services screened 7,618 people entering the courthouse for the month. Security Services had 40 security requests from different departments within the Courthouse. We handed out four masks for the month and had two jury trials.

For the week of the 11th through the 15th, Security Services handled a Criminal Damage to Property complaint in the jail, looked into damage done to a contractor vehicle by a delivery truck in the sheriff's dept. parking lot and arrested a subject, on warrants, that came into the courthouse.

For the week of the 25th through the 29th, we handled a complaint in the jail were jail staff located drugs on an inmate. Later that week there was a dispute in front of the courthouse between a woman and a man. The dispute quickly progressed to the point where security had to intervene and break them up. Security also assisted a male subject who got sick in court and then collapsed in the third floor hallway. An ambulance was called to evaluate the subject.

For the month of July, I utilize part-time employees for 41 hours. These part-time hours were used to cover full time deputies' time off.



Inspection Process: The annual inspection of the facility was conducted pursuant to WI Statute 301.37(3). The inspection compared the facility and its operation to applicable state statutes and Department of Corrections administrative code. This inspection consisted of a tour of the facility to assess the safety, sanitation, adequacy, and fitness of the facility; dialogue with staff and inmates; and a review of facility records and documentation.

Inspection Results:

The following code violations were noted:

Wisconsin Administrative Code DOC 350.16 Control and Administration of Medications

A spot check of the Medication Administration Record (MAR) revealed noncompliance as there were multiple areas of missed documentation. The facility has new nursing staff so the importance of this documentation and possible solutions were discussed on the day of inspection.

Wisconsin Administrative Code DOC 350.18 Security

A review of the documentation provided on the day of the inspection revealed noncompliance as there were overages observed in both the 15-minute and 60-minute wellness checks. Administration verified that in preparation for the inspection they noted the overages and reviewed video for the undocumented checks. In each instance, they reported staff did in fact complete the wellness check, they just forgot to hit the button, and were in fact observed having conversations with inmates at the time of the undocumented check. The issue has been addressed via an email from administration to staff and in staff meetings.

Inspection Comments:

Jail populations continue to be high and the population listed above includes the safekeeping of inmates in both Adams and Waupaca counties, as well as those eligible inmates placed on electronic monitoring (EMP). Efforts to maintain the inmate population continue on a daily basis and are expected to be relieved with the completion of the new jail. Groundbreaking is currently set for September of 2022.

The following initiatives were identified for 2022:

- Continue the Veterans Court initiative
- Partnered with Three Bridges to Recovery for inmates with heroin dependency issues
- Partnership with Mid-State Technical College to provide GED, HSED & technical course prep
- Bonds for Failure to Pay are converted to civil judgements
- EMP Sergeant Position created to run the EMP / HUBER programing
- Discharge planner position continued
- NARCAN program initiated with BSSA for inmates and citizens
- Grant submitted for a Medically Assisted Treatment (MAT) program
- Contracted with TurnKey for inmate communication and commissary
- UV Light placed in air handlers and portable units used to sterilize blocks

• Added additional video conferencing equipment to address increased video requirements

• Put together a jail transition team to address policy and procedure changes

• New jail groundbreaking is tentatively set for September 2022

The facility contracts with Southern Health Partners to provide 60 hours of medical coverage a week. In addition, Aspirus provides 60 hours of mental health coverage each week. Your administration is commended on recognizing the importance of providing adequate medical and mental health services, ensuring inmate needs are being met.

Trinity Food Services prepares inmate meals under the direction of Kitchen Manager Paula West. The Wood County Health Department completed the annual kitchen inspection on 2/10/11, and the annual menu review was completed on 4/29/22.

The Wisconsin Rapids Fire Department completed fire inspections on 2/7/22 and 5/20/22. All internal monthly fire and safety inspections were completed.

During a walkthrough of the jail, the facility appeared to be clean and in good condition. While conducting the inspection, the following items were noted:

• The H and J dorms had large areas of missing floor tile. This is a potential safety risk for staff and inmates and a suitable solution should be identified.

 On the day of the inspection, I entered the housing units to check conditions and speak with inmates. It is notable that inmates in <u>every</u> housing unit had extremely positive things to say about staff interactions. Your staff is commended on their professionalism and the time they spend interacting with inmates.
