Wisconsin Wins: Thank You Retailers

The Wisconsin Wins Program is a campaign designed to decrease youth access to tobacco/nicotine products. The *Central Wisconsin Tobacco Free Coalition*, in partnership with the *Wood County Health Department*, *Healthy People Wood County Coalition*, and local law enforcement agencies, have been conducting retail compliance checks around Wood County to establish retailer compliance with the law. In Wood County a minimum of 54 'checks' must be completed in 2016.

A group of four Wood County youth attempted 60 'checks' and were able to complete 53 'checks' between March and July 2016. The *Central Wisconsin Tobacco Free Coalition* and *Healthy People Wood County* would like to thank the following retailers for complying with the law and not selling tobacco to youth under 18 years of age in Wood County.
