1. At 8:30 a.m., Chairman Clendenning called the meeting to order.

- 2. Attendance sheet was circulated and is attached.
- 3. Motion by Wagner/Curry to approve the minutes of the July 7, 2017 committee meeting. All ayes.
- 4. Public comments.

Rules regarding public comments were explained by Chairman Clendenning. He asked those assembled to appoint a spokesperson.

- Chairman Clendenning without objection moved item 9b up to 5. this point based on the number in attendance and interest in Motion by Leichtnam/LaFontaine to present this item. resolution for discussion. Mark Borchart was recognized and explained his experience and interaction with Enbridge. This group presented a draft bill removing the ability of Enbridge to use eminent domain laws. Discussion centered on eminent domain history, legislators and their positions, similar and previous versions of similar resolutions, and other similar groups that have organized statewide. Names of those groups will be provided to the committee. Others present were recognized and related their personal experiences in the history of Enbridge and their properties. Leichtnam/LaFontaine to forward resolution as written to county board with the reminder that should changes be made, a special meeting would have to occur before the packet deadline of this coming Wednesday at 2:00 p.m. carried with all ayes.
- 6. The Committee reviewed monthly voucher reports and the department head reports of the departments they oversee. Child Support Director Vruwink brought the committee up to date on his efforts to resolve the workload increase due to E-filing. Motion by Curry/Leichtnam, to approve the payment of vouchers and accept the reports. Motion carried with all ayes.
- 7. The Committee reviewed the notices of injury/claim of Ralph Tritz, Eugene Ellis, Darwin Kasner (3). These notices will be provided to the county board.

- 8. There were no new animal claims against the County.
- 9. Discussion with Brandon Vruwink on authorizing placement at Northwest Regional Juvenile Detention Center. Vruwink explained the need for county board approval of any placement of individuals at this facility. Motion by Wagner/Leichtnam, to move the resolution forward to the county board. All ayes.
- 10. The Committee reviewed correspondence and legislative issues. Chairman Clendenning wished to discuss with the committee a request from Representative Krug to address the county board regarding current legislative issues. The consensus of the committee was that there is an open invitation to discuss issues with this committee at every meeting and it is appropriate for legislators to do so.

Corporation Counsel's memorandum "Open Meetings Law - What is a formally constituted subunit?" will be forwarded to the county board.

The county clerk will research and find the recommendation to the county board from the ad hoc committee that was formed in 2013 related to same subject.

State Birth Fund: State collects \$7.00 of every birth record sold.

State Land Record Fund: State collects \$7.00 from each document recorded.

MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE September 2017

- 1. <u>Goals</u>. Ordinance Recodification Project. I sent a reminder to the department heads to give an update on ordinance changes they were working on. Some are done and some will be wrapping theirs up in early September. One glitch that was just brought up is the Sheriff's Department and its concern that retaining squad and body camera video for 121 days verses the current 30 days (with exceptions) will take up too much storage space at a significant cost to the county. IT is looking into that cost but this may result in a significant delay in completing the revisions to the record retention ordinance and, therefore, the entire recodification process. I'll keep you posted.
- 2. Confidentiality of Performance Evaluations. A few years ago I wrote a memo explaining to the department heads and county board supervisors that performance evaluations of department heads and other senior management staff are not confidential and must be released if a request for them is made. Recently such a request was made by a disgruntled former employee for multiple years of performance evaluations of the HR Director, Norwood Administrator, and me. Those evaluations were released. The fact that these performance evaluations are open to the public has several negative consequences that likely outweigh the interest of the public in making them available. Such negative impacts include the reduction in desirability of these top management positions and the resulting difficulty in drawing top candidates to the positions. Another consequence to the openness of the evaluations is that it impedes the elected officials conducting the assessments from being as candid as desirable due to the knowledge that their critiques will be accessible to everyone, including the employees the manager supervisors. There is a natural and logical reticence to undermining the authority of a department head and making publicly available a manager's performance review has that effect. Related to this would be the problem in terminating a manager for poor performance. If the performance evaluations haven't been candid with respect to performance deficiencies due to a desire not to undermine the authority of the manager and a desire not to embarrass them, then disciplinary actions and terminations of the manager appear to be based upon non-legitimate reasons, such as prohibited forms of discrimination. Meanwhile, what is gained by availing the public of these performance evaluations? With that mindset, I am suggesting that the committee may be interested in sponsoring legislation that treats the performance evaluations of local public officials (department heads and some other managers) the same as those of other employees, that being, exempting them from availability to the public under the Public Records Law.

- Vicki Stoflet attended a State Child Support Self-Assessment work group meeting in Madison on August 17th.
- Nicole Stelzer continues to be involved in the work group that is putting together changes to the foster care referral process. The changes are expected to be implemented on January 1, 2018.
- The agency will be busy at the end of the month putting the finishing touches on the WCSEA Fall Conference that we are hosting at the Hotel Mead in October.
- Agency performance continues to exceed Federal Performance measures. We will be working diligently to improve the numbers even more during September which is the final month of the federal fiscal year.
- The current IV-D case count is 3,962.

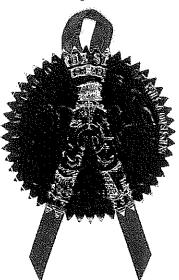

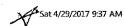

Ad Hoc Administrator Study Committee

The minutes of the June and final *ad hoc* Administrator Study Committee meeting are in this packet. The committee has completed the task of studying administrative options for Wood County. This memo will summarize the committee recommendation.

During the past three months, the committee reviewed a large volume of information, including facts sheets, data on administration of other counties, survey results from other counties, statutory definitions, information from the 2004 ad hoc committee which examined this topic, and all the pros and cons previously compiled by department heads. The committee interviewed our current county chair and administrative coordinator Lance Pliml about the duties and time commitment of the dual position, consulted with our corporation counsel on the legal considerations, and interviewed both the county administrator and the county chair of Dodge County, a county of similar population which added a full-time county administrator. Comments from various department heads were also considered, including comments from one of the "long-time" directors and the newest department director who had experienced both types of administrative operations in other counties. Supervisor Clendenning interviewed several other persons including some from adjoining counties and reported to the committee.

With all of the information considered, the committee voted 4 to 1 to recommend to the County Board that Wood County maintain the status quo at this time, having the County Board Chairperson serve the functions of the County Administrative Coordinator. Supervisor Nelson dissented.

Throughout the study, the committee heard very good comments on the current administrative function, the leadership of Chairman Pliml and the good working relationships between departments. The general feeling seems to be "if it ain't broke, don't fix it." This recommendation, then, is made in light of the current economic and political climate of the county and the state. Any major shifts or changes in conditions and persons may call for the question to be re-examined.
