- 1. Call meeting to order. Meeting called to order at 8am.
- 2. Declaration of Quorum. Declared.
- 3. Public comments. Bill Clendenning, mentioning the following items:
 - a. Sand shed build.
 - b. Would also like to know about the 71st street culvert that is underneath Kellner Road (goes from a farm through a creek to a drainage area that the town dug out) and then goes into Lake Wazeecha. This culvert has been causing a lot of flooding and he is unable to find any info on it.
 - c. They are looking at Washington St. to get a 90/10 grant. The County should be involved in the study of this since it affects County Trunk U. This is on next agenda.

4. Correspondence.

- a. F. Schubert asked if the committee reviewed the email he sent out regarding the advertising/commercial for logging and snowmobile trails. The committee members did not get a chance to review so F. Schubert will re-send it and discuss at next meeting.
- b. Chip sealing information (Hwy.) Tabled for April next meeting.
- c. Information only. Roland implemented the seasonal weight postings.
- d. C. Schooley; regarding Wellness employee discounts for camping/user fees for employees. Possible future agenda item regarding discounts to employees vs. general public.
- e. R. Hawk stated that the WCHA is accepting nominations for Vice-Chair. Nominations are due in April if anyone is interested.

5. CONSENT AGENDA

- a. Approve minutes from previous committee meetings.

- 6. Review items, if any, pulled from consent agenda. **Motion to approve by L. Pliml and second by M. Hokamp. Motion carried.**
- 7. ATV Update. R. Hawk met with Jeff Masephol regarding trails and routes. Sandra Green will be setting up and meeting with all clubs in Wood County in the very near future.
 - C. Schooley spoke about updates on the Dexter ATV sites. Conditions were conducive to trenching at this location recently so staff was able to install the 10 electrical peds and bury the wire. All 10 sites will now have electricity this upcoming camping season.

8. HIGHWAY

- a. CTH V Bridge Bids. Earth, Inc. is the low bidder.
- b. CTH N Bridges (2) Bids. Radtke Contractors is the low bidder. Both funded by the "CHIP" program. Both bids came in below the engineers estimates.

Motion by L. Pliml to approve bids a. and b. and second by D. Polach.

- c. Bituminous Materials Bids. Bids opened on March 10th. MEIGS was low bid for PG 58-28 at \$499.31 per ton and Flint Hills agreed to match that for 40% of the quantity for the year.
 - Motion by L. Pliml to accept low bids by MIGS and Flint Hills and second by B. Winch. Motion carried.
- d. Milling and Pulverizing Quotes. These are not official bids so no motions are needed.
- e. GSB 88 maintenance contracts. R. Hawk said they would like to do this in more urban areas where they have curb and gutter. Its' an asphalt rejuvenator, covered with a sand like material. He would like to bid two or three separate projects and be able to award each bidder with a separate project for comparison purposes. Motion to do a trial to use both contractors without the low bid exempting this project from the bid process to develop a comparison process for future. Motion by L. Pliml and second by A. Fischer. Motion carried.
- f. 50/50 Road Aid Program. This allows municipalities to designate \$4K a year for up to three years in a row. The county allocates a match, which results up to \$12K for a specific project. The match is budgeted in levy and goes into a fund used for a match on these 50/50 programs. R. Hawk is proposing removing the 3 year limit and allow them to do bigger projects vs. getting three years in and looking for something to spend their allocation on, proposing remove the cap on the number of years. Highway will still receive the benefits of doing the work for these municipalities. Allocate \$5k year instead of \$4k and remove the cap on the years. Motion by L. Pliml to adopt the proposal to increase the match from \$4000 / year to \$5000 / year, remove the cap on the number of years, and adopt the 50% match by L. Pliml and second by D. Polach. Motion carried.
- g. Flagging Certification Policy. State Highways over 35mp must have certified flaggers and use temporary rumble strips.
 - Motion to adopt the State Certified Flagger Policy for County Highways, to include certified flaggers and temporary rumble strips on county highways with posted speeds 35 mph or greater by D. Polach and second by M. Hokamp. Motion carried.
- h. Out-of-State Travel. Highway Commission, R. Hawk. **Motion for approval of Out-of-State travel by L. Pliml and second by D. Polach. Motion carried.**
- i. Summer Help and Engineering Intern pay rates. Summer help increase to \$14, with a CDL, \$16. LTE Truck Drivers are at \$18 (required CDL). This will not affect the Highway budget as wages are covered in projects. Engineering Tech Interns will start at \$16/hr. The HR Department recommended this. Motion by L. Pliml to approve increase in wages and second by M. Hokamp. Motion carried.
- j. Adler Road Trail Extension, Marshfield, Wisconsin. City is looking to apply for a grant to extend the trail. R. Hawk included a letter in the packet with details requesting support from the HIRC. **Motion to approve by L. Pliml and second by B. Winch. Motion carried.**
- k. Oversize/Overweight/Seasonal Truck Permit & Utility Permit. R. Hawk has completed research on neighboring counties. Its' designed for a 1-time use for some, but for milk, garbage and septic haulers, there is a permit designed specifically for them and is valid for their entire posted season. R. Hawk is requesting the cost of the OS/OW permit increase from \$25 to \$50 to be consistent with the other permits.

 Regarding utility permits, R. Hawk is looking to raise the fee as well. Currently, the fee is \$25 for the permit. Request is to increase the application fee to \$50. The boring fee would be \$100 and the open cut would be \$500. These fees are all in comparison to Marathon, Portage and Adams counties. Motion by L. Pliml to adopt the policy as outlined by the Highway Commissioner and to adopt the schedule modeled by Portage County for \$35 per additional 1000 feet, and second by D. Polach.

9. PARKS AND FORESTRY

- a. Parks Revenue Report. C. Schooley pointed out the increased revenues for the open shelter reservations. This increase is due to the two new shelters at White Beach that are now available for rentals starting May 30th. Along with these new facilities comes additional staffing needs for cleaning. Schooley provided an overview regarding employee needs for the future. He discussed shelter reservations and cleaning days that are scheduled throughout the year. It is becoming more and more difficult to have all shelter buildings cleaned by 8am with the number of staff we currently have. It is a staffing pressure point in the department right now. Some hours will be adjusted and we will do our best with what we currently have budgeted. Future staffing needs will be requested as we move into budget season, focusing on LTEs when possible to keep labor expenses low. Other areas of concern are office staff numbers. Specifically, the Office Supervisor/Snowmobile & ATV Coordinator position. With the addition of the ATV program taking off and additional office duties over the years, there may be a need for additional staff. Motion to approve the Parks Revenue report by L. Pliml and second by M. Hokamp. Motion carried.
- b. Forestry Revenue Report. F. Schubert stated February was a very good month. L. Pliml noted that he spoke with Dan from Verso Corporation and offered an unsolicited compliment that F. Schubert is doing an excellent job in his position. **Motion to approve the Forestry Revenue report by L. Pliml and second by B. Winch. Motion carried.**
- wood County Forest 15-Year Comprehensive Land Use Plan Draft Chapter 400. B.
 winch had questions regarding the Town Severance Payments and the Forestry Ordinance. F. Schubert and S. Green answered Mr. Winch's questions.
- d. Discuss concerns from Wood County townships. C. Schooley organized a meeting with Wood County staff and representatives from a few town boards. They began the discussion regarding addressing right-of-way and clean-up duties adjacent to town roads and county owned properties. How do we verify the clean up has been done? He will bring recommendations forward to the April meeting after all parties have a chance to review them.
- 10. The committee may go into closed session per Wis. Stat. s. 19.85(1) (g) to confer with counsel over litigation with Members Advantage Credit Union. (9:03 am).

Motion by L. Pliml and second by D. Polach. Roll call – all Yes. Motion carried.

Subject: Commissioner Report for April 9, 2020 HIRC meeting

Department Activities

Personnel

Two truck operator positions have been filled in March. Accounting technician has submitted her resignation, the position was posted and after interviews, the position was reposted. Accounting technician has offered to remain as a Casual Employee until position is filled. Mechanic positioned opened in March, received only a couple mechanic applications for position, will continue posting for another two weeks.

National Association of County Engineers (NACE) conference scheduled for April 19 – 23 has been canceled. TDA Fly-In to Washington DC for May 18-20 has been cancelled. Flights, hotels, and reservations have been canceled or received vouchers for future travel. Non-refunded expenses will be refunded by WCHA.

Due to Covid-19 virus, personnel are practicing social distancing. Any employee who exhibits illness/sickness are sent home to self-quarantine and/or obtain a doctor's clearance to return to work. Public notices have been shared on social media, website, and posted on doors stating Highway facilities are closed to non-essential business. Customers are encouraged to call or email their concerns for available staff to follow up.

All non-essential meetings and gatherings of 10 people or more have been canceled or postponed.

Highway Projects

Notice of award has gone out to successful bridge contractors who were low bid on CTH V and two (2) CTH N bridges. Work is expected to stay on schedule beginning after June 15.

CTH U (STH 54 – South Biron Drive) STP Urban project is scheduled for construction in 2020. WisDOT is seeking assistance from Wood County with notifying residents of upcoming construction project. Process is working and should keep project on schedule.

Highway Department has completed purchase of aggregates, secured AC for asphalts, and obtained culverts for 2020 construction projects. New construction work expected to begin late May or early June.

Highway Commissioner has negotiated with WisDOT to provide funding to replace deficient state salt shed at the Marshfield facility in 2020-2021 FY. WisDOT has provided an offer to use unused RMA funds from 2019-2020 contracts for Wood County forces to replace aged/undersized state salt shed. This

work would be done in conjunction with Wood County replacing aged/deficient/under-sized County salt shed in 2021. Commissioner is seeking approval to use bonded 2021Capital Improvement Funds funds in the amount of \$350,000 to construct a County 2500 Ton Salt Shed at the Marshfield facility. HIRC approved constructing a county shed in 2019 but the funding source was not defined. With the State MLS grant and potential Ho-Chunk BIA Roads division grant for CTH X the Highway Department would limit the total Bonded Capital Improvement funds for 2021 to \$2,000,000 for highway improvement funds.

Highway Maintenance

Patrol Superintendents have been occupied with preparing 2020 construction projects. Crews are grading ditches, cutting trees & brush from the right-of-way, performing bridge repairs, and replacing culverts where possible.

Crews are patching holes, filling cracks, and placing mastic on spots where pavements have been damaged over the winter.

Highway Department has a maintenance plan in addition to the capital improvement plan, a major maintenance practice is chip sealing. This practice has normally been used on pavements between the ages of 7 and 15 years. However, since asphalt cements (AC) are so refined that these binders are left with very poor qualities, asphalt pavements exhibit premature aging as early as 1-3 years. This is why WCH has adopted the chip seal or seal coat practice as soon as 3 year new. Recent communication from concerned Clark County resident providing inaccurate information is call for update on Chip Seal management plan. *Agenda Item*.

ATV Plan

Commissioner has received a request to evaluate CTH AA from CTH G to Lynn Hill Road and CTH X from STH 80 to STH 54 for ATV access. Commissioner met with representative from local ATV club to discuss future plans and options for ATV access. Club member offered to assist with trail and sign maintenance. Commissioner was to evaluate these segments of roadway and provide recommendation at April HIRC, however, due to recent Covid-19 work place changes, commissioner has delayed this review until the May HIRC.

On Line Permitting

Department is working with RTVision to implement on-line permitting. Anticipate segments go live in 2020, with recent work place restrictions due to Covid-19, this will be delayed until later in 2020.

Seasonal weight restriction application and permits were to be ready for on-line submittal March 1, 2020. Vender was not able to complete the set up and Department staff developed paper copies that have been affective. Will continue to develop on-line applications.

Department staff are working on Oversized / Overweight / Over Length/ Over Height, Utility permits, Access Permits, and Special Events as approved by HIRC. Fee adjustments will be incorporated as approved by HIRC.

Misc.

Windshed presentation has been delayed due to Covid-19 restrictions.

Accounting Supervisor Report







A chip seal is a frequently used PM treatment on flexible pavements. It must be recognized that successful chip seals are a function of their application on underlying pavements that have not suffered structural failure. To achieve the pavement preservation benefits of a chip seal, an agency must apply it on roadway surfaces when the level of pavement distress is low. Thus, pavement selection becomes the first and perhaps the most critical factor in an agency's chip seal program.

TOWNSHIP - COUNTY R.O.W. DEBRIS CLEANUP AGREEMENT

In an effort to improve communication and improve Right of Way (ROW) cleanup of woody debris, within town road ROW's that adjoin County owned property, both parties agree to the following:

Township shall:

- 1) During spring road inspections, and throughout the year, document locations of woody debris that has entered the ROW, and that originated from County owned property.
- 2) Report to appropriate Wood County Department (Phone, email, US mail, or hand delivery). (Example of report form attached).

Only property adjoining Town Road is rock quarry in town of Cary, south of Cary-Rock Road.

Wood County Parks and Forestry Department 111 W. Jackson Street Wisconsin Rapids, WI 54495 715-421-8422

There are also several thousand acres that are owned and/or managed by the WI DNR. Townships would have to contact WI DNR to arrange cleanup of these ROW's. If you have questions about ownership, contact Wood County Parks and Forestry Department.

Wood County shall:

- 1) Remove woody debris located in town road ROW that originated in adjacent Wood County owned property. Removal shall be done in a timely manner, preferably within 30 days of discovery by County staff or notification from Townships.
- 2) Follow up with Town Chairperson, or their assigned representative, when debris removal is completed. This agreed upon communication may be via phone, text, email, or US mail.

In the case of a large storm event, it is advised that both parties communicate frequently and, if possible, in person to assess the ROW issues. An agreed upon cleanup plan shall be arranged between both parties at that time.

500 LAND USE

500.1 OBJECTIVES

- To identify policies and procedures employed to effectively manage, utilize and sustain the resources of the County Forest.
- 2. To identify regulated management activities, land uses and special resource areas.
- 3. To layout proper permits needed for certain activities on the County Forest

505 TIMBER SALES

Regulated cutting of timber is essential to the goals and objectives of this plan. Timber harvesting will be conducted to achieve a sustainable harvest level. Harvest areas will be distributed in the forest to accommodate such needs as biodiversity, wildlife, aesthetics, watershed protection and other biological needs. WisFIRS will be used for planning all timber harvest activities on the County Forest. All sales will be established, administered and reported in accordance with the DNR Timber Sale Handbook (2461). All sales on the forest are to be advertised for public bidding, with the exception of small sales with an estimated value of \$3000 or less or sales that would qualify under a salvage provision (s. 28.11(6)(c), Wis. Stats.). These sales may be sold direct without advertising.

505.1 FIELD PREPARATION OF TIMBER SALES

The County and the DNR will cooperate to locate, designate and prepare harvest areas for sale. The Forest administrator and DNR liaison forester shall jointly be responsible to see that the field work on sales is accomplished. Administrator and Liaison will also jointly be responsible for ensuring that all proper documentation for each timber sale is properly filled out and routed for signatures.

505.2 ADVERTISING FOR BIDS

After field work is completed and necessary reports receive DNR approval, the administrator shall prepare a sale prospectus and make it available to interested loggers. Under s.28.11(6)(b) Wis. Stats, timber sale advertisements, at a minimum, will be by classified ad in a newspaper having general circulation in the county (e.g. Wisconsin

Rapids Daily Tribune, Marshfield News Herald). Ads shall be run once each week for two consecutive weeks, the last being at least one week prior to the bid opening. A longer advance time will be given when feasible. Sealed bid sales will generally be offered in the spring and fall, or as needed.

505.3 PROSPECTUS

The following minimum information will be made available to prospective bidders:

- 1. Species to be harvested and estimated volume
- 2. Maps of sale areas
- 3. Special contract provisions
- 4. Procedures for bidding
- 5. Bid forms
- 6. Timber sales bond and advance stumpage schedule

505.4 METHOD OF BIDDING

Bids will be reviewed at a meeting of the committee. A sealed envelope showing tract number and marked "sealed bid" shall be submitted on County Forest bid forms by the bidder for each tract bid on, and shall contain:

- (1) The bid price per unit of species product. The total value of the timber sale bid shall be indicated on both scaled and lump sum bids. The total bid value must meet or exceed the advertised sale minimum acceptable bid value, as documented in form 2460.
- (2) A minimum of 20% of the bid value of each tract must accompany the bid as a bid bond, payable to Wood County.

505.5 AWARDING SALES

- 1. The high bidder is normally awarded the sale contract; however, the committee reserves the right to reject any or all bids and accept the bid offer most advantageous to the county. Grounds for rejecting bids may include without limit:
 - A. Non-compliance with County Forest contract requirements.

- B. Delinquent financial obligations.
- C. Unsatisfactory past performances.
- D. Inability to demonstrate financial or professional capability. Evaluation criteria on timber sales will be price and documented ability to satisfactorily complete the contract. Factors to be assessed may include proposed equipment and operation, references, proof of financial stability, past performance and documented training completed. The award of contract to the successful bidder shall be based upon the bid determined most advantageous to the County.
- 2. Tie bids may be settled by toss of a coin if both parties are agreeable; otherwise the bids on that tract will be rejected and the sale re-advertised.
- 3. Sales remaining unsold after being advertised for two bid openings may be sold direct at not less than the appraised value even though their estimated value exceeds \$3,000. (See DNR Timber Sale Handbook).

505.6 SALE CONTRACTS

- 1. Contracts will be prepared with copies provided to the logger with the original filed in the administrator's office.
- 2. Contracts are to be signed by the successful bidder within 30 days following Committee approval of the sale with payment being made according to the county timber sale bond and/or advance stumpage payment schedule. Failure to sign the contract within 30 days may result in forfeiture of bid bond.

505.7 TIMBER SALE PERFORMANCE BOND

1. Surety bonds or an irrevocable letter of credit issued by a bank which is a member of the Federal Reserve System or insured by the Federal Deposit Insurance Corporation may be used in lieu of cash as a performance bond on sales. The letter of credit or surety bond must be in effect for 6 months beyond the contract length or until released by the County Forest Administrator. If the contract is extended beyond this time, the contractor must provide an extension to the letter of credit or surety bond for a period of time equal to the term of the contract extension, plus 6

months.

2. The bid bond may be transferred to the performance bond.

505.8 CONTRACT PROVISIONS

All timber sale contracts will be on the form approved by the committee and all provisions therein shall apply. A copy of the timber sale map will be attached and become a part of the contract. A copy of the timber sale contract can be found in the appendix. The following items are essential contract provisions that should be covered in each contract.

505.8.1 Contract Number and Contract Name

Every contract shall have a unique numerical number and depending on county policies/procedures shall have a unique name.

505.8.2 Contract Parties

Contracts must have Name, Address, and other contact information of the Purchaser.

505.8.3 Duration and Extension of Contracts

- (a) All contracts will be issued for not less than six months nor more than 3 years, unless otherwise stated on advertisement and/or contracts.Contracts will be dated to expire on the anniversary of the sale.Exceptions may be made in cases of extenuating circumstances.
- (b) Contract extensions may be granted by the Committee. See the contract extension policy that is found at the end of the timber sale contract which is located in the appendix.
- (c) Special stumpage rate adjustments may be made according to the previously mentioned contract extension policy.
- (b) If purchasers do not wish to have contracts renewed or extended the

- county may charge double stumpage for any timber left, cut or uncut, within the sale area.
- (e) The contractor may request a contract release due to severe physical or financial disability. The committee shall determine whether or not a release shall be granted and may withhold all or a portion of the bond deposit for damages.

505.8.4 Termination of Contract by Seller:

See Timber Sale Contract in the Appendix.

505.8.5 Performance Bond, Damages, Future Contracts:

See the Timber Sale Contract in the Appendix.

505.8.6 Title to Timber:

See the Timber Sale Contract in the Appendix.

505.8.7 Payment Schedule:

See the Timber Sale Contract in the Appendix.

505.8.8 Utilization Specifications:

See the Timber Sale Contract in the Appendix. Certain contracts may have additional special products and specifications on a case by case basis, and will be listed in those particular contracts.

505.8.9 Training Requirement

Logging contractor and sale operators are to be compliant with the Wisconsin SFI Training Standard as adopted by the Wisconsin SFI Implementation Committee. Valid documentation of compliance with the Forest Industry Safety and Training Alliance training standards must be on file with the County before cutting operations begin and during all operations. See Timber Sale Contract in the Appendix.

505.8.10 BMPs, Roads, Landings:

See the Timber Sale Contract in the Appendix.

505.8.11 Soil Disturbance and Rutting:

As a requirement of certification all contracts must have a rutting policy in the contract. See the Timber Sale Contract in the Appendix.

505.8.12 Liability and Workers Compensation Insurance:

See the Timber Sale Contract in the Appendix.

505.8.13 Scaling and Conversion Factors:

See the Timber Sale Contract in the Appendix.

505.8.14 Forest Certification:

Wood County will comply with all current forest certification requirements as related to timber sale contract and other sale documentation. See Chapter 100 and Timber Sale Contract in the Appendix.

505.8.15 Other Contract Conditions:

See Timber Sale Contract in the Appendix for the following:

- A. Waste
- B. Stump heights
- C. Zone/Unit completion
- D. Slash requirements
- E. Cleanup of sale area
- F. Forest fire prevention
- G. Survey monument restriction
- H. Indemnification
- I. Independent contractor
- *J.* Assignment (sub-contracting)

- K. Right of inspection by seller
- L. Applicable law
- M. Other conditions

505.8.16 Attachments to Contract:

A Timber Sale Map and associated cutting specifications will be attached and made part of each Timber Sale Contract.

505.9 TIMBER SALE RESTRICTIONS

- 1. To minimize resource damage, the types of logging equipment, methods, and times of operation used on sale areas may be restricted by the county.
- Special restrictions may be required in accordance with county aesthetic policy, if applicable.
- 3. Seasonal restrictions may be applied to protect roads, minimize recreation use conflicts, benefit wildlife management, avoid endangered resources concerns, minimize insect and disease problems, or to assist in fire protection.

505.10 TIMBER SALE ROADS

- 1. The contractor will be responsible for securing legal access to sale areas across private or other non-county ownership.
- 2. The contractor will be responsible for securing permission to conduct logging activities within town, county or state road rights-of-way (e.g. decking, skidding)
- 3. Forestry personnel will approve the lay-out of all roads and make other necessary special provisions within the sale contract.
- 4. Skidding, decking, or other logging activity is not allowed on County Forest roads or ditches unless approved by the County Forest Administrator. These areas will be kept free from logging debris. County Forest access roads will be maintained by the logger and be left in good as original condition at the close of the sale. Roads will be inspected by county personnel to insure minimal resource damage.
- 5. A timber sale purchaser may request permission to gate a timber sale access road.

The administrator may grant a gate permit to prohibit only motorized traffic.

505.11 SUPERVISING SALES

Sale inspections will be performed periodically by county and / or DNR Forestry personnel, as requested, with corresponding notations in the sales record.

505.3.8(c) Contract Violations

Field enforcement of timber sale contracts will be the responsibility of the administrator employing the following procedure:

- (a) The administrator, or designee, will attempt to resolve inadvertent or minor violations by verbal contact with the contractor.
- (b) The administrator, or designee, may immediately suspend logging operations when a serious or emergency situation arises.
- (c) The suspension will be followed by written notice to the contractor, stating the nature of the violation and informing them of committee action taken or pending.
- (d) The Committee, in consultation with legal counsel, may consider, but is not limited to the following remedies:
 - (1) Charge double stumpage
 - (2) Charge for actual damages
 - (3) Suspend contract
 - (4) Retain all deposits
 - (5) Foreclose on cut forest products on sale
 - (6) Refer to District Attorney for prosecution
 - (7) Seek civil damages in addition to the performance bond.
- (e) Suspension of operation will remain in effect until receipt of written notice from the county.
- (f) Failure of the contractor to comply with the committee decision may result in the contractor becoming a non-qualifying and ineligible bidder in the future. At the committee's discretion, the contractor may be banned from future purchase of county timber sales for a period of time to be determined by the Committee on a case by case basis. All deposits may be retained and forest products on

sale areas may be seized and sold by the county.

505.12 FOREST PRODUCTS ACCOUNTABILITY

505.12.1 Scaling Merchantability

- (1) Sawlogs will be scaled by the Scribner Decimal C. log rule. A log is defined as:
 - 9" diameter or larger inside bark (d.i.b.) at 8' in length (plus trim) for softwood.
 - 11" diameter or larger inside bark (d.i.b.) small end at 8' in length for hardwood.
 - Minimum net scale of 50% of the gross scale of the log.
- (2) The standard unit of measure for cordwood is measuring 4' x 4' x 8' of unpeeled wood. Peeled wood will be converted to the standard cord by adding 12.5% for sap-peeled and adding 25% for machine-peeled wood to the gross volume measured. A pulpwood tree contains at least one (1) 8' stick, to a minimum top diameter as defined in the contract.
- 3. The DNR <u>Timber Sale Handbook</u> will be used as a guide in determining the conversion rates for posts, poles, bolts, chips, weight- scaled wood or other types of forest products.

505.12.2 Utilization Standards

Utilization standards will be specified on individual contracts to provide maximum utilization of all merchantable timber and will be based on the scaling standards noted above.

505.12.3 Methods of Accountability

Wood harvested from the sale area must be accounted for and payment made in accordance with existing policy and procedure. One or more of the following may be used on an individual sale:

- (1) The ticket system utilizes serialized three-part tickets. Advance payment for tickets is generally not required. See contract (in appendix) for exceptions under "Mill Scale Ticket System". One ticket must accompany each load of wood to the mill. Mill scale will be accepted for volume determination.
- (2) Wood may also be scaled on the landing. This method is generally used for sawlogs and may be used for pulpwood. Payment for wood products scaled is normally due within 14 days of billing.
- (3) Lump sum sales may be utilized and divided into cutting units when practical. Payment for a cutting unit must be received in full before any cutting begins in that unit.

505.13 SPECIAL FOREST PRODUCT PERMITS

- (4) A written permit for making fuelwood for personal use must be purchased for areas designated under the permit. Designated firewood cutting areas are periodically developed and/or closed. Current maps and cutting directions are available in the Park and Forestry Department. See Appendix for Sample Firewood Cutting Permit.
- (2) Written permits may be issued for other special forest products for community or personal use, on a case by case basis, with fees established by the committee or the Forest Administrator.
- (3) An annual summary report of cut products sold by permit will be filed with the DNR using Timber Sale Notice and Cutting Report (Form 2460).

510 TIMBER THEFT

All cases of alleged timber theft on the county forest shall be investigated and resolved promptly. An allegation of theft by cutting and /or removing timber from the county forest does not alleviate the county from payment under s. 28.11 (9) Wis. Stats. The county will collect damages pursuant to s. 26.05 Wis. Stats. and may also pursue criminal charges under s. 943.20 Wis. Stats. and /or seek civil damages.

510.1 TIMBER THEFT INVESTIGATION

The following procedure should be used in all cases of alleged timber theft:

1. Determination of Theft

- A. Gathering facts The county, through its sheriff's department and along with assistance of the DNR liaison, rangers and wardens, will ascertain the facts pertinent to the alleged theft, including determination of the damages to the county. Legal counsel representing the county should be involved in all aspects of investigation. Property involved in the alleged theft may be seized pursuant to s. 26.064 Wis. Stats. for use as evidence.
- B. Boundary determination If property boundaries are involved, the county shall conduct a legal survey of the boundary in question.

515 ENCROACHMENTS

The county will actively investigate all suspected cases of encroachments on the County Forest. To insure the integrity and continuity of the County Forest land, all cases will be dealt with promptly and in a consistent manner. The following procedures will be used in all cases of suspected encroachments:

- (1) The county will establish property boundaries; if necessary, a legal survey will be conducted.
- (2) The county will gather all facts.
- (3) The Committee, in consultation with the forest administrator, county legal counsel, and the DNR, will make a decision as to the disposition of the case.
 - (a) All above ground encroachments that are movable will be removed from county property.
 - (b) Permanent type facilities, such as homes, garages, and septic systems

- shall be addressed individually and may be removed or handled by a land use agreement. Sale or transfer of the encroachment should remain an option depending on the circumstances involved and the viability of an adverse possession claim (s. 893.29 Wis. Stats.).
- (c) Provisions in the land use agreement, if that option is pursued, may include granting the encroacher permission to encroach on the County Forest lands with the following stipulations: no other encroachments will be allowed; the permit is non-transferable; the county must be notified once encroachment is terminated; county continues full ownership and control of property; permittee agrees to waive any rights to any future declaration of ownership or interest in the encroached county property; county reserves the right to cancel the permit and the permit is to be filed in the office of the Wood County Park and Forestry Department and all fees related to the land use permit shall be paid by the permittee.
- (d) In instances involving encroachments that are the result of updated surveys, relocation of survey markers, property line changes as a result of previously mentioned survey activity; and the net impact to the County Forest is three acres or less; Wood County may choose to sell the property if this action is deemed to be in the best interest of the citizens of county. See the Wood County Park & Forest Land Transaction Policy and Procedures located in the Appendix for more information.
- (e) A sample copy of the Land Use Agreement can be found in the Appendix.

520 SPECIAL USES

1. Recognizing the vast potential for a variety of special uses of the County Forest by governmental units, businesses, organizations or individuals, the committee may

designate specified areas for special uses. Specific management methods are to be considered on these areas. Uses must be consistent with the intent and purposes of the County Forest Law.

- 2. All requests for specialized uses of any County Forest lands will require a permit authorized by the Committee.
- 3. A list of existing special use areas can be found the Appendix.

520.1 SAND AND GRAVEL

Sand and gravel pits located on the County Forest may be used only by units of government or contractors performing public works. Use of existing pits and the opening of new pits by other than the County Park and Forestry Department will require Committee approval and be authorized by permit only. The condition of such permits may include, but are not be limited to:

- 1. Requiring the pit and its access road to be screened from view from any public highway
- 2. Severing trees from the stump
- 3. Disposition of brush and dirt spoil by leveling or hauling away
- 4. Sloping to prevent steep banks
- 5. Filing with the forestry office an annual written report of gravel and sand removed.

Other conditions may be set at the discretion of the Committee or County Forest Administrator. The Committee may set fees for materials removed. Other non-metalliferous materials will be dealt with on an individual basis.

All active, nonmetallic sites greater than one acre in size, including those on the County Forest, are also subject to the provisions of the Nonmetallic Mining Reclamation Program, Chapter NR 135, Wis. Adm. Code. The County Park and Forestry Department shall work with the local permit coordinator (often county or local zoning office) in obtaining the necessary permits for nonmetallic mining operations.

Sand and gravel may, under some circumstances, be leased to private contractors for

private use. In these situations, the land must be withdrawn from the County Forest Law until sand/gravel removal and reclamation of the site is completed. Upon completion of reclamation to the satisfaction of the county and the state, the lands shall be reapplied for entry under the County Forest Law.

520.2 EXPLORATION, PROSPECTING, AND MINING

- 1. The Committee may investigate all mineral exploration, prospecting and mining requests as they are received.
- 2. The DNR shall be notified of all requests as they become known in accordance with s. 28.11(3)(i) and (j) and with DNR Manual Code 2712.1 or other codes which may be subsequently adopted.

The <u>Public Lands Handbook</u> should be referenced for more detailed procedure.

520.3 SANITARY LANDFILLS

The use of County Forest lands for sanitary landfills will not be allowed unless the lands involved are withdrawn from the County Forest Law.

520.4 MILITARY MANEUVERS

Military maneuvers on County Forest lands will be considered under a lease or written land use agreement. Upon receipt of a written request from the military the Committee, other necessary County staff, Military, and DNR representatives will discuss the issue at a public Committee meeting. After the needs have been outlined, the site shall be field checked, DNR input and consistency with the County Forest Law sought, and town officials advised. Depending on the scope of the project, a public hearing may be appropriate. If all aspects and concerns are addressed and agreed to, a legal instrument will be drafted. The matter will then be brought back to a Committee meeting for final input and approval. The Public Forest Lands Handbook will be used for further direction in this matter.

520.5 PUBLIC UTILITIES.

Easements for public utilities may be considered by the Committee. Underground installations will be encouraged. The following main provisions shall be included in any County Board resolution granting permission for construction of any utility transmission line:

- 1. Utility may be billed for merchantable forest products and existing timber reproduction.
- 2. Utility may be billed for land removed from production due to right-of-way clearing for losses of future income and multiple use benefits.
- 3. Land removed for utility operations that is no longer suited "primarily for timber production or, that is no longer suitable for scenic, outdoor recreation, public hunting & fishing, water conservation or multiple use purposes" (s. 28.11(4)(c) Wis. Stats) may need to be withdrawn from county forest law designation. The utility shall replace any lands requiring withdrawal from county forest with other lands suitable for county forest entry that are in the forest blocking of the County Forest.
- 4. Utility companies will be encouraged to use existing corridors and underground lines to minimize disturbance to the county forest and native plants and animals.
- 5. Merchantable timber will be removed in a manner approved by the Committee. Timber cut must be reported to the DNR on form 2460-1.
- 6. Utility must provide notice of proposed route, including a map of not less than l inch/mile scale, 90 days in advance of proposed construction.
- 7. Special maintenance, controlled access and signage concerns shall be addressed in any proposal.
- 8. An appropriate fee shall be charged for easements.

520.6 ACCESS TO PRIVATE LAND

The Department has determined that granting a private easement across county forest lands is not consistent with the County Forest Law program. This determination is based on an Attorney General opinion (*OAG-08-10*). Easement grants to individuals are generally determined to be an exclusive right on a publicly owned asset. Counties are

generally restricted from granting easements unless the overall management of the forest could be improved by granting the easement or if the easement grant will serve a greater public good.

Applications by private parties to build or improve access roads through County Forest land will be handled according to the Land Transaction Policy (See Appendix) and be considered by the Committee on a case-by-case basis. The following stipulations will generally be adhered to as they apply to each situation before an "Access Permit" is granted. Additional stipulations may also be included depending on each specific situation.

- Access across County Forest lands must be demonstrated by the applicant as the route of last resort. Proposed uses must be documented by the applicant.
- 2. No legal easement will be granted, just permission to cross county lands.
- 3. The permit is non-transferable. New landowners must apply to continue the land use agreement.
- 4. Road improvements and upgrading must be approved and will be supervised by the Park and Forestry Department staff. Prior notification of three (3) days is required before work starts.
- 5. All wood cut is the property of Wood County.
- 6. Roadway must be opened to the public through county land. No gate may be erected on county land unless authorized by the Forest Administrator.
- 7. The County continues full ownership of the improved roadway; however, it shall not be liable for maintenance or upkeep of the road.
- 8. Permittee waives any rights to any declaration of ownership or interest in the road on county land for administrative costs as a result of this "Access Permit". The access permit is granted upon the signature and any fees being received by the Wood County Park and Forestry Department.

Requests for temporary access across County Forest Lands will be reviewed for any potential conflicts with management activities or public access. If impacts are minimal, access for short term needs will be permitted through the use of access agreements or permits, and will be handled according to the Land Transaction Policy (see Appendix) Temporary access is generally for activities such as access to maintain utilities (rail, powerline, etc.) or for logging access on private lands. The recipient of temporary access is required to restore the roadway to at least its prior condition and to expand coverage of any performance deposits or liability insurance to cover the use of the County road.

520.6.2 Access Agreements

Requests for access to private lands may be made by private parties to build or improve access roads through the County Forest. Access agreements will be considered on a case-by-case basis and with the understanding that the County is not legally obligated to provide access to private lands.

A fee of \$25.00 minimum will be assessed by the Committee for access permits. Fees may be greater depending on length of access, timber impacted, etc. The Committee may elect to waive these fees in cases of agreement renewals or in cases of existing roads or driveways.

Access across County Forest lands must be demonstrated by the applicant as the route of last resort, including evidence of an offer of fair compensation for access across other private lands. The following stipulations will be included in access agreements:

- Permits are made by and between the County and the property owner. The
 permits are not transferrable and subsequent property owners must secure their
 own agreement.
- 2. Permits are not to exceed 10 years. (Insert specific language, but not to exceed 15 years)
- 3. Gates, signs, or other articles of the permittee are not permitted on County lands

4. Other county specific stipulations

Requests for access to private lands may be made by private parties to build or improve access roads through the County Forest. Applications will be handled according to the Land Transaction Policy (See Appendix) and be considered by the Committee on a case-by-case basis. The following stipulations will generally be adhered to as they apply to each situation before an "Access Permit" is granted. Additional stipulations may also be included depending on each specific situation.

- 1. Access across County Forest lands must be demonstrated by the applicant as the route of last resort. Proposed uses must be documented by the applicant.
- 2. No legal easement will be granted, just permission to cross county lands.
- 3. The permit is non-transferable. New landowners must apply to continue the land use agreement.
- 4. Road improvements and upgrading must be approved and will be supervised by the Forestry Department staff. Prior notification of three (3) days is required before work starts.
- 5. All wood cut is the property of Wood County.
- 6. Roadway must be opened to the public through county land. No gate may be erected on county land unless authorized by the Forest Administrator.
- 7. The County continues full ownership of the improved roadway; however it shall not be liable for maintenance or upkeep of the road.
- 8. Permittee waives any rights to any declaration of ownership or interest in the road on county land for administrative costs as a result of this "Access Permit". The access permit is granted upon the signature and any fees being received by the Wood County Park and Forestry Department.

520.6.3 Prescriptive Easements

Historical access points and driveways may meet the requirements of prescriptive use. A prescriptive use easement does not generally trigger a need to withdraw lands from the County Forest program unless the public is excluded from motorized travel on the subject

road. Any potential claims of prescriptive easement across County Forest lands must be reviewed by legal counsel in order to determine legal validity and possible legal defense or standing.

520.6.4 Other Types of Access

Complex issues of private access needs may arise in the future. Any proposals to grant an easement across County Forest must help achieve the purposes of the County Forest Law and meet a standard of better and higher public use. Easements to private parties will require withdrawal from County Forest Law and are to be discussed with the Department prior to initiating any proposals.

520.7 PRIVATE UTILITY SERVICE LINES

If a landowner cannot gain utility access across other lands, the committee may consider a land use agreement/permit for access across County Forest. Requests will be handled according to the Land Transaction Policy and is considered on a case by case basis. These agreements/permits should consider the inclusions mentioned below:

- 1. The permit is non-transferrable
- 2. The County retains full ownership of the utility corridor, however it shall not be liable for maintenance, upkeep, or other damages associated with the utility service.
- 3. The permittee waives any rights to any declaration of ownership or interest in the utility corridor on County land for administrative costs as a result of this Land Use Agreement Utility permit. This agreement is granted upon the signature and any fees being received by Wood County.
- 4. The fee for such a land use agreement shall be negotiable.

520.8 COMMUNICATION TOWERS

The siting of communication towers on the Wood County Forest will be considered by the Committee on a limited basis. Requests will be considered on a case by case basis subject to the following conditions:

- 1. It must be demonstrated that the site is the most practical location for such a tower.
- 2. Land selected for such a tower is no longer suitable for continued entry in the County Forest program. According to section 28.11(4), Wis. Stats, any accompanying lands needed for tower support wires that inhibit the practice of forestry and are no longer suitable for scenic, outdoor recreation, public hunting & fishing, water conservation or multiple use purposes may also need to be withdrawn from County Forest Law. Withdrawal is subject to approval by both County Board and DNR. The communication company shall replace any lands requiring withdrawal from county forest with other lands suitable for county forest entry that are within the blocking boundaries.
- 3. A request to withdraw lands from County Forest Law by a private communication company shall follow withdrawal protocol.
- 4. Any agreement should also consider the inclusions listed under 520.5 (Items 1-8).

520.9 OTHER

The committee may consider other types of special uses of the county forest. These may include, but are not limited to: research, independent study and scientific areas. Regulations governing these uses will be developed on an individual basis.

- d. Purchaser agrees to make stumpage payment at the rate indicated in Clause 7B, for timber marked or designated on premises which is destroyed or reduced in value as a result of the Purchaser's operation or negligence.
- e. The Seller may charge, and the Purchaser agrees to pay, double stumpage for any timber left, cut or uncut, on the sale area if purchaser does not wish to have the contract renewed or extended.
- 8. Payment instructions: (All stumpage payments will be cash, certified check or bank money order unless other arrangements are made with Seller).

- 9. All wood will be piled conveniently for scaling, but not on town road right-of-way and not removed until scaled by authorized representative of the seller.
- 10. Mill scale ticket system may, upon approval of the Seller, be accepted provided arrangements are made with the Forest Administrator and scale slips are mailed or delivered to the Forestry Office as wood is hauled; destination of wood to be indicated in advance. The County will bill by invoice all scale slips, and payment will be required within 14 days of billing.

MILL SCALE TICKET SYSTEM

- 11. Tickets may only be issued when the Contract is signed and periodically thereafter as needed. Advance Payment for tickets is not required unless:
 - 1) Purchaser fails to make timely payments to the Wood County Park and Forestry Department as specified on regular billing notices (payment due Within 14 days of statement date).
 - 2) Purchaser conducts harvest operations poorly and in a manner that does not comply with contract specifications (e.g. severe rutting, severe damage to residual trees, poor utilization, etc.) and receives written notice of such noncompliance.

Two such payment breaches and/or written notices of poor job performance on one or more timber sale contracts, will result in the purchaser being required to prepay on all Wood County timber sales for a two year duration.

The Purchaser shall account for all tickets. Unused tickets shall be returned to the Seller immediately upon completion or termination of the Contract.

- 12. Lock boxes shall be placed on the premises by the Seller.
- 13. The Purchaser shall provide the Seller with a list of all destinations of timber to be removed from the premises. Changes in timber destination shall be reported before hauling to the new destination.
- 14. Prior to hauling any timber, the Purchaser agrees to provide, on forms supplied by the Seller, intent of all buyers of cut timber from the premises to return copies of scale slips attached to corresponding tickets. Purchaser agrees to sell no cut timber to any buyer who has not provided written verification of his/her intent to return scale slips and tickets.
- 15. Each time a load of cut timber leaves the sale area, the appropriate portion of the ticket shall be clearly and completely filled out and deposited in the lock box.
- 16. Failure to deposit tickets in the lock box each time a load of cut timber leaves the sale area shall be considered a breach of contract. Purchaser agrees to pay double the stumpage rate as indicated in Clause 2 as liquidated damages for such removed timber.
- 17. Tickets are issued for the contract specified on each individual ticket and shall not be used for any other contract.

- 18. When transporting timber from the sale area, the truck driver shall have in his/her possession the appropriate portion of the ticket applicable to the load.
- 19. A list of all truckers that will be hauling timber from the premises shall be provided to the Seller by the Purchaser. It shall be the responsibility of the Purchaser to provide such truckers with appropriate tickets.
- 20. The Seller may check scale and scale tickets at any time.
- 21. Truck Delivery: The appropriate portion of the ticket shall be detached at the point where the timber is scaled and attached to a duplicate copy of the scale slip and then immediately returned to the Seller.
- 22. Rail Car Shipment to a Mill: The appropriate portion of the ticket shall be attached to the bill of lading for the car. At the mill, the ticket shall be attached to a copy of the scale slip, then immediately returned to the Seller.
- 23. Other conditions: (If none, write NONE):

SCALING AND CONVERSION FACTORS

- 24. The Seller may inspect trucks hauling forest products from the premises and check scale at any time.
- 25. When peeled cord wood is measured, it is agreed that 12.5% will be added to hand peeled or ring debarked volume, and 25% will be added to other machine peeled volume to compute equivalent non-peeled volume.
- 26. The Scribner Decimal C Log Rule shall be used for scaling logs.
- 27. Conversion of MBF (thousand board feet) to cords or cords to MBF will be 2.44 cords per MBF for softwoods and 2.20 cords per MBF for hardwoods.
- 28. Other conversion factors are as follows:

Weight conversion factors are those as according to Wisconsin DNR Timber Sale Handbook (current year or most recent revision).

UTILIZATION

- 29. Cutting requirements: (DBH represents the diameter at 4.5 feet above ground). See the timber sale prospectus and the attached map.
- 30. Utilization specifications: Merchantable trees are those that have one or more 100 inch sticks with the following top diameter:
 - <u>Standard utilization</u> Aspen pulp 5" top Diameter, Hardwood pulp 5" top, Pine pulp 4" top, Hardwood Sawlogs 10" top diameter, Pine Sawlogs 9" top.

<u>Increased utilization</u> - Trees that meet the standard utilization requirements for merchantability (as listed above) but must be utilized to a two-inch top diameter.

Whole tree utilization - Trees with a DBH of three inches or greater must be entirely utilized.

- 31. Maximum stump height shall not exceed stump diameter, and for stumps of diameter less than 10 inches, it shall not exceed 10 inches.
- 32. All and only the timber marked or designated for cutting on the premises shall be cut whether it be more or less than the volume listed herein. Unmarked or non-designated trees cut or damaged through carelessness, negligence or intention shall be paid for at double the stumpage rate specified or at a rate to be determined by the Seller, if not specified.
- 33. Any timber wasted in tops and stumps, broken in careless felling or not removed on termination of this contract shall be paid for at the specified rate.
- 34. The Purchaser shall be particularly careful not to damage the residual timber stands. Young growth bent or held down by felled trees shall be promptly released. Trees damaged through normal cutting operations may be designated for cutting by the Seller and harvested if merchantable.

TRAINING REQUIREMENT

35. The Purchaser is responsible for ensuring that the actual logging contractor engaged in performance of this contract complies with the Wisconsin SFI (Sustainable Forestry Initiative) Training Standard as adopted by the Wisconsin SFI Implementation Committee (SIC). Criteria for the standard can be found at the website www.fistausa.org/sfi standards or by contacting the Forest Industry Safety & Training Alliance (FISTA). Purchaser agrees to provide documentation to Seller that training has been attained prior to initiating sale.

SLASH AND DEBRIS DISPOSAL

36. The Purchaser agrees to comply with the State Slash Law, Section 26.12(b), Wisconsin Statutes, and with requests regarding forest fire prevention and suppression made by the Seller.

In addition the Purchaser agrees to comply with the following:

- a. All slash, including hanging trees, tops or limbs in standing trees, must be reduced to a maximum specified height of <u>36</u> inches.
- b. No slash will be deposited, or machinery operated, in lakes or streams.
- c. No slash, logging debris, or machinery operation is permitted outside the sale boundary, unless approved by the Forest Administrator.

- d. The Purchaser will properly dispose of all debris or material not natural to the land, as it is generated.
- 37. The Purchaser agrees to take reasonable precautions to prevent the starting and spreading of fires. Those precautions include, but are not limited to:
 - a. A minimum of one fully charged 5 pound or larger ABC fire extinguisher with a flexible spout shall be carried on each off-road logging vehicle.
 - b. All chainsaws and equipment used in the operation shall be equipped with spark arresters, which have been approved by the U.S. Forest Service. Such arresters may not be altered in any manner or removed. (Information on approved arresters may be obtained from the Seller.)
 - c. If a fire occurs, the Purchaser shall promptly assist in the control and suppression of the fire.
 - d. The Purchaser shall comply with requests regarding forest fire prevention and suppression made by the Seller and take all reasonable precautions to prevent, suppress and report forest fires. Those requests may include ceasing or modifying operations.
 - e. The purchaser shall be responsible for damage and forest fire suppression costs in accordance with s. 26.14 and 26.21, Wis. Stats. caused by their operation under this Contract.
 - f. Other.
- 38. Other slash disposal requirements are as follows:
- 39. The Purchaser shall remove, to the satisfaction of the Seller, all solid waste, trash and debris generated by the Purchaser.

ROADS, CAMPS, LANDINGS, SURVEY CORNERS

- 40. Location, construction, and use of logging roads, mill sites and campsites is subject to advance approval by the Seller. All such areas or facilities used or constructed by the Purchaser must be operated, maintained and restored prior to termination of the contract in a manner satisfactory to the Seller. Purchaser shall repair damage to existing and new roads.
- 41. No residence or dwelling or permanent structure or improvement shall be established or constructed on the premises.
- 42. Logging roads that intersect town, county, or state roads or highways, must have the intersections approved by the proper authorities prior to construction and cleared of all unsightly debris at the time of construction.
- 43. Landings and decking sites are not allowed within 100 feet of any public road, unless approved by the Forest Administrator.

44. The Purchaser agrees to pay for the cost of repair or replacement of any land survey monuments or accessories, which are removed or destroyed or made inaccessible. In the event that the performance bond is insufficient to cover such cost, Section 59.635, Wisconsin Statutes, Perpetuation of Landmarks, may be enforced.

SOIL DISTURBANCE AND RUTTING

- 45. The Purchaser agrees to take all steps and precautions to avoid and minimize soil disturbances, such as soil compaction and rutting.
- 46. Excessive soil disturbance (as defined in Table 1) will not be permitted. Purchaser agrees to contact Seller and work cooperatively to mitigate any and all instances of soil disturbance and rutting.
- 47. Prior to sale completion the Purchaser shall restore soil disturbances to the Seller's satisfaction.
- 48. Other restoration requirements (e.g. repair of soil disturbances or rutting on recreational trails used for skidding trails):

Note: The depth is to be measured from the original soil surface to the bottom of the depression. BEST MANAGEMENT PRACTICES (BMPs) REQUIREMENTS AND OTHER GUIDELINES

49. The purchaser shall comply with all recommended BMPs for Water Quality guidelines as described in "Wisconsin's Forestry Best Management Practices for Water Quality" published by the Wisconsin Department of Natural Resources, publication Pub-FR-093, unless specifically provided otherwise below. A copy of this publication is available upon request to the Seller if not possessed by the Purchaser. Purchaser's certification

- in Wisconsin BMP training or equivalent through FISTA-coordinated BMP workshop is also required.
- 50. The purchaser shall comply with all recommended Forestry BMPs for Invasive Species as described in "Wisconsin's Forestry Best Management Practices for Invasive Species" published by the Wisconsin Department of Natural Resources, publication Pub-FR-444-09, unless specifically provided otherwise below. A copy of this publication is available upon request to the Seller if not possessed by the Purchaser. The publication can also be found at the Council on Forestry website at: http://council.wisconsinforestry.org/invasives/forestry
- 51. The purchase shall comply with all General Guidelines as described in "Wisconsin's Forestland Woody Biomass Harvesting Guidelines" published by the Wisconsin Department of Natural Resources, publication Pub-FR-435-09, unless specifically provided otherwise below. A copy of this publication is available upon request to the Seller if not possessed by the Purchaser. The publication can also be found at the Council on Forestry website at: http://coucil.wisconsinforestry.org/biomass

OTHER

- 52. Purchaser shall be responsible for determining the boundaries of the sale area and shall be liable for all trespass committed by Purchaser outside of such boundaries.
- 53. The Purchaser shall notify Forest Administrator at the time the cutting begins.
- 54. The Purchaser agrees to complete all operations on each portion of the premises or each compartment as designated in the cutting requirements.
- 55. No wood product shall be removed from the premises without prior notification to the Administrator for each occurrence.
- 56. The Purchaser agrees not to do or allow any waste or nuisance upon the premises.
- 57. Purchaser agrees to make stumpage payment at the specified rate for timber marked or designated on the premises, which is destroyed or reduced in value as a result of the Purchaser's operation or negligence.
- 58. The decision of the Committee acting on the advice of its agent and the Department of Natural Resources Forester, as to whether Purchaser is in compliance with the terms of this contract, shall be final.
- 59. The Seller shall give the Purchaser notice in the event of a breach of any condition of the contract. All operations shall cease forth with upon receipt of such notice by the Purchaser, and continued occupancy shall be a trespass. Operations may not be resumed without written authorization from the Seller.

60. The purchaser shall haul all pine products, cut during spring and summer months, within two weeks of cutting as a measure to prevent insect infestations.

WORKERS COMPENSATION INSURANCE

61. The Purchaser shall provide the Seller with a Certificate of Insurance, from an insurance company duly licensed to transact the business of Workers Compensation in the state of Wisconsin, indicating that Worker's Compensation Insurance coverage is provided for employees of the Purchaser, in compliance with Chapter 102, Stats., working under the contract for its duration prior to any performance under it. Such Certificate of Insurance shall further include the condition that the insurer shall notify the Seller within five (5) days of any change in its terms or twenty (20) days prior to its termination.

A person claiming that coverage is not required under Chapter 102, Stats. shall provide the basis for such opinion in writing to the Seller.

GENERAL LIABILITY INSURANCE

- 62. The Purchaser agrees to protect, indemnify and save harmless the Seller from and against any and all causes of action, claims, demands, suits, liability or expense by reason of loss or damage to any property or bodily injury to any person, including death, as a direct or indirect result of timbering operations or in connection with any action or omission of the Purchaser, who shall defend the Seller in any such cause of action or claim.
- 63. Purchaser agrees that, in order to protect itself as well as the Seller under the indemnification provision set forth in the above paragraph, Purchaser will at all times during the terms of this contract keep in force a liability insurance policy, including contractual liability coverage, with a minimum limit of \$1,000,000.00 per occurrence, issued by a company authorized to do business in the State of Wisconsin and licensed by the Wisconsin Insurance Department. Upon the execution of this contract, Purchaser will furnish the Seller with written verification of the existence of such insurance. This verification, typically in the form of a certificate provided by the purchaser's insurance company, **must name Wood County as an "Additional Insured".**

EMPLOYMENT

- 64. The Purchaser is an independent contractor and not an employee or agent of the Seller.
- 65. To the extent that it is applicable to the Purchaser, the Purchaser agrees to comply with Wisconsin Worker's Compensation Act, Chapter 102, Wisconsin Statutes, and all rules promulgated thereunto.

- 66. The Purchaser agrees not to discriminate against an employee or applicant for employment because of age, race, religion, color, sex, handicap, physical condition, development disability or national origin, regarding employment, upgrading, demotion or transfer, recruitment or recruitment advertising, lay-off or termination, rates of pay or other form of compensation, and selection for training, including apprenticeship. The Purchaser further agrees to take affirmative action to ensure equal employment opportunities for persons with disabilities.
- 67. Jobbers and other employees who, on this timber sale or on previous state or county timber sales, have been unsatisfactory in the execution of their work, or in their integrity, shall upon written request by the Seller, be barred from work on the premises by the Purchaser.

DISPUTES, ASSIGNMENT AND CHANGES

- 68. Disputes regarding quality and quantity may be settled by arbitration in accordance with Chapter 788, Wisconsin Statutes, if the party alleging such a dispute notifies the other party in writing thereof within ten (10 days) after the notifying party became aware of, or reasonably could have become aware of, such dispute.
- 69. This contract cannot be assigned or subcontracted in part or in whole without prior written approval from the Seller and may be changed or amended only in writing. The Purchaser shall notify the Surety, if any, of such change or amendment.

CONTRACTING PARTIES

- 70. In this contract, the Seller and the Purchaser include their respective officers, employees, agents, directors, sub-contractors, assignees, partners, representatives, successors, heirs, members and servants.
- 71. If the Purchaser ceases to exist, in fact or by law, the Seller may immediately terminate this contract and, without waiving any remedies available to it, perform the contract.
- 72. OSHA Compliance, Danger trees. The Purchaser is responsible to comply with, and assure compliance by all employees or subcontractors with, all Occupational Safety and Health Act (OSHA) requirements for the health and safety of Purchaser's employees, including provisions relating to danger trees. In addition, the Purchaser agrees to notify, and obtain agreement from, the Seller if the Purchaser intends to modify performance required under this Contract for the purpose of compliance with OSHA requirements.

TIMBER SALE CONTRACT EXTENSION POLICY

The Wood County Highway Infrastructure and Recreation Committee is responsible for the extension of timber sale contracts and would like to see sales cut in a timely manner. The Committee grants contract extensions and associated stumpage increases at their discretion. Each contract extension/stumpage increase will be determined on a case by case basis with factors such as: access, weather, ground conditions, silvicultural objectives, balances owed, natural disasters, etc. taken into account.

In general, the Committee may be more willing to grant first extensions without any stumpage increase if a job has been started. Contracts that are two years old with no activity, and contracts that have had more than one extension are of special concern and are more likely to have stumpage increases assessed. There may be special contracts that have no flexibility in length due to timing of silvicultural considerations, storm damage, etc. In these cases contract length will be fixed, and the contractor should expect to be penalized for not completing the sale in the time specified in the contract. Additionally, contracts that have had multiple extensions may not be extended in the future.

The typical contract extension will be for one year. The extension/stumpage increase schedule is as follows:

- 8. Firewood may not be removed with skidders, tractor, log truck, or any vehicle rated with a load capacity exceeding 1 ½ Tons or a gross vehicle weight of 12,000 lbs.
- 9. Permittee agrees Section 895.52, Wis. Stats., is applicable as to liability and, further, agrees to save and keep harmless Wood County and its employees against any and all liability claims, costs of whatever kind and nature, for injury to or death of any person of the loss or damage to any property, occurring in connection with or arising out of the occupancy, use, service, operation or performance of work in connection with removal of wood authorized under this permit of the permittee or permittee's agents.
- Permittee understands that he/she may be held responsible for damage to any county property that he/she may cause while operating under this permit.
- 11. All wood cut by the permittee must be for his/her personal use only and not to be sold.

It is understood by the Owner and the Permittee that this permit is subject to the following conditions:

- 1. Prior to this permit taking effect, the Permittee shall submit for approval to the Owner a plan describing any construction and maintenance on the above described property. No deviations from this plan will be allowed without the prior written approval of the Owner.
- 2. Accessway improvements and upgrading must be approved in advance and will be supervised by the Wood County Forest Administrator. Prior notification of not less than ten (10) working days is required before work starts.
- 3. If the Owner determines that further use of the above-described property by the Permittee is not in the best interest of the owner, for whatever reason, the owner reserves the right to cancel this permit by sixty (60) days written notice to the Permittee by the Owner.
- 4. This permit is nontransferable.
- 5. The accessway width is to be no greater than one rod (16.5 feet).
- 6. No cutting or trimming of trees shall be done without the prior written approval of the Owner. All wood cut is the property of Wood County.

- 7. Any wood products approved for cutting will be cut and piled by species and all wood in 100 inch lengths cut to a 4 inch top diameter.
- 8. Present and future forest management, timber sales, timber stand improvement, reforestation or other forest or recreational activity shall be of high priority of the Owner and in no way should be hindered by this agreement.
 - 9. All stumps, slash, waste materials and other debris resulting from the permitted land use shall be disposed of by the Permittee as directed by the Owner.
- 10. The Permittee shall maintain the area under this permit in a safe and environmentally sound condition at all times, causing no obstruction to free and uninhibited use by the public.
- 11. No gates, signs, or other articles of the Permittee will be allowed on the Owner's land.
- 12. This land use agreement does not extend to the Permittee any permission to use County Forest Land for personal use or to store equipment, lumber, or other miscellaneous items.
- 13. The accessway is not to be used to gain access to a domicile or place of business.
- 14. The Permittee agrees to reimburse the Owner for any property or environmental damage to the subject property that may arise from the construction, maintenance or use of the described lands.
- 15. This permit does not give the Permittee, its members or agents, any rights pertaining to hunting or trapping; said rights remain under the control of the Owner.
- 16. The Owner continues full ownership of the improved roadway and land; however, it shall not be liable for maintenance or upkeep of the road.
