Donor Recognition

All contributions of \$1,000 or more will be recognized on the Donor Recognition Wall in the Multi-Use Shelter Building. Gifts of \$100 or more will be publicly acknowledged during the course of the campaign. Donors may remain anonymous.

All gifts and pledges will be kept confidential, to the extent of the open records law. Donors may choose to make their gifts in honor or in memory of another person, or they may choose to have business or personal names engraved on the plaques.

The following Giving Societies have been established to recognize different levels of giving for gifts and pledges.

Benefactors Giving Club	\$25,000 - \$49,999	Specialized Plaque based on gift range
Legacy Giving Club	\$15,000 - \$24,999	Specialized Plaque based on gift range
Heritage Giving Club	\$7,500 - \$14,999	Specialized Plaque based on gift range
Leaders Giving Club	\$3,000 - \$7,499	Specialized Plaque based on gift range
Friends Giving Club	\$1,000 - \$2,999	Specialized Plaque based on gift range

The size of the recognition plaques will correlate with the Giving Society that you are a part of. The final Donor Recognition Wall design will be approved by the Highway, Infrastructure and Recreation Committee prior to construction. Donors will have the opportunity to identify how they wish their names to be displayed prior to installation.
