1. Call to Order:

4. Emergency Management Department:

a. Communications August 2014 Claims

Sheriff Reichert stated a long-term agreement has been taken care of regarding the range. This agreement will be beneficial to both departments.

c. Tribal Law Enforcement Grant – Resolution

Wood County is eligible for the yearly tribal grant from the State regarding providing additional funds for law enforcement on tribal lands within Wood County. This would be the Ho-Chunk Nation. The dollar amount varies from year to year. This is a state grant and the County only spends the amount they receive. This account is a non-lapsing account and doesn't affect tax levy. The money is used for extra patrol and activities and education by the Ho-Chunk.

Motion by Hamilton, second by Polach to sign the Tribal Grant resolution and send on to County Board. Motion carried unanimously.

Crimestoppers: Sheriff Reichert stated Crimestoppers is having a fundraising show on September 13, 2014. He will be speaking at this event.
