SPECIAL ORDER OF BUSINESS UPDATE REGARDING UW CAMPUSES REGIONALIZATION

Dr. Keith Montgomery, Regional Executive Office and Dean for the North District presented information to the board regarding the recent changes in the administrative structure. He explained the administrative structure for the North Region and explained the background of the restructuring needed in part because of budget reductions and a decrease in high school graduating classes. He highlighted some benefits of regionalization as centralizing services, sharing of resources, and consolidation of positions between member campuses. Dr. Montgomery answered the many questions of those assembled.

INTENT & SYNOPSIS: To obtain County Board approval as required under §59.52(28), Wis. Stats., to contract with the Wisconsin Department of Revenue (DOR) for the collection of unpaid debt under §71.93(8).

FISCAL NOTE: Unknown. The Department of Revenue's State Debt Collection Agency has statutory authority for the use collection tools not available to private collection agencies, which is expected to result in an increase in collections. However, the amount of that increase cannot be estimated.

FISCAL NOTE: No cost to Wood County--Total reimbursement from State Snowmobile Aid account #55441.

ORDINANCE 16-2-10

FISCAL NOTE: Unknown; there is an undeterminable savings associated with the increased safety of highway workers, there will be costs attendant to creating and maintaining the temporary signage

SPECIAL ORDER OF BUSINESS TRANSITION TO RIVERBLOCK UPDATE

Jason Grueneberg gave an update to the board regarding progress in transitioning departments to the River Block Building. Venture feels that the timeline is going faster than anticipated. Dispatch and IT will probably remain here at the courthouse, while Human Services and Health will go to River Block. IT staff is heavily involved in the research of running fiber to that building. Parking is a challenge and solutions are being researched and considered. There is a meeting with city inspectors on Thursday. Key people have received training on the card reader system there. There is an Advisory Committee made up of representative staff from IT, Maintenance, Human Services, Health, Parks & Forestry and Dispatch to work through issues. Questions, discussion and suggestions followed. Motion by Wagner/Hendler to waive County Board Rule #42 to allow the Executive Committee the authority to enter into negotiations regarding downtown parking and matters related to the Courthouse Annex building. Motion carried. Voting no were Winch, Polach, Hamilton, Clendenning. Excused was Miner. Further discussion decided that notice of the Advisory Committee meetings will be set to the county board supervisors for their information.

Motion by Wagner/Nelson to adjourn. Motion carried by voice vote. Next scheduled county board meeting is March 15, 2016.
