1. Call meeting to order

- 2. Declaration of quorum
- 3. Public comments. Bill Clendenning regarding a bridge.
- 4. Correspondence: None.
- 5. Approve minutes from previous committee meetings: One correction #7 bottom of page 3, Section D, misspelled word, change to "IF" the plow. **Motion to approve by D. LaFontaine, second by A. Breu. Motion carried.**
- 6. ATV Trail/Route system update: R. Hawk met with T. of Port Edwards regarding various issues. Departments involved with the initial County ATV Route have a meeting scheduled soon to get the initial planning group together to talk about signage, as well as updating the ATV Route/Trail Map. Matt Susa from the SD will also attend to address issues related to operation of ATV's. Highway is continuing to place signs throughout the end of May or early June. Send out an invite to the local ATV groups to attend this meeting. Grand Rapids, on May 10th will have their regular monthly meeting and will be a public hearing on routes in the Town of Grand Rapids. Grand Rapids will not open roads west of 32nd street. Hwy. Z and W will remain closed. C. Schooley states that potential town roads opening in Grand Rapids lead to South Wood County Park. How will this be managed within the Park? Recommendations will come to the HIRC for review and approval.

7. HIGHWAY

- a. Highway staff reports.
 - Contracted w/a Forestry Consultant to mark the timber in Highway Dept. pit property, in the Town of Cary. F. Schubert has included consultant's timber sale map and bid documents in Wood County Forest timber bid packet for the spring bid opening, on May 26 at 9am at the ATV Intensive Use Area Shelter.
 - Supervisor's Vehicles: In early March, a supervisor came in during a snowstorm and left the road and hit a tree. Totaled by the insurance company. Received a check from the insurance company and purchased two new ones to replace this totaled vehicle as well as another vehicle that needs replacement. They found two vehicles at an East Dubuque dealership.
 - Met with public works department to talk about shared camps to talk about the bonding issues. Public hearing on May 26 regarding this.
 - R. Hawk submitted a draft policy regarding changing of CDL requirements. They would hire someone with a learning permit and train them on the job for CDL skills test. They would give the employee 60-90 days to pass the test. If not passed, they would be terminated. Anyone obtaining a CDL has to attend a certified school. R. Hawk is going to check more into this new policy. His proposal is to hire a candidate and if they don't have a CDL, hire at Step 1, enroll in school pay their salary while attending salary, once they complete school, they can pay for it out of pocket or loan and we would reimburse them over a 36-month period but only if they stayed employed w/the county for those 36 months. This is a proposal that is currently being reviewed with HR and Corp Counsel. No action is taken right now on this proposal, for informational purposes only. Parks & Forestry is also in the same situation.

- Engineer applicant has turned down the position.
- They have one offer in to a Mechanics hire. Being down a Mechanic has really slowed down that department quite a bit. May need to hire someone that is not a certified diesel mechanic to perform work on other equipment. That would free up our other mechanics to take care of heavy diesel and off road duties. Would at some point, be requesting an additional employee to the shop. Not asking for approval right now, just for informational purposes. This position would be funded by all the outside departments and agencies that they work with.
- b. Highway revenue reports & vouchers: Motion by A. Breu and second by J. Hokamp. Motion carried.
- c. Marshfield Shared Campus. Discussed under staff reports. He will keep us posted as to what is presented at the next meeting. May 26th is the hearing on the re-development plan.
- d. Shop Personnel. Mechanics position which was discussed in the staff report.
- e. STP Bipartisan Infrastructure Projects Update. Met w/DOT to discuss CTH A. They agree it does warrant to be transferred to a State Hwy. status. A process will need to be followed regarding this transfer and R. Hawk will be working with the State DOT to complete this transfer. Will apply for a grant for the southern six miles. R. Hawk mentioned several grants that were approved for various projects.
- f. Supervisors Trucks. Discussed in staff reports.

8. PARKS AND FORESTRY

- a. Parks & Forestry staff reports. F. Schubert highlighted the Timber Sale Bid Opening coming up on May 26, 2022 at 9am at the ATV Intensive Use Area Shelter. A total of 497 acres is up for bid.
 - Powers Bluff Bike Trail Project contract signed with Rock Solid. Will be flagging trails the week of May 16, with construction beginning in June. C. Schooley will be doing a walk-through with DNR water specialist to determine what permits will be needed. Rock Solid plans to bring in three crews to get a jump-start on it and will be working all the way to freeze-up this year. Anything left over will be finalized in spring of 2023.
- b. Snowmobile and ATV Grant resolutions for application for 2022-2023 Trail Aids/Maintenance and Development on Plum Road. **Motion to approve by A. Breu and second by D. LaFontaine. Motion carried.** Supervisor Clendenning would like to have maps included in the County Board packet showing the locations for these funded projects.
- c. Powers Bluff Project. C. Schooley passed out a map and provided explanation as to what parts of the project he is getting cost estimates for. The Highway Department is putting together cost estimates for the multi-use trail, and the entrance road with parking lot for the trail head location. MSA will be providing updated construction costs for the trailhead shelter building. Hwy will also be putting together an estimate for the continuation of the entrance road, up to the future site of the warming house/multi-use shelter building, at the base of the tube hill. ARC Central has provided cost estimates for a new shop at Powers Bluff. This has been forwarded to Erik E, Communications, for possible funding assistance from one of the vendors using the existing Powers Bluff communications tower. Other project expenses that will have to be determined include signage replacement/improvement throughout the park. This may be an eligible project for CEED grant funding. D. LaFontaine feels that the overall costs of the different parts of the project should be compiled for County Board. Perhaps split into segments and introduce them separately and what our plans are. C. Schooley is looking into engineering/design costs associated with snow making/lighting for the tubing/skiing hills. C. Schooley has been invited to present at the May Towns Association Meeting and will be discussing this project.
- d. Special Use Permits. Humane Society for a Run/Walk Fundraiser around South Park. They utilize the walk trail around Wazeecha in partnership with the Blue Grass Festival. The date is June 11th and will utilize the Red Sands Beach Pavilion. The second permit is from ODC, and is a first time event, which is a run/walk around Wazeecha as well. They want to utilize one of the small shelters at White Sands Beach and have that parking lot as their staging location for the event. It is scheduled from 9am to 8pm on August 20, 2022. Concerns are that is when the beaches are still open and the other shelter building is being utilized by a different event. They are expecting 100 people so parking may be an issue. She is looking at other dates later in the year if this date does not work. Motion by D. LaFontaine to approve the Humane Society event and deny the ODC unless date changes to after Labor Day. Second by L. Thao. Motion carried.

- e. Parks and Forestry revenue reports. F. Schubert answered questions on Forestry report. Parks Revenue Report was not completed this month due to demands on the office staff of the new reservation system being launched on May 2, 2022.
- f. Parks & Forestry vouchers. Motion to approve by D. LaFontaine, second by J. Hokamp. Motion carried.

Subject: Commissioner Report for June 2, 2022 HIRC meeting

Department Activities

Personnel/Administration

The Highway Department currently has two truck operator positions and a mechanic position open. Interviews for the truck operator position were conducted on May 25. Candidates are being notified. Interviews for mechanic will be scheduled when qualified applicants apply.

There has been a considerable increase in the number of non-Highway equipment and vehicles repaired or serviced at the Highway Shop over the past few years. The vacant mechanic position makes it difficult for the shop to keep up. There is enough revenue to support a light duty mechanic position that would free up more time for the diesel mechanics to service Highway equipment. Commissioner would like to add an additional light duty mechanic position to the Highway Department Staff. Diesel mechanics are Grade H, the light duty mechanic would be Grade G.

The engineering position remains open, however there have not been any applicants apply. May need to adjust salary range.

Commissioner is working with HR on a policy to help new hires obtain Commercial Driver License (CDL) from a certified training school. Policy will need HIRC & Board approval before implementation.

In order to attract and retain qualified staff in the Highway Department, Commissioner is recommending;

- Moving Grade F (CDL holders & Program Assistant) to base step 6 and increase all remaining Grade F employees \$0.31 per hour for each year of service in the Highway Department.
- Moving Grade G (Operator I) to base step 5 and increase all remaining Grade G employees \$0.29 per hour for each year of service in the Highway Department.
- Moving Grade H (Operator II) to base step 4 and increase all remaining Grade H employees \$0.27 per hour for each year of service in the Highway Department
- Moving Grade I (Lead Person) to base step 3 and increase all remaining Grade I employees \$0.25 per hour for each year of service in the Highway Department.

This adjustment equates to approximately \$148,720 annually.

Commissioner and supervisors met with Barrientos Design & Consulting to initiate the Space Needs Study for the Wisconsin Rapids Highway Shop approved by the HIRC in February. The study will take approximately 3-4 months.

Commissioner will continue to work with WisDOT NC Regional regarding a Jurisdictional Transfer of CTH A from STH 80 to US 10 to a State Highway while pursuing Federal Funds to reconstruct CTH A.

Projects approved in the 2022 – 2027 STP-Rural program submitted in December include:

CTH N Bridge replacement (located 0.1 miles east of STH 186) FY 2024

CTH HH & CTH F Intersection (recommended improvement is a roundabout) FY 2026

Highway Maintenance

Work in May included:

- repairing cracks, dips and potholes on State, County & Local highways
- installing/replacing culverts and restoring drainage in ditches
- preparing chips for chip seal projects
- retrieving shoulder material on county and state highways
- repairing bridge rail and beam guard

Chip Seal Projects are scheduled June 6 – 16

Spraying Noxious and Invasive weeds in roadside ditches will take place June 6-16.

ATV Plan/Development

Crews are installing signs as outlined in the adopted ATV ordinance. The sign crew has been working very diligently to complete the signing by Memorial Day Weekend. The ATV sub-committee met May 17 to discuss removal of County designated ATV Mainline Route, new maps, signing, and coordination with ATV Clubs.

Equipment/Machinery

Commissioner, shop supervisor, and plant lead person inspected crushing equipment and conveyors for sale in Langlade County that would be beneficial to the crushing and recycling process for the Highway Department. Langlade County Highway has a 1966 Cedar Rapids breaker, 2004 Masaba stacker and a 2016 Kafka transfer conveyor for sale for \$80,000. This equipment would greatly reduce crushing costs and improve our recycled asphalt process. Commissioner is requesting approval to purchase.

The Traffic Safety Subcommittee submitted a grant application for a Predictive Analytics Grant and a portion of it was approved. The Commissioner worked with the Sheriff's Department, Emergency Management, and various police departments in Wood County to develop a project and grant proposal. See the attached. A major component of the grant was to purchase a Portable Changeable Message Sign. At the time we submitted the Grant the estimate for the PCMS was \$13,000. The cost has gone up to \$19,000 in the past month. Commissioner is requesting permission to purchase the PCMS and request the grant to reimburse the \$13,000.

WCHA

The WCHA is seeking committee members for the Board of Directors and a Vice Chair to be elected June 8 at the Summer Road School at the Chula Vista in Wisconsin Dells. To be eligible a committee member must be serving on a county highway or public works committee. The BOD position generally serves 2 – 4 years or until the committee member is no longer a member of the highway or public works committee. The Vice Chair serves one year as VC, one year as Chair, and one year as Past Chair or until no longer a member of the highway or public works committee.

Wood County Highway Traffic Safety Commission; Predictive Analytics; Speed enforcement and Crash reduction

Wood County is proposing a goal of reducing crashes with the focus on failure to yield, inattentive driving and failure to maintain control for a span of two years. There will be 4 main areas of focus for this project, those being Wisconsin Rapids, Marshfield, Grand Rapids and one chosen rural area.

Data Collection

Over the next two years Wood County will work with WisDOT to look at data pertaining to crashes that are due to failure to yield, inattentive driving and failure to maintain control. It is the goal to compare data that was used to determine the parameters for this project and the data that was collected after the project was started to see if any of the techniques were useful and/or effective in reducing crashes in Wood County.

Solution Techniques

Main corridors will be chosen for each of the main areas of focus where an increased police presence will take place. The main corridors in Marshfield will be Business 13 from the city limits to the county line and Central Avenue. Wisconsin Rapids will focus on State Highway 13 from the expressway to south of the city limits. Grand Rapids will focus on State Highway 54 from the Portage County line through Wisconsin Rapids into the intersection of State Highway 54 and State Highway 66. This will allow Grand Rapids, Wisconsin Rapids, Biron, and the County police departments to participate. The rural area will be focused on State Highway 10 from State Highway 186 to County Highway K. We would like to have a pamphlet that includes what the laws are for failure to yield as this appears to be a widely unknown topic. We would also like to install and utilize flashing "stop ahead" signs on county roads and high-volume town roads.

Collaborations

The Wood County Traffic Safety Committee is working closely with the Wisconsin Department of Transportation on the State Highway corridors included in this project. The Regional WisDOT Office has granted approval for placement of the Portable Changeable Message Signs on USH 10, STH 13, and 54 as it relates to the Predictive Analytics Project and study area. In addition to the PCMS, the TSC has obtained approval from the Regional WisDOT Office to install stop signs at STH 186 and USH 10 with LED lights as part of the project.

Planned Activity Description:

The work plan is to reduce inattentive driving and failure to yield crashes in targeted areas and conduct educational activities.

Activities

- 1. Utilize local media to heighten awareness of the traffic hotspots and the factors in contributing to crashes.
- 2. Purchase and deploy PCMS board and flashing signs on the corridor approaches to provide advanced warning and enhanced enforcement.
 - a. Relocated equipment based on data when goals and targets are met.
- 3. Conduct 245 hours of enforcement in the hotspot areas and saturation patrols in 2022 and 236 hours of enforcement in 2023.

Parks & Forestry Department Reports

June 2, 2022

Director Report, by Chad Schooley

- Last fall we had a representative from the USDA speak at one of our HIRC meetings regarding Canada goose abatement/control measures within our parks. As in the past, I am in favor of a round up due to the high goose activity each year on our beaches, swimming areas, and shelter building walkways and green spaces. This contributes to the high e-coli counts within our swimming areas each year, and makes for a very messy walk near our shelter buildings. This is on the agenda for consideration.
- Rock Solid Trails Construction has completed their flagging of the PB bike trails. I am now
 working with the DNR on required permitting. I will also be meeting with the Tribal Historical
 Officers from the Potawatomi and Ho-Chunk Nations in early June to discuss the trails project, and
 future interpretive signage within the southern 80 acres of the park, which is included in the
 State/National Register of Historic Places. Trail construction is scheduled to begin in mid/late
 June.
- Highway Department is putting together cost estimates for the Powers Bluff multi-use trail project; trailhead entrance road/parking lot; and the road/parking lot to the future warming house shelter building. MSA has completed an updated cost estimate for the trailhead shelter building. I will bring a summary sheet with this information to the HIRC meeting.
- Currently, the Parks and Forestry Department allows hunting and trapping on the northern 223 acres of Powers Bluff. At the time of acquisition in 2012, the HIRC approved allowing hunting/trapping at this location until development occurred which would increase the safety risk to park users. Chairman Hahn has requested to place this on the agenda for discussion/review.
- Continue assisting Emergency Management on grant application materials for the South Park storm shelter project.
- Participated in interviews for the Parks Maintenance Worker position for Dexter County Park.
- Attended the Towns Association meeting held at Dexter Town Hall. I gave a presentation on the Powers Bluff bike trail project.
- Overseeing security camera installation at the Nepco shelter, White Beach House, and South Park ranger station. We are working with Solarus on this project. They currently have Wi-Fi at each one of these locations, and will be allowing us to use the Wi-Fi free of charge in the future.

Maintenance Program Supervisor Report, by Dan Vollert

Construction Projects

Roofs for signs and bulletin boards are built and on list to install.

- South Park pit toilet, south of dam, roof repair and interior upgrades.
