The Wood County Board of Supervisors composed of nineteen members convened at the Wood County Boardroom in Wisconsin Rapids, Wisconsin on March 18, 2014.

Chairman Pliml called the meeting to order at 9:30 a.m.

Supervisor Moody came forward and gave the invocation and led the Pledge of Allegiance.

Motion by Feirer/Machon to approve the minutes of the previous meeting. Motion carried by voice vote.

There were public comments: Jason Angell, City of Marshfield Economic Development Director briefly updated the board on their Economic Development Board activities and the housing study they're currently undertaking. He plans to do a quarterly report from now on. Dave Sullivan from Excel Lawn Care spoke in support of the proposed ordinance for enforcement of non-blockage of railway crossings. This is having an adverse effect on this business.

ORDINANCE 14-3-3

Introduced by: Public Safety Committee

INTENT & SYNOPSIS: To set forth in the county's code of ordinances the adoption by reference of the state statute regulating trains obstructing highways so that citations can be utilized for violations of the law, and

To also set forth in the county's code of ordinances a catch-all provision that provides that any act required to be performed or prohibited by Wisconsin statute that can be incorporated herein are so incorporated by reference so that citations can be utilized for those violations.

FISCAL NOTE: Nominal impact anticipated; citations result in more of the forfeiture imposed being allocated to the county.

Introduced by: Judicial & Legislative Committee

INTENT & SYNOPSIS: To ratify the Executive Committee's overseeing of negotiations with the City of Marshfield (City) for the extension of the Marshfield city hall lease.

FISCAL NOTE: None at this time.

RESOLUTION 14-3-5

Introduced by: Judicial & Legislative Committee

INTENT & SYNOPSIS: To establish a salary for the Wood County Administrative Coordinator position and in doing so to give better recognition to the work load and responsibilities associated with that position.

FISCAL NOTE: The proposed \$20,000 annual salary of the Administrative Coordinator would replace the current \$405 per month paid to the county board chairperson. For calendar year 2014, the budget impact would be \$15,000 (9/12th of \$20,000) - \$3,645 (9 x \$405) for a total of \$11,355. Funds have not been budgeted for this and, therefore, a transfer of \$11,355 from the available balance in the contingency account (51590) to the committees and commissions account (51120) is needed. The current balance in the contingency account is \$450,000.
