K9 Program – October 2017

TRAINING – This month was the first month with the K9 Hot and Pop system installed in both of the K9 squads. This equipment will help ensure the safety of our K9 with regards to the temperature of the squads. Deputy Pidgeon and Deputy B Christianson have been working with the equipment and have been familiarizing themselves with it. Another feature of this equipment is to remotely open the door allowing the K9 to exit and assist in the event the Handler cannot manually open the door. This equipment will be very useful.

Deputy Pidgeon and K9 Toro as well as Deputy B Christianson and K9 Ace also attending the Wisconsin Law Enforcement Canine Handler Association Conference in Oshkosh WI from October 1-4. At this conference, there were numerous K9 teams from across the state. Trainings sessions varied from Tracks to Narcotics Detection to Apprehensions.
