# PROCEEDINGS OF WOOD COUNTY BOARD OF SUPERVISORS October 15, 2013 - 9:30 a.m.

The Wood County Board of Supervisors composed of nineteen members convened at the Wood County Boardroom in Wisconsin Rapids, Wisconsin on October 15, 2013.

Chairman Pliml called the meeting to order at 9:30 a.m.

Supervisor Moody came forward and gave the invocation and led the Pledge of Allegiance.

Supervisors present were: Allworden, Ashbeck, Breu, Clendenning, Curry, Feirer, Hendler, Henkel, Hokamp, Miner, Moody, Murphy, Pliml, Polach, Rozar, Wagner and Winch.

Excused were: Supervisors Nelson and Machon.

Motion by Clendenning/Breu to approve the minutes of the previous meeting. Motion carried by voice vote.

Motion by Feirer/Hokamp to re-appoint Beth Martin to a three year term to the Veterans Service Commission. Motion carried by voice vote.

Public comments: Supervisor Miner brought to the attention of the board the recent election of Chairman Pliml as Second Vice-Chairman of the Wisconsin Counties Association. He will ascend through the ranks to become president in two years. Congratulations were offered.

Acknowledgements and Recognitions: Sheriff Reichert came forward to announce that Deputy Sheriff Bren Derringer was the top prize winner at the Wisconsin County Mutual Insurance Corporation ALERT (Advance Law Enforcement Risk Training) shooting competition. With this achievement, Deputy Derringer receives a \$7500 prize gift to the Wood County Sheriff's Department and a \$1000 personal gift certificate.

Supervisor Feirer announced that a new Dispatch Manager has been hired. He is pleased to announce that Lori Heideman has been chosen. Lori comes with 20 years Wood County experience. She has been, and will continue to be a great asset.

Minutes of various committees were reviewed. Reports, requests and resolutions relating to county board business are as follows:

Committee minutes presented: Executive Committee- Supervisor Winch noted that too many acronyms are used in the minutes. It would be helpful for them to be spelled out. Short discussion regarding Clean Sweep funds not in the budget. Discussion regarding the Space Needs Implementation Committee's selection/hiring of architect to move forward in planning the needs of the county. Motion by Winch to hold off hiring and funding an architect until we have the results of the Space Needs Committee and a decision on what we will be doing. Rozar explains the differences in the first and second "Space Needs" Committees and their evolution and purposes. Much discussion ensued. As there was no second to Supervisor Winch's motion, after it was made, clarification was sought from Corporation Counsel. Supervisor Murphy then seconded the motion. Further discussion regarding if this

motion has any merit/impact. Motion failed. Yes 4, No, 13. Voting no were Rozar, Feirer, Wagner, Hendler, Breu, Miner, Henkel, Curry, Hokamp, Pliml, Allworden, Murphy, Moody. Absent were Nelson and Machon. Supervisor Miner noted that the November Budget Hearing starts at 9:00 a.m. and noted that Finance Director Martin handed out a synopsis today. Health and Human Services Committee – much discussion regarding lease/leased Health Department space at Riverview Hospital. Health Director Kunferman explained the terms of the lease and ongoing negotiations. Authority to sign leases is questioned. Corporation Counsel explains the authority of a department head and county board. Motion by Wagner/Clendenning to postpone decision or execution of the Health Department lease until it comes before the county board at its next meeting. Motion carried 9 yes, 8 no. Voting no were Rozar, Feirer, Hendler, Breu, Miner, Henkel, Hokamp, Allworden.
