# PROCEEDINGS OF WOOD COUNTY BOARD OF SUPERVISORS April 15, 2014 - 9:30 a.m.

The Wood County Board of Supervisors composed of nineteen members convened at the Wood County Boardroom in Wisconsin Rapids, Wisconsin on April 15, 2014.

Chairman Pliml called the meeting to order at 9:30 a.m.

Supervisors present were: Allworden, Ashbeck, Breu, Clendenning, Curry, Feirer, Hamilton, Hendler, Henkel, Hokamp, Leichtnam, Machon, Miner, Nelson, Pliml, Polach, Rozar, Wagner and Winch.

Supervisor Miner came forward and gave the invocation and led the Pledge of Allegiance.

County Clerk Cepress asked the Supervisors to rise and administered the Oath of Office.

Chairman Pliml informed those assembled that today as we celebrate the 100<sup>th</sup> year anniversary of Wisconsin's 4-H, we are honored to have representatives from our local 4-H groups who will lead us in the Pledge of Allegiance and the 4-H pledge.
