## 1) Call to Order

Meeting called to order at 5:00 p.m. by Chair Rozar.

<u>HUMAN SERVICES</u> – Kathy Roetter responded to a question regarding an anonymous complaint investigated by surveyor from the hospital unit.

## 7) Financial Statements - Edgewater Haven, Human Services, Norwood Health Center

Financial statements were reviewed and specific questions answered by appropriate department heads.

## 8) Update on Edgewater Haven renovation project

Amy Slattery reported all bid numbers are in and construction costs are \$37,500 under budget at this time.

#### 9) Edgewater Case Mix and Consultant education

Amy Slattery described how case mix index is determined and noted incorrect coding has cost Edgewater lost revenues. Meetings are currently being held daily to ensure billing is accurate and all potential sources of revenue are included in reimbursement codes.

# 10) Resolution – Veterans Service Commission request for additional \$1,000 appropriation for Veterans Relief – Grants and Loans

Rock Larson explained reasons for variance of budgeted expenditures. Motion (Feirer/Machon) to amend the 2012 budget for Veterans Relief with a transfer of available appropriations from non-lapsing fund balance, and forward to Executive Committee and County Board for approval. ## 13) Impact of Wage Compensation Study on Human Services Department

Kathy Roetter shared concerns regarding 60 employees red-circled as a result of the wage compensation study (51 of those are employed in Human Services; 40 of who are at Norwood). She also shared concerns with proposed starting wage rates of newly classified social worker positions. Employees feel they have no understanding of how the data was obtained because comparable information is not being shared at this time. Concerns were expressed on the perceived lack of process transparency.
