- 1. At 11:00 a.m., the meeting was called to order. All participants identified themselves.
- 2. Public comments. Most of the public attendees spoke at least once. The general tenor of the comments was that the Register of Deeds was doing a good job and they supported her handling of this matter. Several abstractors spoke in favor of their being able to use pens and having a cell phone on them when in the vault.
- 3. Conditions on public access to Register of Deeds vault.

Attorney Richard Bender, who owns a title company, has been frustrated with Register of Deeds Tiffany Ringer's policy that pens, cell phones, and brief cases are not to be brought into the Register of Deeds' vault. The Register of Deeds is trying to comply with regulations that provide that these items are not to be brought in the area where vital records are stored and since the vital records and land records are all stored in the vault area, the entire vault should be treated as the vital records area.

Discussion was had about what could be done to segregate the vital records as well as the level of need in making things more convenient to the abstractors. It was pointed out that title work can be done online, albeit, at a cost to the consumer.

The Committee recognized that Ms. Ringer is a constitutional officer and its role was to advise and avail the Register of Deeds with funds, if sought and necessary to resolve the problem.

At the end of the discussion there seemed to be clarity on the issues by those present.

Moved by Wagner, seconded by Curry, to recognize that Register of Deeds Ringer has acted within her scope of authority and if she decides it is appropriate to seek funding from the County to make physical changes to the facility, specifically the

vital statistics records area, she can bring such a request back to the Committee. 4 ayes, 1 nay. Zurfluh voted no as he thought the motion was unnecessary. Motion passed.



Electroconvulsive Therapy (ECT). As I have previously reported, this office has been doing a lot of work and spending a fair amount of time dealing with ECT petitions lately. We have had some successes and some failures as well. In the end, it is our role to assist the Human Services Department in providing the best services possible to their clientele even though at times those clients don't recognize what is in their best interest. This office is involved in pursuing the involuntary administration of psychotropic medications on a weekly basis but the involuntary administration of ECT, which has fewer side effects than psychotropic medications, is just a touchy area and that is why I bring it to your attention.





WHEREAS, in addition to Medicaid, Wisconsin also administers BadgerCare Plus, a similar program for groups of people who need healthcare coverage but who may not qualify for Medicaid or who need different kinds of services. BadgerCare Plus is also sometimes informally referred to as just BadgerCare; and

WHEREAS, those individuals who do qualify for BadgerCare or BadgerCare Plus face a "benefits cliff", defined as "A benefit cliff occurs, when a public support program is designed in such a way that, at a certain level of income, a small increase in earnings can result in a significant loss in eligibility for benefits." (Source; Over the Edge: An Analysis of the implications of Benefit Cliffs Within Wisconsin Public Benefit Programs, Workshop in Public Affairs, Spring 2020, Robert M. LaFollette School of Public Affairs, University of Wisconsin-Madison); and

WHEREAS, this benefit cliff, in some instances, becomes a barrier for individuals seeking employment, or seeking better employment; and

WHEREAS, there currently exists in Barron County, approximately six-hundred (600) full-time positions for which workers are needed; and

WHEREAS, allowing individuals to work productively without harming their health benefits, not only reduces the cost of a benefit program but also simultaneously, improves the overall economic activity of a region; and

WHEREAS, the drafting of this Resolution has the support of State Representative David Armstrong and Barron County Health and Human Services Director Stacey Frolik, and

WHEREAS, attached to this Resolution are selected pages from the above referenced source which provided additional details; and

REQUESTING THE STATE OF WISCONSIN DECRIMINALIZE RECREATIONAL CANNABIS

WHEREAS, Wisconsin is one of 17 states that saw an increase in marijuana possession arrests from 2010 to 2018 despite an attitudinal shift towards decriminalization, legalization, and possession of marijuana; and

WHEREAS, the Wisconsin ACLU found that Black Wisconsinites were more than 4 times more likely to be arrested for marijuana possession despite comparable usage rates; and

WHEREAS, Wisconsin ranks 14th in the country for the largest racial disparities in marijuana possession arrests; and

WHEREAS, Wisconsin's marijuana laws are not aligned with neighboring states and countries. Canada, Illinois, and Michigan have legalized recreational usage for parties over 21 years of age and Minnesota has a medical marijuana program and may soon approve recreational usage; and

WHEREAS, Wisconsin voters answered the question to legalization clearly with only 15% indicating marijuana should remain illegal across the state; and

WHEREAS, a Marquette Law School poll indicated that 60% of Wisconsinites believe marijuana should be legalized; and

WHEREAS, according to the Marijuana Policy Project an estimated 663,367 arrests were made in 2018, 92% of which were for possession alone; and

WHEREAS, in 2018, Wisconsin arrested nearly 15,000 adults for marijuana possession; and

WHEREAS, one person in the United States is arrested for marijuana possession every 48 seconds, and

WHEREAS, simple logic reveals that people from marginalized communities are being singled out under this prohibition; and

WHEREAS, removing the prohibition against marijuana will benefit the people of Wisconsin across all socio-economic backgrounds by providing a cash crop for farmers, increasing the amount of money within the State budget available to use on issues like drug treatment and education; and

WHEREAS, it is estimated that legalization of marijuana would annually generate more than \$165 million dollars in revenue for the state; and

WHEREAS, between the lost revenue from marijuana sales and the cost associated with maintaining this prohibition it is estimated to cost taxpayers \$41.8 billion annually; and

WHEREAS, marijuana usage has increased approximately 4000% since the current prohibition went into effect in 1937; and

WHEREAS, policing efforts should be focused on more illicit drug use and more serious crimes; and

WHEREAS, achieving equity across all groups of people within the criminal justice system is a goal worthy of our best efforts; and

WHEREAS, the City of Eau Claire has already passed an ordinance change amending the fine for marijuana possession to \$1; and

WHEREAS, there is little evidence to suggest that marijuana decriminalization or legalization leads to a substantial increase in usage; and

WHEREAS, legalizing and providing oversight of marijuana sales is in the interest of public health and safety.

NOW THEREFORE BE IT RESOLVED, that the Eau Claire County Board of Supervisors requests that the Wisconsin State Legislature and the Governor of Wisconsin, decriminalize or legalize recreational marijuana usage for adults over the age of 21 years of age. This legislation will be retroactive; and the Eau Claire County Board of Supervisors supports district attorney offices state-wide to educate on and initiate the expungement process for people with marijuana conviction records.

BE IT FURTHER RESOLVED, that the Eau Claire County Board of Supervisors directs the clerk to forward a copy of this resolution to the Office of the Governor of the State of Wisconsin, members of the Wisconsin Assembly and Senate, the county clerk for every county in the State of Wisconsin, as well as the Wisconsin Counties Association.

RESOLUTION IN SUPPORT OF LEGISLATIVE CHANGES TO WIS. STAT. CH. 980 – SUPERVISED RELEASE

WHEREAS, Wis. Stat. Ch. 980 (Ch. 980) currently provides for the supervised release of certain sex offenders to various properties that meet statutory criteria, and for notice of said release to be provided to certain individuals once the Court orders supervised release; and

WHEREAS, the Brown County Supervised Release Committee (SRC) is tasked with identifying properties in Brown County that meet statutory criteria, and with submitting a report regarding said properties to the Wisconsin Department of Health Services for use in court, but neither the SRC nor its members are Parties to the court action where placement is determined; and

WHEREAS, it is desirable for the Wisconsin Legislature to revise the Ch. 980 definition of "Youth Center," which is currently defined as "...any center that provides, on a regular basis, recreational, vocational, academic, or social services activities for persons younger than 18 years old or for those persons and their families," in order to specify whether the definition of a "Youth Center": 1) may include a private residence; or 2) only includes licensed centers and facilities, such as a Boys & Girls Club, and/or a YMCA or YWCA; and

WHEREAS, it is desirable for the Wisconsin Legislature to add an *additional* notice requirement to Ch. 980, requiring that the State fund and provide written notice to any and all households within 1,500 feet of the property in which a court places a Ch 980 offender in, with said notice including: 1) the name, address and recent headshot of the offender; 2) the sex-related crimes for which the offender being released has been convicted of; 3) the restrictions placed on the offender; and 4) how to report a violation of the restrictions placed on the offender.

NOW, THEREFORE, BE IT RESOLVED that the Brown County Board of Supervisors hereby requests that Wisconsin Legislators make changes to Ch. 980 as described above in this Resolution; and

BE IT FURTHER RESOLVED, that a copy of this Resolution shall be sent via email to the Governor of the State of Wisconsin, to the Brown County Legislative Delegation and to all Wisconsin County Clerks.

Fiscal Note: This Resolution is a sense of the board and does not require an appropriation from the General Fund. This Resolution does not appropriate any funds, and there is no known fiscal impact if the legislative changes requested in this Resolution are made.


