# PROCEEDINGS OF WOOD COUNTY BOARD OF SUPERVISORS February 19, 2013 - 9:30 a.m.

The Wood County Board of Supervisors composed of nineteen members convened at the Wood County Boardroom in Wisconsin Rapids, Wisconsin on February 19, 2013.

Chairman Pliml called the meeting to order at 9:30 a.m.

Supervisor Henkel came forward and gave the invocation and led the Pledge of Allegiance.

Supervisors present were: Allworden, Ashbeck, Breu, Clendenning, Curry, Feirer, Hendler, Henkel, Hokamp, Machon, Miner, Moody, Murphy, Nelson, Pliml, Polach, Rozar, Wagner, and Winch.

Motion by Feirer/Curry to approve the minutes of the previous meeting. Motion carried by voice vote.

Motion by Henkel/Nelson to appoint supervisors Minor, Machon, Murphy, Wagner, Winch to the Compensation/Wage Study Ad hoc Committee and appoint Brent Vruwink and Tim McNaughton as advisory members. Inclusive of this motion is appointment of Joyce Schauer to the Ethics Committee. Motion carried by voice vote.

Chairman Pliml advised those present that he intends to appoint members to the committee to look at Administrator/Administrative Coordinator position. The members he has in mind are Supervisors Henkel, Hokamp, Clendenning, Allworden and Polach. He also intends to appoint members next month to a Strategic Planning Committee to discuss the findings of the Space Needs Study Committee.

There were no public comments

Minutes of various committees were reviewed. Reports, requests and resolutions relating to county board business are as follows:

Committee minutes presented: Executive – Supervisor Clendenning questioned an item in the Executive minutes of February 5, 2013 in regards to payroll direct deposit. Discussion ensued and questions and clarification came from Supervisor Minor and Corporation Counsel. Motion by Clendenning/Murphy to refer the policy to have payroll direct deposit mandatory back to the Executive Committee for further review and to make it a County Board Rule. Further discussion as to whether requiring disclosure of banking information would limit or make that a condition of serving on the county board. Motion to refer carried. Voting no were Nelson, Rozar, Feirer, Hendler, Breu, Henkel, Pliml, Allworden, Moody.

Chairman Pliml without objection from the floor stated that as the first five resolutions are all budget amendments they would be acted on jointly. No objection was heard.

# **RESOLUTION 13-2-1**

Introduced by: Health & Human Services and Executive Committee

INTENT & SYNOPSIS: To amend the 2012 budget for the Norwood Health Center for transfer of available appropriations to functions where actual expenditures have exceeded budget.

FISCAL NOTE: No additional cost to Wood County. The additional revenues and appropriations needed for transfers in are available and are not anticipated to be spent in the appropriations to be transferred out.

# **RESOLUTION 13-2-8**

Introduced by: Judicial and Legislative Committee

INTENT & SYNOPSIS: To request the state to enact legislation that prohibits an entity from foreclosing on property unless that entity itself has a recorded interest in the property. The goal of the legislation is to provide clarity to property owners and lien holders as to the rights and interests of any foreclosing party.

FISCAL NOTE: No fiscal impact to the county or state.

Motion by Clendenning/Wagner to adopt Resolution 13-2-8. Motion by Murphy/Allworden to refer this resolution back to the Judicial & Legislative Committee for needed revisions based on more current information. Motion carried by voice vote.
