### c. Update on Communications Towers/Narrowband Project

The Parks department is on board and installed on the tower. Dennis Polach asked if there was a reason that we moved the antenna on Marshfield

The stations are not currently set up to accommodate pets, but a plan is being looked in to that would possibly consider a shelter with pet accommodations.

They will not be supporting our current system by the end of 2015. Dispatch is looking at getting all the upgrades to our existing system so that we can prolong the need to upgrade to a digital phone system for a while. The cost of the digital system is approximately \$400,000.
