Safe Ride Initiative: Sheriff states that he gave 5 rides home on New Year's Eve and put on over 200 miles as they were all over the county. He believes these initiatives are working as there were no alcohol related crashes on New Year's Eve and only one OWI arrest was made

Criminal Justice Task Force: None.

K9: States that there is a magic show coming up in March to raise funds for this program.

All jail reports were reviewed.

Sheriff Reichert stated the Electronic Monitoring Program (EMP) is doing exceptional for the year. It had a savings of over \$525,000 for the year.
