- 2-21; WR2756 Follow up on quarantine and Veterinarian for a doberman that bit. 18
- 2-22,27; WC1982 Welfare check on horse and working with the owner on moving round pen panels to the south side of the barn and run a fence board inside the barn to separate this horse from the herd but still allow this horse to have access to both the outside and shelter @ 8000 block of 36th St S. The owner has kept this horse separate from the herd, due to the rest of the horses picking on this one. She's kept the horse this way for a few years by keeping him in a round pen with no access to shelter. Most recently she's started locking the horse in a stall only at night, in spite of the extreme cold and windchill's days on end. This round pen is quite a distance from the herd, the barn and 3-sided shelters. 4,4
- 2-22,26; WC1988 Follow up on ill puppies @ 11300 block of County Road S, Milladore. Open Case. 60,60
- 2-23,24; WR3220 Dog Bite Victim said he was bit when he was laying on a couch eating beef jerky and an unknown family member's dog bit him near his left eye brow. Victim won't disclose the name of the owner of the dogs. I explained the quarantine process to him and also I called Aspirus and advised them that the victim declines rabies prevention shots and asked that they contact the victim as well. 20,20
- 2-24,3-6; WC2231 Open Case regarding cattle not being fed properly @ 5000 block of Grant Road. There are about 20 beef and Holstein cross. The water tank, which has no heater was near empty with the owner stating he fills the one water tank once a day. We discussed that the cattle need 24/7 access to unfrozen water. A small few of the steers were on the thinner side, which he states is due to the recent cold spell and that they are part Holstein and are on the leaner side normally. He had hay out for the cattle when I was there. He states he has 6 round bales left and about 2,000 small bales of hay. I also noted that he feeds three, 6-gallon buckets worth of grain each day as well. The area for the cattle was relatively clean in spite of the mud with the melting snow, the sheds were clean as was the buildings holding the silage and grains. 40,40
- 2-25,26; PE219 Dog Bite Victim stated she was walking along the road near 500 block of Market Ave, Port Edwards when a loose yellow lab mix attacked/jumped on her and bit her in the stomach area and scratched her leg. 11,11
- 2-25,26,28; WR3351 The complainant was walking her small dog on a leash when a Husky surprised her by coming up from behind her and grabbing her small Shih Tzu. The Husky pulled the harness off the Shih Tzu and carry him away. The Husky was dragging and shaking the Shih Tzu and was able to take the Shih Tzu to the Husky's yard in spite of the little dog's owner trying to stop it. The adult son of the Husky's owner heard the yelling and came out and was able to restrain the Husky and put it back in the fenced in yard @ 1500 block of Chestnut Street. The owner of the Shih Tzu noticed blood in the mouth of her dog and that the dog was limping on two legs. She took the Shih Tzu to the veterinarian where the vet found puncture wounds as well. The victim dogs owner stated that the Husky's gate is often open with the Husky in the fenced in area. I did have the owner obtain a lock and chain for the gate. 12,12,12

3-3,4; PE253 The victim is also the owner of the dog that bit her. The victim @ 1600 4th Street, Port Edwards was putting together a puzzle when she noticed her dog under the table chewing on something, which was a puzzle piece. The Beagle Jack Russel bit both of the victims hands when she was grabbing the leash to pull the dog out from under the table. 22,22

3-4,5;WC3007 The victim of the dog bite said he and his son were outside @ 3500 block of Ervin Road in the township of Sigel, and when the son went to play ball with their two dogs the dogs got into a fight over the ball. Security Services March 2021 Report

For the month of March 2021, the total number of prohibited items prevented from entering the Courthouse are:

Guns - 0 Knives - 114 O.C. - 8 Misc. Items - 12

Some of the miscellaneous items that were located for the month were numerous scissors and hand tools, a baton, a shovel handle with a sharp hook on the end that the man used as a walking stick and two empty holsters. One of the subjects with a holster told Security Services that he usually brings his gun into the building but he knew that we are now screening people so he left it in his truck.

Security Services also located, on two separate occasions, drugs entering the courthouse. The first incident was a female subject that had a "Dab" on her, which is THC, marijuana. We were able to identify the substance and hold the subject until an investigator came down and interviewed her. The second occasion was a male subject that Security Services took into custody on a court order. During the search of the male subject, suboxone was located in the crotch area in his pants.

Security Services screened 8,360 people entering the courthouse for the month. We handed out 292 masks to individuals coming into the courthouse. Security Services also had 43 security requests from different departments within the Courthouse.

On March 5th, two Oneida County representatives came to the courthouse to see how Security Services operations ran. There county is looking into courthouse security and a having a single point entry courthouse just as we have here in Wood County.

During the Month of March, I did utilize part-time employees for 43 hours to fill employee shortage hours.

INTRO

The Wood County Sheriff's Department is committed to providing county and community programs and services to the incarcerated population. Research shows by enhancing access to programs and services such as mental health and substance use recovery, financial literacy, parenting, resiliency, and more this population is better equipped to successfully reenter the community and overall reduce recidivism rates.

A different facility with expanded and dedicated spaces for programs and services will help to expand the number, duration, and frequency of programs and services available while incarcerated. A targeted approach with criteria for enhanced programs and services will target high-risk individuals, build a framework for continuity of care coordination, and track data for more consistency and improved results.

CURRENT PROGRAMMING SPACE

The jail currently has limited space available to provide ample and expanded programs and services. In the current Wood County Jail Facility below are the available room spaces for programming and services and some of the limitations that have been experienced by both staff and the inmate population.

Example of Experiences of staff and those incarcerated with space availability:

Video Conference Room: This room is currently the only video conferencing available for use. It is primarily used for court. When court is not scheduled it has been used for mental health consults set-up through our mental health staff with outside providers; however if a court needs arises – this consult is cancelled and has to be rescheduled – usually taking many days to do.

Conference Rooms / Jail Library:

Scenario 1: Mental health is working with a distressed individual and that persons ex-significant other walks past the conference room and they see each other. Causes disruption and more mental distress with this individual.

Scenario 2: Individuals state they are not willing to meet with mental health because they do not want other staff or people in their cell blocks to see them cry or to even know they are in the jail facility. The conference rooms and jail library are like "being on display" there is no privacy.

Scenario 3: Discharge Planner or mental health is meeting with an individual in Conference Room 1. Outside of the conference room a new individual is being booked in, staff are walking by, and the individual in Conference Room 2 is standing at the window staring into Conference Room 1. It's extremely distracting and difficult to concentrate; privacy is again very limited.

Scenario 4: Prior to Covid, jail staff have stated there were lines of PO's and Attorneys lined up in the jail to get a free room. Sometimes CO's would take the PO and/or Attorney to meet the person in the hallway outside of their jail block to go over paperwork. We expect this to happen again.

CURRENT PROGRAMMING

While some programs and services are currently taking place they are limited. Many county and community partners are interested in providing services to the jail population; however with limited space, time available, and labor intensive movement of individuals to and from programming – the frequency and consistency of these services are limited.

Prior to COVID, some weekend programming was available totaling 12 hours available on the weekends for church services and domestic violence support groups. Programming would expand to the weekend dependent on availability of our community partners.

^{*}Monday overall is suggested as not a good day to come in as weekend intake is being processed. Jail shifts are 6am-6pm.

*Currently the best times for programming (in-person, virtual or by phone) are 9:00am – 11:30 am = 2.5 hours and 3:00pm- 4:30 pm = 1.5 hours; for a total of 4 hours available each day in a perfect case scenario.

Best case scenario, it's more likely this would be limited to about 3 – 45 minute classes each day with transport needed from CO's to and from the library and all other unscheduled duties and circumstances taking place in the jail.

CURRENT SPACE PROGRAMMING AVAILABILITY

Assuming 3-45 minute classes available Monday – Friday with no duplicate participants.

- It is suggested most of a person's time in jail should be spent in programs and services to better equip them for reentry into the community.
- **45 Minutes a week is not enough** for individuals to receive the support they need to successfully reenter the community and reduce recidivism.

PROGRAMMING AND SERVICES FOR THOSE HOUSED OUTSIDE OF WOOD COUNTY

Bed space is limited in the current facility and many of those in Wood County custody must be transferred to Waupaca and Adams Counties for safekeeping. Below are some of the challenges jail and program staff have encountered with out of county placements.

- Inability to provide programs / services to them.

- Video Conferencing not available or inconsistent as well as phone calls.
- Wood County Safekeepers not eligible for Waupaca County Inmate Programming
- Mail can be sent from facility to facility; however is not timely and things often change before response is received.
- Inconsistent communications between Wood Count Staff and Waupaca/Adams Facility.

Out of County Safekeepers

Example: Discharge Planner scheduled a video call for an inmate to do an Oxford House Interview so when they left they could move in. Inmate was not brought to the video conference, missed the interview and then did not have housing upon release.

Three Bridges Recovery was able to set-up some video conferences with individuals, not all individuals were brought to their scheduled meetings by other jails staff. Instead of video Three Bridges asked for phone calls but they weren't approved, lack of consistency in information and communication is a large barrier.

Recommendation: More space would allow us to keep those in Wood County custody in Wood County. Communication would then be consistent and services could be offered.

FUTURE PROPOSED SPACE AVAILABLITY

A new facility with more bed space would decrease costs in out-of-county spending and increase programs and services available to those in Wood County's custody.

A new facility where the design includes programming space into the pod will:

- Increase the options of programming available as multiple groups can be ran concurrently instead of one at a time.
- Increase the overall frequency of programming available from a minimum of 45 minutes a week to multiple program options a day.
- In a new facility where individuals can self-escort themselves to the programming area will decrease the labor intensive needs of our CO staff and increase efficiency of transport to the programming area.
- With dedicated program space, the programming will not be disrupted and with remain consistent.
 Currently if a phone or meeting space is needed by an attorney, public defender or P&P programming in the jail library could be cancelled.

FUTURE PROGRAMMING INTEREST / EXPANSION

Current programming is very limited due to space constraints, staff capacity and COVID 19 safety protocols. Below are some groups who have expressed interest in programming to the Wood County Discharge Planner. These groups would provide consistent and more frequent programming ability in the jail and throughout the year if more dedicated space and time would allow.

FUTURE PLANNING FOR POST-RELEASE SERVICES

With the transient nature of the jail population it will be important to continue services and program outside of the jail setting. With expanded space available for post-release services day report and EMP case management can be expanded and implemented.

Day Report is a facility or space made available outside the jail. It is available for people on EMP or post-release to come in for 1:1 case management, programs and services, and/or drop-in connection to resources as needed.

Electronic Monitoring Program (EMP) – is granted by a judge and facilitated by the jail. Allowing the person to leave jail but remain monitored by staff and provided expanded case management and access to programs/services.

OVERALL RECOMMENDATIONS

- **Expand dedicated space for programs and services**. Increasing the duration, frequency, and availability of options to those who are incarcerated.
 - Courts, Probation & Parole, Attorneys and Public Defenders will always take precedent over mental health, discharge planning and jail programming in current space.
 - o Confidential and safe places for attendees and facilitators is currently not available.
 - It is labor intensive to currently move people from one location to the other. With classes going
 on frequently staff capacity would be stretched thin ability for people to move to
 programming without escort of CO in new jail facility would cut down on this time significantly
- Continue to expand technology use for 1:1 consultations and programming
 - Technology will not fix the space problem for group programs and services to be available and in an appropriate dosage/availability.
 - In confined spaces of jail, in-person helps build relationships and is more effective.
 - Confidential video conferencing with still require individuals to leave cell blocks to go to a more private dedicated space which is currently not available.
- Expand number of beds available.
 - A larger facility will allow all Wood County inmates to be housed in one facility; decreasing outof-county costs and increasing programs and services available to those who are currently housed outside of wood County
 - A larger facility will allow for more dedicated pods such as a recovery pod or a veterans pod. If a
 facility is large is doesn't necessarily mean it needs to be full. With more space available smaller
 pods can be created for targeted programming.
 - Example: A veterans pods may have 5 individuals housed in it. Current space will not allow for such pod as bed space is at a premium and no pod is consistently vacant others would need to be house with them.
- **Expand EMP Program and Day Report availability** concurrently with case management and program and services availability post-release. Plan for a space for day report services.
- Continue to expand resources for programs and services and targeted case management prior to and post-release for all high and medium risk individuals.
