The number of deaths handled by the coroner's office were down from the month of December. This was due to the decrease in the number of Covid-19 related deaths. Despite this, the overall deaths are still higher than

normal as compared to previous months as we are still experiencing Covid related deaths.

The number of cremation permits issued is still higher than what was previously the norm. I believe this will remain the norm for the future due to the fact more people are choosing cremation as a final means of disposition.

Even with the lower numbers, I am still looking to add 1 or 2 more deputy coroners to our department to help offset the limited availability of the current deputies. I am currently working with Human Resources to achieve this goal.

Lastly, the van from the Sheriff's Department has officially been transferred to the coroner's office for our use. A huge thank you to all that were involved in making this happen! I greatly appreciate it.

I contacted a Lieutenant with the City and explained about the dog being dangerous and that I have been unsuccessful in making contact with the owner other than the one time, he said he'd call Dispatch and have that warning on record that a dangerous dog lives at that address. We are trying to make contact with the owner of this dog and work with the City to proceed with Impoundment. Open Case. 16,16,0

2-1,2,4; WC1937 Report of hording, fleas and sanitation issues with cats, dogs, a hedgehog, rats and a Ball Python in the upstairs apartment of a duplex in the town of Rudolph. The out of town complainant had adopted two cats from this place that had fleas, tapeworms and was concerned of the living conditions of this home. No one was home the first time myself and the new Humane Officer went to the upstairs apartment. The second time we tried to make contact I knocked on the downstairs apartment door to inquire if she knew a good time the upstairs resident is home. In speaking with the downstairs neighbor it became clear that the complaint was about her, and not the upstairs resident. Both downstairs owners of the animals let us in the home. The smell of urine was strong, the cages were filthy, hording conditions throughout the home and there was fleas. Also there was a teenager and a baby living in the home. The owners set up a vet appointment for the following Monday and a re inspection would be needed. The urine was very strong and I had a hard time breathing, and that would last for a couple days.

I contacted Human Services and Environmental Health. I later contacted Dispatch to give them the correct apartment number and correct names for their records. Soon after hanging up with Dispatch, they called back and asked if we'd been in that house yet, I stated that yes, we had. Dispatch stated that not to go back without a couple of deputies as there is a caution on this address and that one of the adults living at the home has outstanding warrants, a pistol and a record of strangulation, battery, disorderly conduct, etc.

Not knowing what you're walking into such as being sent, without safety gear, to homes where you don't know that a known dangerous person resides has happened many times over my 14 years.

I called back to Human Services and Environmental Health and informed them to not go to the residence without Deputies.

Human Services and the new humane officer and myself met with deputies on February 4th we met down the road from the residence and the three deputies went up to the residence first in an attempt to make contact with the renters. They would not come to the door. Case Open. 12,24,24

2-5; WR1730 Hording, sanitation, fleas, mistreatment, strong urine smell @ 400 block of 10th Ave. North, WR. Feces a few inches deep throughout the home. Two of the three dogs were missing their hair and had small red sores covering their bare skin either due to the fleas or mange. I first issued an impoundment form for the dogs. The owner agreed to surrender them instead. The granddaughter who lived upstairs also surrendered her three cats. The owner of the dogs needs help for his own well being. WOOD COUNTY SHERIFF'S DEPARTMENT NEWS RELEASE January 6, 2022

On December 21, 2021 the Wood County Sheriff's Department responded to the Village of Hewitt, Wisconsin for a report of a deceased 22 year old female. Initial investigation by the Wood County Sheriff's Department showed that the female likely died of a drug overdose. A forensic autopsy of the female was completed on December 22, 2021 which indicated a suspected overdose. The Wood County Sheriff's Department is waiting for the final autopsy report from the UW Hospital in Madison, Wisconsin.

On December 22, 2021 the Wood County Sheriff's Department executed multiple search warrants, and interviewed multiple individuals who are connected to the death of this female subject. On December 22, 2021 the Wood County Sheriff's Department took into custody a male subject from Wisconsin Rapids who provided the deceased female the drugs that likely caused her death.

Luis A. Reyes (26 year old male) is being held at the Wood County Jail in connection with the death of this 22 year old female. Investigators from the Wood County Sheriff's Department will be requesting a charge of First Degree Reckless Homicide, along with other drug related charges to the Wood County District Attorney's Office.

Our Investigative Team did an outstanding job with this case. Within 24 hours of the reported overdose, the suspect, Luis Reyes, was identified, located, and taken into custody.

For the month of January 2022, the total number of prohibited items prevented from entering the Courthouse are:

Guns - 1 Knives - 82 O.C. - 6 Misc. Items - 2

The miscellaneous items that were located were a paint scrapper and a pick tool. The individual with the gun came in, looked at the scanning equipment and then left. She stated that she was carrying a cancelled firearm and remembered about it when she seen the screening equipment. A check was completed on the individual and she did have a permit.

Security Services screened 6,923 people entering the courthouse for the month. Security Services had 39 security requests from different departments within the Courthouse for the month. There were two jury trials this month and security handed out 17 masks to individuals that requested them.

On January 17th a male subject became disorderly by yelling and swearing in Child Support. Security Services was called and the subject was removed without incident. On the 25th a female subject came into the courthouse and informed Security that she was just involved in a Hit and Run accident by the hospital and the person that hit her came just walked into the courthouse. We talked to the individuals involved and handed it all over to Rapids PD. Security Services found a wallet on January 26th and was able to return the wallet to the owner with nothing missing. We also took a female into custody that had four warrants for her arrest.

During the Month of January, I utilize part-time employees for 29.5 hours to fill employee shortage hours.
