1. Call to Order:

Mike Feirer called the meeting to order at 12:00 p.m.

2. Review minutes of January 9, 2018:

Motion by Hamilton, second by Winch to approve the minutes of the January 9, 2018 meeting as presented. Motion carried unanimously.

3. Public Comments:

No public comments

4. Courthouse Security Issues and Updates:

Bill Clendenning gave updates on security. He stated there will be a meeting on February 13th and a meeting of the Public Property Committee after the next County Board meeting.

5. Discuss railroad crossing time limits in the City of Wisconsin Rapids:

Supervisor Winch explained the reasoning behind this agenda item. He would like to see the City of Wisconsin Rapids and the County work together to address and find solutions for this issue. Rep. Krug states that he has been trying to work with Canadian National and they are not cooperating. Mr. Eichstadt from the City agrees that this is an issue. Sup. Polach asked about the idea of an overpass. Mr. Eichstadt said that there are multiple crossings so it is not a feasible idea.

Amy Sue Vruwink stated that the transportation person in Senator Kind's office, Ethan Holmes, would like to hear from individuals that are having problems with long waits, etc...This will help him when he calls Canadian National to speak about this issue. His email is ethan.holmes@mail.house.gov

6. Animal Drawn Vehicles:

Rep. Kulp gave an update on the bill in the House. It has been voted on and is up for scheduling in the Senate. Supervisor Winch explains that safety is the reasoning behind these proposed changes. Rep. Kulp speaks as to the motivations behind the State level response and reasoning. Sup. Feirer asks what the pending legislation will do to help Wood County. He states that he feels this will help Wood County more than other Counties with more restrictive Amish communities. Bill Winch questions how much authority the County has over their own roads. Vicki Palen states that discussing visibility as a separate issue is the way to go. Mose Hellmuth states that he believes that more lights are good. Dan Schrock states that he believes an amber flashing light would be a good idea. One of the Amish stated interaction with traffic has been improving since this has become a news item. Sup. Feirer states that the committee will wait to see what happens with the State Legislation. The Amish community agrees to a meeting to discuss implementation in their communities before the legislation is passed. Emergency Management and Sheriff will continue to meet with the Amish Communities, along with going into their schools to teach rules of the road to the students.

TRAINING -

ACE – On February 17, Deputy B Christianson and K9 Ace conducted a training scenario that worked on narcotics detection. During this training exercise, no issues were observed. On February 21, Deputy B Christianson and K9 Ace attended a multi-agency training session hosted by Portage County. The training scenarios worked on Tracking, Narcotics Detection, Apprehension Work and various scenarios utilizing the Door Pop System recently installed. During the training No issues were observed.

TORO – Deputy Pidgeon and K9 Toro attended a training session hosted by WRPD. On this training day, they worked on Building Searches, Tracks, Article Searches and Narcotics Detection. NO issues were observed.

COMMUNITY/DEMOS – No Community Events or Demos for February.

DEPLOYMENTS (K9 ACE) – K9 Ace was deployed 4 times by Deputy Christianson. He was requested by NKPD on one stop and in this contact K9 Ace did not indicate on the vehicle.
