- 2. Public comments. None at this time.
- 3. The minutes for the June 4 and 22, 2021, meetings were reviewed.

 Moved by Zurfluh, seconded by Wagner, to approve. All ayes.
- 4. The Committee reviewed the claims of Tonya Rehbein. This claim will be provided to the county board.
- 5. There was one new animal claim against the County.

 Moved by Leichtnam, seconded by Wagner, to approve payment to

 Castlerock Veterinary Hospital in the amount of \$96 for rabies

 testing of a kitten. All ayes.
- 6. The Committee reviewed monthly voucher and department reports of the departments it oversees. Moved by Zurfluh, seconded by Leichtnam, to approve the reports and payment of department vouchers. All ayes.
- 7. The Committee reviewed correspondence and legislative issues.

 Amy Sue Vruwink gave a legislative update on behalf of Representative Ron Kind's office.
 - a. Report of Citizens Groundwater Group.

 Supervisor Leichtnam updated the Committee on the group's 6/21/21 meeting wherein neonicotinoids were talked about again. Neonicotinoids kill pollinators and have been banned in many countries but that is unlikely to happen here as it is a popular type of insecticide.
 - b. Barron County resolution, re: Elimination of Badger Care Eligibility Cliff. Discussion had but no action taken.
 - c. Eau Claire County resolution, re: Decriminalize Recreational Marijuana.

 Supervisor Zurfluh spoke against legalizing marijuana.

 District Attorney Lambert advised that he sees marijuana as a gateway drug and opposed legalizing it. Quite a bit

of discussion had on the impact of decriminalizing marijuana. No action taken.

- d. Brown County resolution, re: Wis. Stat. Chapter 980 modifications. No discussion or action taken.
- e. Chippewa County resolution, re: Request WCA address clean water issues. Moved by Leichtnam, seconded by Zurfluh to support the resolution before the WCA. All ayes.

 Note: It is too late to present a resolution to the WCA but Supervisor Clendenning is on the WCA's resolution committee and will take the Committee's position into account in voting at the WCA meeting.
- 8. County Board rules.

Motion as amended, 4 ayes, 1 nay. Clendenning voted nay as he felt the current rules are adequate. Motion passed.

I just wanted to remind you that I never gave the officers that night permission to talk to my son or take his phone to record. I also wanted to add that after we (my son and I) got back in the house that night I never gave the one officer permission to take my son to my room when I believe at the time I was at the kitchen table talking with one officer about victim rights. I then got up and followed them (my son and the other officer into my room and did not give them permission to take the gun from Tony's closet. It actually was a gun, holster and two clips. 



MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE August 2021

Opioid Litigation Settlement Funds.

Governor Evers signed into law legislation that puts in place a structure for the state and counties to receive opioid lawsuit settlement funds. 2021 Wisconsin Act 57 will permit counties to use these funds to assist families that have been impacted by the misuse and abuse of opioids. The major components of the legislation provide as follows:

- 1. All settlement funds are split 70% to litigating local governments (71 counties and a handful of municipalities) and 30% to the state;
- 2. The state's settlement funds are appropriated to DHS;
- 3. All funds, state and local, must be spent on the opioid abatement effort;
- 4. A local government is barred from suing the opioid defendants unless the claim was filed before June 1, 2021; and
- 5. The law addresses various other matters providing for administration of the settlement and settlement funds.

There are both the Purdue bankruptcy plan, which includes an approximate \$5 billion settlement for state and local governments, and then the \$26 billion distributor and Johnson & Johnson settlement.

In addition to the monetary payments, the defendants have agreed to fundamental changes in their business practices to help abate the epidemic and make sure it does not happen again.

Before becoming final, the nationwide tentative settlement agreement must meet the approval of two groups. First, states have 30 days to decide whether to participate in the settlement. If enough states agree, then counties and cities have the opportunity to accept the terms. A critical mass of state and local governments must agree to the terms before funds are released to the communities that have been impacted by the epidemic.

The new jail. I have been working with the Facilities Manager, Sheriff, First Deputy, and the Planning and Zoning Director to lay some groundwork for the new jail. At this point, that means reviewing draft contracts. Soon it will entail assisting in acquiring the necessary real property and vacating the easements thereon. I will likely be reporting directly to the Jail Construction Committee on these matters if the county board approves the creation of the temporary committee.

We are gearing up for the release of the 2022 Treatment Alternatives and Diversion grant announcement that we anticipate to release soon. The TAD grant typically has an application deadline in August or September and the funding will be for the next five years (2022-2026). This is a competitive grant cycle and the state has released some information that highlights some changes that we are working hard to ensure we will be able to meet. We are also gearing up for a two day intensive training in July for the Wood County Adult Drug Court. This training is hosted by the National Drug Court Institute and brings discipline leaders from across the nation to look over our program and help to make recommendations for improvements.

Key Highlights

- Space The Sheriff's Department was able to vacate the fourth office space in our hallway as the new contracted commissary vendor has now been implemented. I am working with Reuben to ensure that I am aware of total rent costs for this additional space allowing me to identify funds within my budget for this expense. Reuben and I have been working on attempting to track down funds that are currently housed in the drug court budget for rent that are being expensed but no one is aware for what space they are assigned. Reuben and I will continue to work on this as funds currently budgeted should be more than enough for the additional office space.
- TAD We continue to work on getting historic data in an effort to be prepared to submit our competitive grant application later this year. In this grant application I hope to include dollars for housing and transportation supports which have been an ongoing barrier for our participants. In addition, I hope to work collaboratively with community providers to enhance access to care for participants. Formalizing the Criminal Justice Task Force through bylaws is something that will be required in the funding as the state is requiring a formalized multidisciplinary group that focuses on collaborating to solve systemic issues. The official grant has not yet been released; however, I am beginning to draft the documents that will be required in this grant cycle with prerelease information provided by the state.
- Collaboration –The Drug Court program has created four workgroups to begin reviewing our program and how we align with best practice standards. These workgroups including focusing on data, the team structure, the referral/admittance/and termination policies, as well as rewards and sanctions. During my interview process it was identified that the group felt that veteran's services was a place of interest. I was able to work with the District Attorney as well as the CVSO to start a small pilot that identifies Veterans and diverts them into services using both deferred prosecution and deferred judgement agreements. Our hope is to gather and track data that can then be used to inform conversation about what may or may not be a good fit for Wood County. I have been working with Three Bridges Recovery to discuss potential partnerships as it relates to Drug Court as well as any future programming and the delivery of psychoeducational groups, this is something that if possible I could write into the TAD grant. I continue to collaborate with Sheriff Becker on programming for the Wood County jail as well as the Electronic Monitoring Program.

- **Drug Court Programming** Our Seeking Safety group continues to meet. This curriculum is one of several evidence based manualized groups that are evidenced within the justice population. I am working on training Ryan and Maribeth on this as well as a new curriculum called, Getting it Right these curriculums can be provided within the jail programming and other future programming. We are also using three new interactive journaling workbook Women in Recovery, Traumatic Stress & Resilience for Men, and Remodeling My House. These too are tools that can be used in the jail and with future programming. I have created the first draft of our MOU for drug court. This MOU addresses team membership, expectations of members, information sharing and other key factors that are outlined in best practice.
- **Veterans Treatment Initiative & Diversion** We had our first Veteran plea into this collaborative partnership. This veteran will be connected to services within the VA and connected with the Wood County VSO. We are able to use the Treatment Alternatives and Diversion data host to manage the data for this post plea collaboration which will be helpful as we look to move forward.
