PROCEEDINGS OF WOOD COUNTY BOARD OF SUPERVISORS June 16, 2015 - 9:30 a.m.

The Wood County Board of Supervisors composed of nineteen members convened at the Wood County Boardroom in Wisconsin Rapids, Wisconsin on June 16, 2015.

Chairman Pliml called the meeting to order at 9:30 a.m.

Supervisors present were: Ashbeck, Breu, Clendenning, Curry, Hamilton, Hendler, Henkel, Hokamp, Leichtnam, Miner, Nelson, Pliml, Polach, Rozar, Wagner, Winch and Zurfluh.

Excused were Supervisors Machon and Feirer.

Supervisor Rozar gave the invocation and led the Pledge of Allegiance.

Motion by Hamilton/Nelson to approve the minutes of the previous meeting. Motion carried by voice vote.

Motion by Breu/Hokamp to accept the re-appointment of George Bartels, Jim Winkler and John Kubisiak to the Wood County State Wildlife Area Advisory Committee for a three year term and also the appointment of Jessica Vicente as a citizen member to the Health and Human Services committee for a three year term. Motion carried by voice vote.

Public Comments: UW Marshfield/Wood County Assistant Dean, Michelle Boernke introduced Interim Dean Keith Montgomery who will be assuming his duties effective July 6th. Cecelia Stelzer Johnson stated that she is concerned with the quality of water. Arnold Mancl explained the Groundwater Guardian Program and how it got started. He is a state certified water operator. Brian Hamm imparted that he feels that regulating water should happen at the county level. Helen Donahue spoke in favor of regulating groundwater. Christie Greening thanked the Judicial and Legislative Committee for bringing the resolution forward. Don Swanson supports the groundwater resolution being presented today. Eleanor Terrell lives in the Town of Rome and is concerned about water. Helen Sullivan asked the board to please pass the resolution.

Department heads came forward to present plaques to long term employees within their departments. Those recognized for 25 years of service were Patricia James, Jacklyn Brown, David Beyer, Timothy McNaughton and Stephen Weiler. 30 years of service award went to Cheryl Gazeley, Jonathan Anderson and Lisa Boyarski. 40 years of service was recognized for Lee Garrels.
